 - 709.11-HP BEAMS, WIDE FLANGE BEAMS (WHALERS) AND SHEET PILING: All HP beams and wide flange beams (whalers) used for structural piling systems shall be hot rolled ,new and unused and conform to ASTM A572 Grade 50.

 All steel sheet piling shall conform to AASHTO M202/ASTM A328 Grade 50 unless otherwise directed on project plans.
 - 709.12-STRUCTURAL AND EYEBAR STEEL: All structural steel for bridges shall conform to the applicable grade of AASHTO M270 that is specified in the Plans. CONSTRUCTION CONTRACTS: Under W. Va.
