- (1) Do we need to use patch panels and then go from the patch panel to the POE switch with a patch cord? **Answer= Wiring shall meet the manufacturers requirements without causing increased resistance and or voltage loss.**
- (2) Is there to be a monitor quoted in this bid and if so what size and where will it be installed? **Answer= Yes, installed in the main office basement. 20" monitor matched to the NVR manufacturers recommendations.**
- (3) It was said that all cat 5 cable is to be put in rigid conduit, is this correct? Because while doing the walk-thru on Friday I seen EMT conduit all over the building, and there is just low voltage running through it? There is a Major cost difference between EMT and Rigid Conduit. **Answer= Rigid Conduit shall be required when passing through an interior or exterior wall and have a minimum 12 inches of stickout to the interior and connect to the camera on the exterior.**
- (4) I would like to know 2 measurements (1) the height to the peak above the cranes in the garage and the length of the main garages? (For proper Lift Rental) **Answer= Height to peak is 45 feet. Length measurements for main garage is 345ft x 266ft**
- (5) I would also like to know the thickness of the sandstone walls? **Answer= 4ft thickness**
- (6) I was shown a switch just laying on top of a file cabinet in the garage area, it will need to be replaced with a POE switch, I need to know if that switch needs to be installed in a locking data cabinet (wall mount)? **Answer= No it does not need to be in a locking cabinet.**
- (7) Conduit Requirements:
 - a. It was stated at the bid meeting that all camera wiring shall be ran in rigid galvanized conduits. Is this what you are wanting? **Answer= Rigid Conduit shall be required when passing through an interior or exterior wall and have a minimum 12 inches of stick-out to the interior and connect to the camera on the exterior.**
 - b. It was stated that the camera located at the main gate shall utilize an existing conduit. If we are not available to utilize this conduit shall this be handled in a change order? **Answer= No change orders will be issued.**
- (8) Delivery & Return:
 - a. In the bid documents it states that delivery of the contract items shall be sent within 20 working days. Does this include the onsite installation must it be done in that 20 day timeframe as well? **Answer= 20 working days can be changed to 30 working days for completion after the notice to proceed has been issued.**
- (9) Lighting Requirement for the facial cameras:
 - a. It was stated that proper lighting will need to be added to some of the cameras that do not have enough lighting to utilize the facial recognition. Will these lights be added on a

per needed basis on change orders? Or do we need to include these lights on this quote? If so will a line item be added to the quote? **Answer= No change orders will be issued camera systems bid should be bid with what is needed to meet the minimum required specifications.**

- b.** If we are to include them on the quote then can you provide a lighting layout and light information so we can see what you currently have as we are not allowed back on site. The quote documents do not state which camera/s are needing lighting and their field of coverage. **Answer= Cameras bid shall be bid with what is needed to meet the minimum specification requirements without the aid of WVDOH lighting. In the event of a WVDOH lighting failure the cameras systems could become useless.**

(10) What manufacturer or brand of cameras were these bid specifications based on? **Answer= No specific brand was singled out for bases of specification.**
