



PURCHASING AFFIDAVIT

CONSTRUCTION CONTRACTS: Under W. Va. Code § 5-22-1(i), the contracting public entity shall not award a construction contract to any bidder that is known to be in default on any monetary obligation owed to the state or a political subdivision of the state, including, but not limited to, obligations related to payroll taxes, property taxes, sales and use taxes, fire service fees, or other fines or fees.

ALL CONTRACTS: Under W. Va. Code §5A-3-10a, no contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and: (1) the debt owed is an amount greater than one thousand dollars in the aggregate; or (2) the debtor is in employer default.

EXCEPTION: The prohibition listed above does not apply where a vendor has contested any tax administered pursuant to chapter eleven of the W. Va. Code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

DEFINITIONS:

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Employer default" means having an outstanding balance or liability to the old fund or to the uninsured employers' fund or being in policy default, as defined in W. Va. Code § 23-2c-2, failure to maintain mandatory workers' compensation coverage, or failure to fully meet its obligations as a workers' compensation self-insured employer. An employer is not in employer default if it has entered into a repayment agreement with the Insurance Commissioner and remains in compliance with the obligations under the repayment agreement.

"Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceeds five percent of the total contract amount.

AFFIRMATION: By signing this form, the vendor's authorized signer affirms and acknowledges under penalty of law for false swearing (W. Va. Code §61-5-3) that: (1) for construction contracts, the vendor is not in default on any monetary obligation owed to the state or a political subdivision of the state, and (2) for all other contracts, that neither vendor nor any related party owe a debt as defined above and that neither vendor nor any related party are in employer default as defined above, unless the debt or employer default is permitted under the exception above.

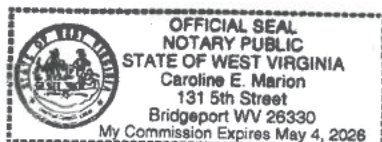



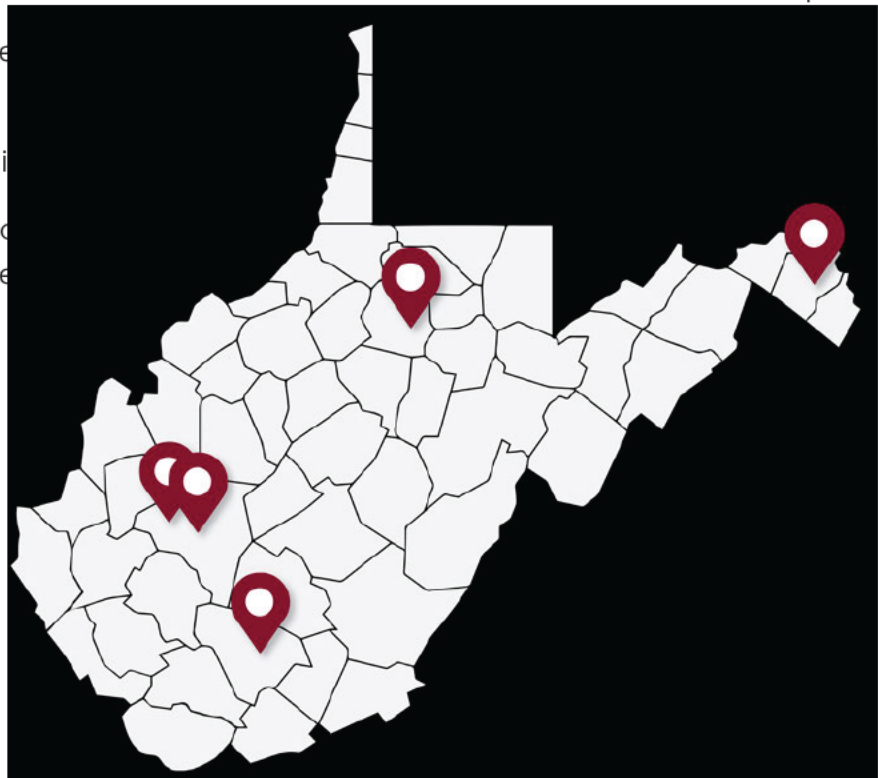

2. APPROACH TO YOUR GOALS

A critical step in meeting your goals is first ensuring we understand them. Thrasher's team has thoroughly reviewed the Expression of Interest request and is confident in our ability to deliver the highest-quality solutions to your problems. We are capable of meeting each goal/objective you have outlined and feel strongly that you will be satisfied with the outcomes you receive.

We understand your goals for Elk River Rail Trail New Headquarters and Maintenance Building project and will handle them in the following manner:

Goal 2.1 | Program Review

The Thrasher Group can provide the West Virginia Division of Natural Resources with all of the services required. This will begin with a review of the program for the facility along with a review of existing site conditions. Communication with all stakeholders will be key to align project expectations with the budgetary, timeline, and physical constraints of the project.

Goal 2.2 | Meeting Objective and Budgets

With a full team of in-house experts, Thrasher will be able to provide all necessary architecture and engineering services to design the new Headquarters and Maintenance Building for the Elk River Rail Trail. As a well established West Virginia firm, we have a deep understanding of the local codes, laws, and applicable state regulations that will be necessary for this project. This will prove beneficial in sticking to outlined timelines and budgets, as Thrasher will be able to plan ahead to meet the regulations from the outset. As budget is such an important aspect of our work, Thrasher's cost estimating and budgeting information can be found in more detail in the coming pages.

Goal 2.3 | Construction Contract Administration

2. APPROACH TO YOUR GOALS

Thrasher will keep your project goals in mind throughout the process. We will address each in turn, working directly with the West Virginia Division of Natural Resources to meet your needs with the project approach outlined below. Thrasher will conduct design review meetings with your team at each phase of the process, making sure we are keeping with the overall intention of the project.

Our general steps for project management are as follows:

Step 1 - Site Visit

Your assembled team of engineers and architects will conduct a site visit. This group will evaluate the project conditions and identify and document potential problem areas. We will coordinate with your team and any identified key stakeholders to take all the facts into consideration during this process.

Step 2 - Conceptual Design and Report

Thrasher will prepare a conceptual design for the needed services at the Elk River Rail Trail Headquarters and Maintenance Building. Where applicable, we will also provide design alternatives for consideration. We will then prepare a written report of the conceptual designs and outline any issues.

Step 3 - Construction Documents

Our team will provide design solutions and construction documents to the appropriate personnel for the project. These plans will be carried forward to final design based upon the conceptual design report. Thrasher recognizes that you are requesting drawings and specifications at 35%, 65%, 95%, and 100% and will provide both drawings and cost estimates at those intervals. We will complete the final design documents based upon comments received and conclusions throughout the design review process. Our field evaluations and design approach will specifically address these issues in the construction documents.

Step 4 - Bid Process

We will assist the WVDNR and stakeholders in preparation of the bid documents and will attend pre-bid meetings and assist in issuance of addenda.

Step 5 - Construction Administration

The project team will review project submittals, attend project meetings, and provide inspection of the construction being completed. The project team will also provide final punch list inspection at project completion.

Step 6 - Project Close Out

Upon completion of the project, the Thrasher team will work with the General Contractor to assure that all closeout documents are provided and that the facility is fully complete and functional at turn over.

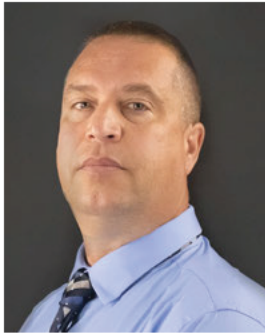

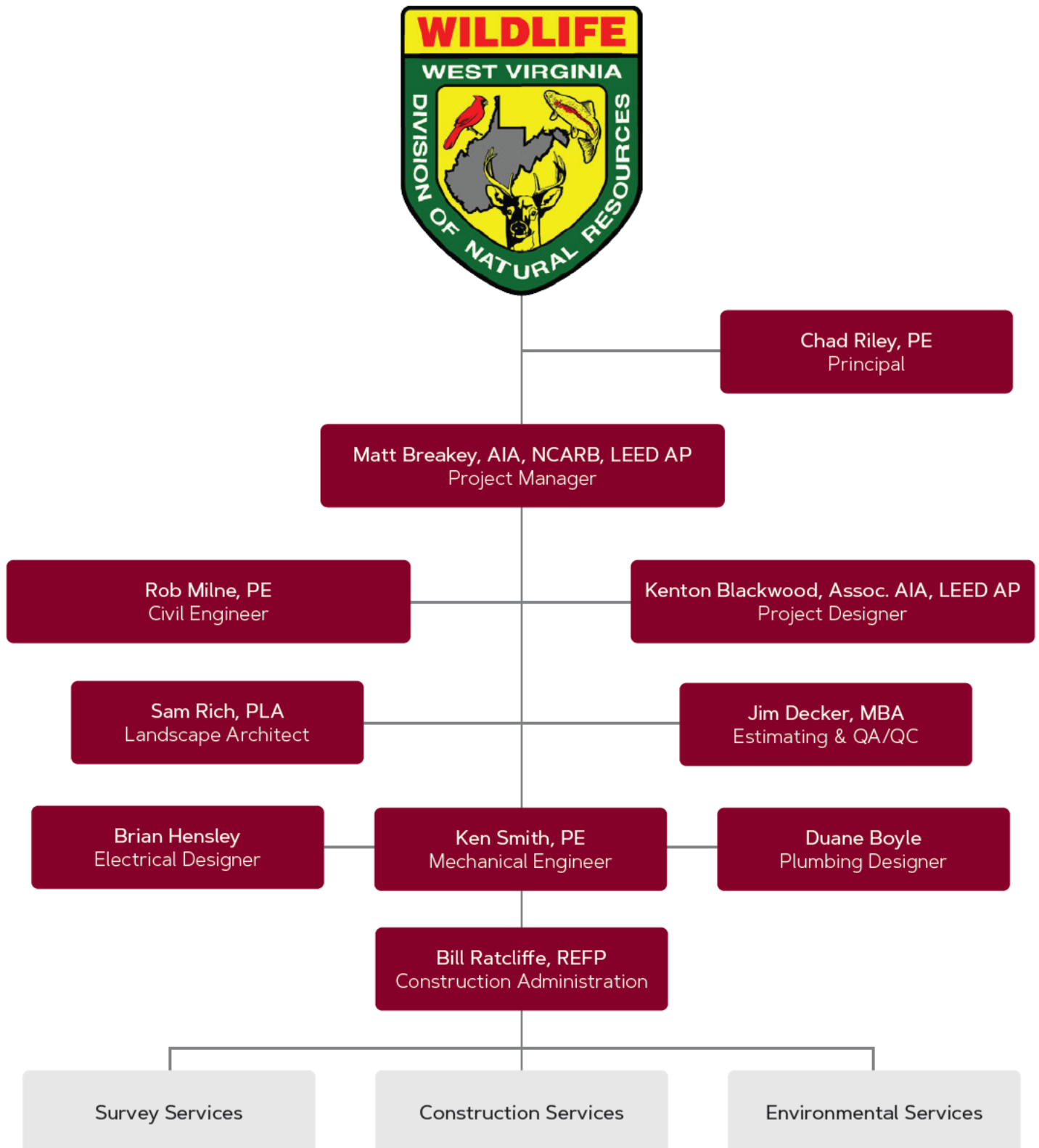

Thrasher was retained by the Pike County Fiscal Court to prepare a trails master plan. Pike County — the largest county east of the Mississippi River — is the economic and outdoor recreation center of eastern Kentucky and offers diverse outdoor adventure, cultural, historic, and musical attractions. Establishing a best-in-class trail system adds new visitor choices and will attract both local and out-of-state visitors. The Pike County system is named “Hillbilly Trails,” which is a tie-in to the annual Hillbilly Days event, the largest annual gathering in the region.

Hillbilly Trails will tie in with other trail systems, such as Hatfield-McCoy — also a Thrasher project — and Spearhead. Thrasher designated a central trail corridor that is more than 35 miles in length. Spur trails off the main spine will add hundreds of additional miles, with trailhead locations recommended approximately every 20 miles. Most trailheads are adjacent to communities such as Phelps, Elkhorn City, and Mouthcard.

The Marshall University Center and Business and Economic Research (CBER) prepared an estimate of the economic impact of the trail system. Hillbilly Trails has the potential to bring long-term beneficial economic impact to Pike County through direct, indirect, and induced impacts. Trail construction impacts were estimated to be \$25.2 million in onetime impacts and contribute approximately 128 jobs in Pike County. Annual maintenance and operating expenditures would create almost five full time jobs in Pike County. Outside visitor spending would generate an additional six jobs in Pike County if 10,000 annual permits are sold.

The Rex W. Tillerson Leadership Center is part of the Summit Bechtel Reserve in Glen Jean, West Virginia. This Center provides six educational classrooms and a Leadership Hall. The Hazel Ruby McQuain Park and Amphitheater is one of Morgantown's premier outdoor recreation facilities. The park is home to annual local festivals, community movie and concert events, and several organized run and walk events during all seasons.

The improvements project consists of: a new amphitheater canopy, new restroom building, adaptive reuse of the historic depot, renovation of the existing restroom building to a new green room and police department storage facility, renovations to the amphitheater seating area, redesign and renovation of the park pedestrian areas and landscape, bike/walking path improvements, new ADA kayak launch, and renovations to the Walnut Street Landing parking and pedestrian area.



The project upgrades the quality and capacity of the amphitheater facility as a performance venue. The new canopy provides covered seating and sun shading. The new restroom building provides modern facilities capable of serving the park during large events and during daily operations. 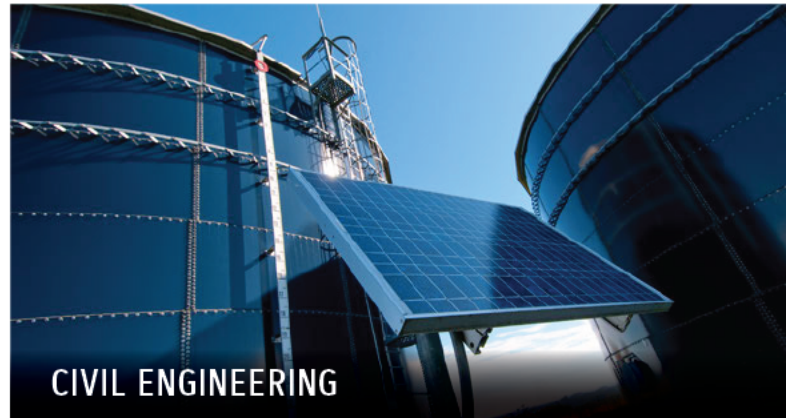
