



- 29. STATE EMPLOYEES: State employees are not permitted to utilize this Contract for personal use and the Vendor is prohibited from permitting or facilitating the same.
- **30. PRIVACY, SECURITY, AND CONFIDENTIALITY:** The Vendor agrees that it will not disclose to anyone, directly or indirectly, any such personally identifiable information or other confidential information gained from the Agency, unless the individual who is the subject of the information consents to the disclosure in writing or the disclosure is made pursuant to the Agency's policies, procedures, and rules. - **40. BACKGROUND CHECK:** In accordance with W. Va. Code § 15-2D-3, the State reserves the right to prohibit a service provider's employees from accessing sensitive or critical information or to be present at the Capitol complex based upon results addressed from a criminal background check. - 41. PREFERENCE FOR USE OF DOMESTIC STEEL PRODUCTS: Except when authorized by the Director of the Purchasing Division pursuant to W. Va. Code § 5A-3-56, no contractor may use or supply steel products for a State Contract Project other than those steel products made in the United States. A contractor who uses steel products in violation of this section may be subject to civil penalties pursuant to W. Va. Code § 5A-3-56. As used in this section:
  - a. "State Contract Project" means any erection or construction of, or any addition to, alteration of or other improvement to any building or structure, including, but not limited to, roads or highways, or the installation of any heating or cooling or ventilating plants or other equipment, or the supply of and materials for such projects, pursuant to a contract with the State of West Virginia for which bids were solicited on or after June 6, 2001.

The cost of domestic aluminum, glass, or steel products may be unreasonable if the cost is more than twenty percent (20%) of the bid or offered price for foreign made aluminum, glass, or steel products. If the domestic aluminum, glass or steel products to be supplied or produced in a "substantial labor surplus area", as defined by the United States Department of Labor, the cost of domestic aluminum, glass, or steel products may be unreasonable if the cost is more than thirty percent (30%) of the bid or offered price for foreign made aluminum, glass, or steel products. This preference shall be applied to an item of machinery or equipment, as indicated above, when the item is a single unit of equipment or machinery manufactured primarily of aluminum, glass or steel, is part of a public works contract and has the sole purpose or of being a permanent part of a single public works project. This provision does not apply to equipment or machinery purchased by a spending unit for use by that spending unit and not as part of a single public works project.

All bids and offers including domestic aluminum, glass or steel products that exceed bid or offer prices including foreign aluminum, glass or steel products after application of the preferences provided in this provision may be reduced to a price equal to or lower than the lowest bid or offer price for foreign aluminum, glass or steel products plus the applicable preference. 1. PURPOSE AND SCOPE: The West Virginia Purchasing Division is soliciting bids on behalf of the WEST VIRGINIA LOTTERY to purchase and replace 12 existing networking switches owned by the agency. #### **Response Notes:**

- Cisco switches are installed at the Primary Data Center on Pennsylvania Avenue in Charleston WV as well as the backup data center in Anmoore near Bridgeport WV. In addition each of the five casinos online to the Lottery have installed various Cisco devices to connect to the Lottery network. Support and maintenance will generally be requested at the primary data center but should be available transparently from the backup data center or any of the five casinos.
- 2. Any references to specific devices above are general in nature, the Bill of Materials attached as **Exhibit B** controls the specific requirements to be covered by this procurement.

- 2. **DEFINITIONS:** The terms listed below shall have the meanings assigned to them. Additional definitions can be found in Section 2 of the General Terms and Conditions.

  - 2.3 "Solicitation" means the official notice of an opportunity to supply the State with goods or services that is published by the Purchasing Division.
  - **2.4 "Solicitation"** means the official notice of an opportunity to supply the State with goods or services that is published by the Purchasing Division.
  - 2.5 "FIPS" means Federal Information Processing Standard.
  - 2.6 "RJ-45" means a 8-pin/8-postion plug or jack commonly used to connect computer into Ethernet-based local area networks.
  - 2.7 "Cryptographic modules" means any combination of hardware, firmware or software that implements cryptographic functions such as encryption, decryption, digital signatures, authentication techniques and random number generation.
  - 2.8 "PoE" means Power over Ethernet which describes any of several standardized or adhoc systems which pass electrical power along with data on twisted pair Ethernet cabling.
  - 2.9 "Layer 3 Switch" means a specialized hardware device used in network routing. Layer 3 switches technically share much in common with traditional routers.

  - 2.13 "VLAN" stands for virtual LAN, which is any broadcast domain that is partitioned and isolated in a computer network at the data link layer. LAN stands for local area network.

#### 4. CONTRACT AWARD:

- **4.1 Contract Award:** The Contract is intended to provide Agency with a purchase price for the Contract Services. The Contract shall be awarded to the Vendor that provides the Contract Services meeting the required specifications for the lowest overall Total Bid Amount as shown on the Pricing Page.
  - 4.1.1 Vendor should provide with their bid a copy of any and all Software Terms and Conditions or licenses that the State of West Virginia or the Agency will have to agree to or accept as a part of this solicitation. This information will be required before Purchase Order is issued.

#### 5. PAYMENT:

**5.1** Payment: Vendor shall accept payment in accordance with the payment procedures of the State of West Virginia.

#### 6. DELIVERY AND RETURN:

6.1 Shipment and Delivery: Vendor shall ship applicable Contract Items immediately after being awarded this Contract and receiving a purchase order or notice to proceed. Vendor shall deliver the Contract Items within thirty (30) calendar days after receiving a purchase order. Contract Items must be delivered to:

- **6.2 Late Delivery:** The Agency placing the order under this Contract must be notified in writing if the shipment of the Contract Items will be delayed for any reason. Any delay in delivery that could cause harm to an Agency will be grounds for cancellation of the Contract, and/or obtaining the Contract Items from a third party. Any agency seeking to obtain the Contract Items from a third party under this provision must first obtain approval of the Purchasing Division.
- **6.3 Delivery Payment/Risk of Loss:** Vendor shall deliver the Contract Items F.O.B. destination to the Agency's location.
- 6.4 Return of Unacceptable Items: If the Agency deems the Contract Items to be unacceptable, the Contract Items shall be returned to Vendor at Vendor's expense and with no restocking charge. Vendor shall either make arrangements for the return within five (5) days of being notified that items are unacceptable, or permit the Agency to arrange for the return and reimburse Agency for delivery expenses. If the original packaging cannot be utilized for the return, Vendor will supply the Agency with appropriate return packaging upon request. All returns of unacceptable items shall be F.O.B. the Agency's location. The returned product shall either be replaced or the Agency shall receive a full credit or refund for the purchase price, at the Agency's discretion.
- 6.5 Return Due to Agency Error: Items ordered in error by the Agency will be returned for credit within 30 days of receipt, F.O.B. Vendor's location. Vendor shall not charge a restocking fee if returned products are in a resalable condition. Items shall be deemed to be in a resalable condition if they are unused and in the original packaging. Any

restocking fee for items not in a resalable condition shall be the lower of the Vendor's customary restocking fee or 5% of the total invoiced value of the returned items.

#### 7. VENDOR DEFAULT:

The following shall be considered a Vendor default under this Contract.

- **7.1.1** Failure to provide Contract Items in accordance with the requirements contained herein.
- 7.1.2 Failure to comply with other specifications and requirements contained herein.
- **7.1.3** Failure to comply with any laws, rules, and ordinances applicable to the Contract Services provided under this Contract.
- 7.1.4 Failure to remedy deficient performance upon request.
- 7.2 The following remedies shall be available to Agency upon default.
  - 7.2.1 Immediate cancellation of the Contract.
  - **7.2.2** Immediate cancellation of one or more release orders issued under this Contract.
  - 7.2.3 Any other remedies available in law or equity.

#### **Overview**

Together, Arista's family of switching and WiFi platforms are managed through a single Cognitive Campus management plane in CloudVision, providing sub-second real time telemetry, database archival and automated analytics to manage and monitor the infrastructure, users and applications in the Campus-Cloud Network.



Driving the campus CMP (Cloud Management Plane) in the CCS-720 is the FlowTracker hardware telemetry feature (IPFIX), native in the CCS-720 series non-blocking switching processor. FlowTracker delivers real time updates for all device state, performance statistics, and application flows, without burdening other system functions. Over a thousand unique flows can be concurrently tracked per switch, with hardware support to scale to 32K flows. Device fingerprinting features are also supported, allowing the 720XP to identify connected device type, operating system and user id, helping facilitate security audits and workgroup/workload segmentation.





## **Customizable Topologies for Optimized Performance**

As with all Arista devices, the CCS-720 switches support open, standards based, L2 MLAG and L3 ECMP load balancing features. Administrators can employ either scheme to deliver high availability load sharing at the core building, or intermediate distribution frame. The CCS-720's Dynamic Load Balancing (DLB) feature improves on typical load sharing by dynamically tracking flow volumes and rebalancing them across shared links to optimize network utilization. DLB interoperates with other networking platforms, helping administrators improve the performance of their installed campus infrastructure.

The 720XP uses standard RJ45, SFP+ and QSFP+ interfaces for in closet and uplink interconnections, giving administrators the freedom to choose the right media type and speed that suits campus use cases and their budget. These optics allow administrators to invest in 25Gb but still run in 10Gb mode while connected to legacy infrastructure, thus simplifying campus migrations and reduce CapEx.

The CCS-720 series supports industry standard 802.1X and RADIUS authentication schemes, and interoperates with leading authentication solutions. Authorized users and devices can be automatica/.lly segmented into assigned 802.1Q or EVPN VXLAN segmented networks, facilitating infrastructure and data security. Wire-speed layer 3 VRF segmentation is also supported, giving administrators additional flexibility for supporting the most sophisticated campus use cases. The CCS-720 platinum rated power supplies, coupled with its low nominal consumption leaves an ample power budget for connected appliances and IoT devices. A choice of 650W or 1050W single or redundant AC power supply and 700W DC power supply options allow administrators to customize power allocation and redundancy to meet their use cases and budget.

### **Dynamic Power Management**


