to the design are easier to achieve. As the project progresses, we will consider alternate systems that can provide the required result in a way that is cost-effective, both short-term and long-term. We will also develop alternate bid items to ensure that the project stays within the budget. During construction, we will work with the contractors to establish a team relationship so that as issues arise, we can work together to find the most cost-effective solution. 



















# Blennerhassett Island Landing WV Division of Natural Resources Parkersburg, West Virginia

The project included a new floating concrete dock and gangway, as well as mooring pilings for the State sternwheeler, the Island Belle.








## WV Department of Natural Resources Winfield Boat Ramp




## **Guyandotte Boating Access**WV Division of Natural Resources

The West Virginia Division of Natural Resources teamed with the City of Huntington to develop boating access on the Ohio River in the Guyandotte area of Huntington, West Virginina. An extra-wide ramp will allow for two boats to be launched at the same time, and an ADA-compliant courtesy dock will allow for easy passenger access.

Parking for more than 50 cars and trailers will be provided. The site was designed using lowimpact, green infrastructure techniques.







## City of Moundsville Boarding Dock

Moundsville, West Virginia

The Moundsville Boarding Dock project consisted of the design and construction of an ADA accessible public courtesy dock to replace the existing dock. Four new accessible boat trailer parking spaces were included, along with a concrete accessible walkway from the parking down to the dock and ramp areas. A floating, pontoon-style debris barrier was installed upstream of the dock for the purpose of deflecting debris flow which could damage the dock. Stabilization and riprap armoring of the river bank in the immediate project area was also completed.








## WV Division of Natural Resources Nitro Boat Ramp

Located on the Kanawha River in Putnam County, the old boating facilities near the Town of Buffalo had fallen into disrepair. A new self-cleaning boat ramp was designed, along with an ADA-accessible courtesy dock. Parking, drainage, and general access was also improved in the \$500,000 project.


