EIGHTEEN (18) 100 GALLON TRUCK-TYPE FIRE SUPPRESSION SKID UNITS

Q.1 We were looking at a recent bid that has put out for 18 100G skid units and were hoping to get some clarification on the pump if possible from you? The bid asks for a removeable wick-100 pump and we were wondering if there are any ways around this feature? It seems counterintuitive to have a pump plumbed into the skid unit then be able to disconnect it from the plumbing somehow and be of use so we were trying to understand the project more because we wanted to put in a bid on it.

Is there a possibility to sell the skid units as one unit then have a backup hand pump for drafting or other operations like the wick pump separate from the skid?

A.1 We are requiring the Wick 100 variant pumps or equivalent for the following features. The unit must have a 4 cycle engine, be able to operate at any angle, have a single stage pump head and centrifugal clutch.

We have built our skid units to pump and roll by a single firefighter. We operate in steep terrain so the pump must be able to run setting at any angle. The centrifugal clutch allows one man operation so the firefighter can pull up on scene, start the pump and work the hose lay. They can pull hose or reposition the hose lay without turning off the pump or mess with recirculating water back into the tank. They reposition the truck while leaving the powerhead running without pumping water, or losing draft. We have a lot of remote water sources that you can not get a vehicle to. The quick detach feature allows us to quickly remove the pump to get to the remote water sources. This also allows us to quickly swap out if the pump goes down. We do not want to deal with the added expense and storage issues of multiple pumps.

Q.2 Will you accept the Vallfirest BH-1 and/or Mercedes WICK100-4H pump as an equal?

Rationale: They both have a centrifugal clutch, these pumps outperform the WICK100-4M making them more effective for a Type 7. Its engine has been an effective backpack pump for decades with Waterax , Mercedes, and now Vallfirest.

A.2 Yes, provided that the pump meets all mandatory specifications. We operate in steep terrain so the pump must be able to run setting at any angle.

Q.3 We did not see the following items included in the bid specification and wanted to clarify if they should be:

- 1. A hand primer for the pump?**
- 2. For the hose reel, there is no roller fairlead mentioned, should one be included?**
- 3. 1 ½" tank fill, is this a direct fill or tank fill/recirculate?**
- 4. Should the pump be draft capable from overboard?**
- 5. Should suction hose be included?**

A.3 Yes, there should be a hand primer for the pump.

Yes, there should be a roller fairlead included for the hose reel.

Yes, the tank fill is a direct fill.

Yes, the pump should be draft capable from overboard.

Yes, a suction hose should be included.

INSTRUCTIONS TO VENDORS SUBMITTING BIDS

1. REVIEW DOCUMENTS THOROUGHLY: The attached documents contain a solicitation for bids. Please read these instructions and all documents attached in their entirety. These instructions provide critical information about requirements that if overlooked could lead to disqualification of a Vendor's bid. All bids must be submitted in accordance with the provisions contained in these instructions and the Solicitation. Failure to do so may result in disqualification of Vendor's bid.

2. MANDATORY TERMS: The Solicitation may contain mandatory provisions identified by the use of the words "must," "will," and "shall." Failure to comply with a mandatory term in the Solicitation will result in bid disqualification.

3. PREBID MEETING: The item identified below shall apply to this Solicitation.

All Vendors submitting a bid must attend the mandatory pre-bid meeting. Failure to attend the mandatory pre-bid meeting shall result in disqualification of the Vendor's bid. The Purchasing Division will disclose any document labeled "confidential," "proprietary," "trade secret," "private," or labeled with any other claim against public disclosure of the documents, to include any "trade secrets" as defined by West Virginia Code § 47-22-1 et seq. All submissions are subject to public disclosure without notice.

32. LICENSING: In accordance with West Virginia Code of State Rules § 148-1-6.1.e, Vendor must be licensed and in good standing in accordance with any and all state and local laws and requirements by any state or local agency of West Virginia, including, but not limited to, the West Virginia Secretary of State's Office, the West Virginia Tax Department, West Virginia Insurance Commission, or any other state agency or political subdivision. Obligations related to political subdivisions may include, but are not limited to, business licensing, business and occupation taxes, inspection compliance, permitting, etc. Upon request, the Vendor must provide all necessary releases to obtain information to enable the Purchasing Division Director or the Agency to verify that the Vendor is licensed and in good standing with the above entities.

SUBCONTRACTOR COMPLIANCE: Vendor shall notify all subcontractors providing commodities or services related to this Contract that as subcontractors, they too are required to be licensed, in good standing, and up-to-date on all state and local obligations as described in this section. 33. Such assignment shall be made and become effective at the time the purchasing agency tenders the initial payment to Vendor.

35. VENDOR RELATIONSHIP: The relationship of the Vendor to the State shall be that of an independent contractor and no principal-agent relationship or employer-employee relationship is contemplated or created by this Contract. The Vendor as an independent contractor is solely liable for the acts and omissions of its employees and agents. Vendor shall be responsible for selecting, supervising, and compensating any and all individuals employed pursuant to the terms of this Solicitation and resulting contract. Neither the Vendor, nor any employees or subcontractors of the Vendor, shall be deemed to be employees of the State for any purpose whatsoever. Vendor shall be exclusively responsible for payment of employees and contractors for all wages and salaries, taxes, withholding payments, penalties, fees, fringe benefits, professional liability insurance premiums, contributions to insurance and pension, or other deferred compensation plans, including but not limited to, Workers' Compensation and Social Security obligations, licensing fees, etc. and the filing of all necessary documents, forms, and returns pertinent to all of the foregoing.

Vendor shall hold harmless the State, and shall provide the State and Agency with a defense against any and all claims including, but not limited to, the foregoing payments, withholdings, contributions, taxes, Social Security taxes, and employer income tax returns.

36. INDEMNIFICATION: The Vendor agrees to indemnify, defend, and hold harmless the State and the Agency, their officers, and employees from and against: (1) Any claims or losses for services rendered by any subcontractor, person, or firm performing or supplying services, materials, or supplies in connection with the performance of the Contract; (2) Any claims or losses resulting to any person or entity injured or damaged by the Vendor, its officers, employees, or subcontractors by the publication, translation, reproduction, delivery, performance, use, or disposition of any data used under the Contract in a manner not authorized by the Contract, or by Federal or State statutes or regulations; and (3) Any failure of the Vendor, its officers, employees, or subcontractors to observe State and Federal laws including, but not limited to, labor and wage and hour laws.

37. NO DEBT CERTIFICATION: In accordance with West Virginia Code §§ 5A-3-10a and 5-22-1(i), the State is prohibited from awarding a contract to any bidder that owes a debt to the State or a political subdivision of the State. By submitting a bid, or entering into a contract with the State, Vendor is affirming that (1) for construction contracts, the Vendor is not in default on any monetary obligation owed to the state or a political subdivision of the state, and (2) for all other contracts, neither the Vendor nor any related party owe a debt as defined above, and neither the Vendor nor any related party are in employer default as defined in the statute cited above unless the debt or employer default is permitted under the statute.

38. CONFLICT OF INTEREST: Vendor, its officers or members or employees, shall not presently have or acquire an interest, direct or indirect, which would conflict with or compromise the performance of its obligations hereunder. Vendor shall periodically inquire of its officers, members and employees to ensure that a conflict of interest does not arise. Any conflict of interest discovered shall be promptly presented in detail to the Agency.
