# **Response to Specifications**

Visual Language Professionals, LLC is honored and excited to present our proposal to continue providing high quality American Sign Language (ASL) interpreting services to provide remote video sign to voice and/or voice to sign interpretation when needed for meetings, events, and in classroom settings to West Virginia Schools for the Deaf and Blind (WVSDB). Visual Language Professionals, LLC (VLP) will ensure that all interpreters providing services as a result of this contract will possess at minimum, a valid NIC, NAD, RID, or state certification to provide ASL interpreting services as well as at least three years of classroom educational interpreting experience. ASL interpreters providing services to WVSDB will also possess at least a 3.5 or higher on the EIPA or experience interpreting for a variety of content subject areas. VLP background checks all interpreters prior to hire, and all interpreters providing services are required to complete HIPAA and Ethics compliance training on an annual basis, to ensure alignment with confidentiality and interpreter best practices.

VLP can provide ASL interpreting services during the standard business hours described by WVSDB in the solicitation documents, and we are also available after hours and on weekends when requested. VLP currently employs a vast roster of qualified interpreters available to perform remote ASL interpreting services through this contract, should one be awarded. VLP is proposing a unit price of \$62.50/hour. Once the billing minimum has been met, services will be billed in 15 minute increments rounding up to the next quarter hour. VLP agrees with WVSDB's proposed cancellation policy in which only services cancelled with LESS than 24 hours notice will be billable a maximum of 2 hours.
