- 12.1.1. All existing gate posts, fence posts, fence fabric, barbed wire, brackets and hardware to be reused.
- 12.1.2. All existing gate posts, fence posts, fence fabric, barbed wire, brackets and hardware to be reinstalled in the same manner as it was found and in accordance with CLFMI.
- 12.1.3. New gate material shall comply with CLFMI and electric operator/ gate manufactures guidelines.
- 12.1.4. Electric operators shall be compatible with Galaxy Control Systems.

12.2. Access Hardware /Software:

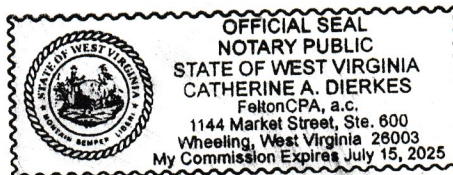
