RE: Request for Emergency Purchase: South Gate Road Slip (DESIGN Only)

On Monday, March 25, 2019, the Post Engineering Office at Camp Dawson was notified a slip had occurred along what is known as South Gate Road, which is the main access point to the Briery Mountain training area within the Camp Dawson property. Our agency entered into a lease with the WV Department of Transportation, Division of Highways for the right of way use of this road and is responsible for custody, maintenance, and operation of it per the terms of that lease. For safety reasons, the Post Commander for Camp Dawson has closed access to the road for most military vehicles and only compact or smaller vehicles are currently allowed to use this route until we can make repairs.

As the situation currently stands, the WV Army National Guard, the Adjutant General, and the State of West Virginia are in the position of potential liability should an accident occur in a military or state vehicle while using the only current access route into the Briery Mountain training site. That available route is a state road known as Route 7/13. It has restricted roadway width, passes several private residences, and has civilian traffic. We need this situation addressed and repaired before our summer training rotations start in June and July. We cannot have larger military vehicles using that route.

Due to the emergency nature and scope of the project, the required exploration and design services needed to abate and repair the site will need to be performed by an outside engineering firm. In accordance with Section 5G-1-3 of the State Code of West Virginia and Section 6.3.1.1 of the Purchasing Division Procedures Handbook, our agency declares that special circumstances exist and requests the Purchasing Director allow us to short-list and interview 3 civil engineering firms, Thrasher, CEC and E.L. Robinson Engineering to perform the design services needed at this site. The estimated cost for these services should not exceed \$35,000.00. Our agency cannot estimate the cost to make the needed repairs until we get an engineer of record under contract to evaluate the seriousness of the situation and provide construction documents and cost estimates.

It is with all of the urgency contained herein we respectfully ask for the approval of this emergency purchase.

Thank you in advance for your prompt consideration of this request.
