During a complaint investigation on February 26, 2109, an active landslide near the town of Smithers was found which as displaced areas of both Clay Street and WV Route 60. Multiple repairs have been made to the running surface of both roads. Emergency vehicle access to multiple residences on Clay Street are affected. The area of the landslide has been undermined in the Eagle Seam. Exploratory drilling conducted during the investigation confirms the abandoned mine contains a mine pool which may be influencing the landslide.

Based upon the conditions observed at the site and the potential for additional damage to infrastructure and or vehicles, an emergency reclamation project should be conducted at this site.

Due to the scope of the project, the required design services to abate the problems at the site will have to be performed by an outside engineering firm. In accordance with Section 5G-1-4 of the State Code of West Virginia, since a special circumstance exists and the cost of the project is estimated to be less than \$250,000.00, I have the option of selecting an architectural/engineering firm on the basis of satisfactory performance and knowledge of the agency's needs. Therefore, I propose to utilize E.L. Robinson Engineering of Charleston, WV to perform the required services at the site. The estimated cost for these services should not exceed \$50,000.00. The estimated cost of the site reclamation portion of the project should not exceed \$750,000.00.
