Dear Mr. Sheets,

The Landfill Closure Assistance Program is requesting approval of a 60-day emergency contract for the hauling of landfill leachate from the Pine Creek Omar Landfill (Landfill) to the Logan County Public Service District (PSD). Based on the maximum total gallons that can be disposed of at the PSD and current hauling volumes and prices, the estimated cost for the emergency hauling is \$250,000.00.

This Landfill continuously produces leachate and if significant rainfall occurs, the leachate could overflow the secondary tank and onto the ground potentially causing a danger to human health and/or the environment. Additionally, the current CMA, DEP2100000003, will expire on July 31, 2021 and WVDEP has chosen not to renew this CMA. This decision is based on the June 9, 2021 letter from West Virginia Purchasing to Ms. Joyce Matney notifying her that probable cause exists to begin debarment proceedings against Mountaineer Trucking.

Approval of this 60-day emergency hauling request will allow both Agencies time to issue a new solicitation and work through any potential legal proceedings resulting from the debarment of Mountaineer Trucking.
