Re: Emergency purchase of contract to provide IP delivery of our broadcast feeds.

Mr. Sheets:

Our agency has been working to replace our current satellite delivery of our broadcast feeds with an IP-based solution. Our initial need related to the delivery of the Lottery drawing to other stations in WV and surrounding areas. This could be done in sufficient time to go to bid, but we now have a new need that is more urgent.

We have been selected to broadcast a Dolly Parton event at the Clay Center on August 9<sup>th</sup>, 2022. This is an extremely high visibility event for the State, and failure of any kind is not an option. In preparation for this we have reviewed our current delivery method and determined that there are too many points of failure on the satellite systems to trust such an important event to satellite without a backup/new primary delivery method in place. It is for this reason, as well as cost savings, that we were already working to institute IP-based delivery of our broadcast feeds.

The delivery time of the IP-based broadcast method is approximately four (4) weeks. This doesn't allow enough time to solicit bids, have this in place, train staff, and test the new system in time for the Dolly Parton event.

We have been able to find only three (3) qualified providers of this service. We have a quote from the most prevalent vendor in the industry of approximately \$40,000.00 per year. We will continue working to get quotes from the other two vendors.

We are requesting your approval to establish a contract for an IP-based broadcast delivery system on an emergency basis. Please provide us a determination at your earliest convenience.
