The West Virginia Tax Department (TAX) is requesting a three-month emergency contract be issued to replace CMA VoIP13EEEE, Hosted Voice and Contact Center Services. This emergency contract, tentatively called VoIP13E-TAX, will be awarded to Verizon Business for the continuation of existing services and be effective January 21, 2022, through April 20, 2022. The monthly cost will be approximately \$24,000; however, that cost is only expected to decrease as the migration to the Segra Hosted Voice Contract, VoIP19 is completed.

Tax is asking that this emergency contract not be a Statewide, only a contract between TAX and Verizon Business. Because of the relatively low usage and cost, and the Office of Technology (WVOT) has removed themselves from the ordering, billing, and payment process with Verizon. This three-month contract does not meet the traditional definition of a Statewide; however, as with previous requests from WVOT, TAX is requesting that the new contract incorporate VoIP13 and all of its emergency iterations to form the basis of the agreement.

As with most things, the COVID-19 Pandemic and staffing shortages have impacted the Tax Departments ability to complete the migration on a timely basis. We believe this Emergency contract will allow adequate time for the migration to be completed.
