On 7/08/2022, the Point Pleasant BII Building suffered severe roof damage because of a thunderstorm cell that occurred in the area that evening. It was Monday, July 11, before the damage was noticed by a caretaker that was mowing grass and noticed several roof fasteners on the ground. The caretaker entered the building and discovered massive amounts of water on the floor. He accessed the roof and discovered the roofing membrane rolled back and the decking exposed on a significant portion of the roof.

The Division of Engineering & Facilities was contracted and informed of the situation. The caretaker was instructed to get the roof covered as soon as possible. I gave preliminary Emergency Purchasing approval and our office contacted Tri-State Roofing. The contractor arrived July 14, conducted an inspection of the situation and offered two options, one for repairing the affected area only and one for total roof replacement.

Copies of both proposals are attached with this memo along with photos of the damaged roof and building interior.


We have filed a claim with BRIM and are waiting to find out which option they will entertain and approve.





Mr. Griffith,

Tri-State Roofing and Sheet Metal Company inspected the roof at 729 Fairground Road, Point Pleasant, WV, on July 15, 2022.

Visible wind damage was observed, as evidenced by the membrane being loose and wrinkled over approximately 40% of the roof. The membrane had been pulled back into place and temporarily tacked down with tarps, covering exposed areas, to mitigate interior damage.

Upon inspection, several of the button caps across the roof, including on the opposite side of the blow off, had popped. There was also visible wind de-lamination of the membrane on the parapet walls on the far side of the roof, which indicates the wind uplift damaged the entire system.

Our recommendation would be to replace the roof in its entirety. Attached is a proposal to go back with a similar EPDM system. The button cap system is no longer manufactured, so we would be installing an adhered membrane.

The existing roof had EPS insulation and HD wood fiberboard. Typically, EPS is not used in roofing anymore due to the flammability. Polyiso insulation has been used in our replacement quote.

Replacement quote uses polyiso in lieu of EPS due to flammability of EPS, 1.5" polyiso is needed for enough rigidity to span metal deck flutes. Button cap systems are no longer manufactured. Adhered system is quoted as 'like' replacement.
