SUBJECT: Emergency Contract for SentinelOne Services

DATE: December 8, 2025

The West Virginia Office of Technology (WVOT) is requesting a one-year emergency contract for the continuation of services offered with SentinelOne. This emergency contract is necessary to ensure no disruption of network security for the Executive Branch agencies.

The WVOT is requesting the Emergency be awarded to SentinelOne, as no other vendor can provide the uninterrupted services of the SentinelOne Complete Protection Platform. Because transitioning takes considerable time, no third-party solution is feasible either. If the State were to award to a company other than SentinelOne, the State would have to transition to this third party exposing the Executive Branch agencies to potential security risks. The current contract is CPO OOT25*05. The reason we are asking for an emergency and time is limited is this contract ends Jan 5, 2026. Security had a different plan scheduled to take over for this contract, but found out at approximately Nov 20 that the server hardware was not capable of handling their planned change. So we had to adjust plan to use SentinelOne for another year while they planned the needed changes.

Because of the foregoing reasons, the WVOT is requesting a one-year Emergency Contract, January 5, 2026 through January 4 2027, for the Complete Protection Platform licenses with SentinelOne for continuity of services. The total cost for these licenses is \$431,513.60.


