REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)**

1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. All quotations are governed by the *West Virginia Code* and the *Legislative Rules* of the Purchasing Division.
4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
5. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
6. Payment may only be made after the delivery and acceptance of goods or services.
7. Interest may be paid for late payment in accordance with the *West Virginia Code*.
8. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
12. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
13. **BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, the State may deem this contract null and void, and terminate such contract without further order.

Duck Creek (Jenkins) Landslide Project**

The Contractor's work hours for this project will be 7:00 a.m. to 7:00 p.m. Monday through Saturday. Work on Sunday and major holidays shall not be allowed on this project.

The following questions were identified from the Pre-Bid Conference. The answers provided herein take precedence over verbal answers at the PBC should there be any conflicts between the two.

- 1.) Q. Is payment for the drop inlet incidental to the bid item for the pipe installation?
A. Yes.
- 2.) Q. What size is the gas line that is located within the project area?
A. It is a feeder line.
- 3.) Q. Who is the owner?
A. Dominion Gas.
- 4.) Q. Has the existing haul road to the excess material disposal site been stoned?
A. Yes.
- 5.) Q. Is the stone that is provided for on the Bid Schedule to be placed on the access road and not the haul road?
A. Yes.
- 6.) Q. Will the route of the haul road change?
A. No.
- 7.) Q. Will the sediment ditch adjacent to the disposal area require cleaning?
A. No, it is not to be disturbed.
- 8.) Q. Has right of way for using the haul road already been obtained?
A. Yes.
- 9.) Q. What is the requirement regarding the water well?
A. Don't adversely impact the water quality.
- 10.) Q. How much cut is there at the toe?
A. As shown on the cross sections.
- 11.) Q. The plans indicate that the piezometers are to be closed, but they are mostly located in cut sections. How is this to be accomplished?
A. Pull the piezometer casing prior to performing the excavation for regrading the slide area.

- 12.) **Q.** Will the contractor be allowed to mobilize from the excess material disposal site, using it as a staging area?
- A.** Mobilization and staging for the project has always been anticipated to occur at the bottom of the hill to the west of the Jenkins residence. As such, the construction limits were not established to allow for staging from any other location. If bidders desire to mobilize and stage construction from the top of the hill they will have to independently negotiate that location with the mine permittee and/or land owner. Furthermore, any revisions to the permit that this would entail as a result would have to be approved by the Division of Mining and Reclamation. Please note that the surface mine located at the top of the hill to the north of the project is a permitted and bonded area with the WVDEP. As such, any contractor activities in the permitted area are subject to MSHA and OSM regulations and requirements.



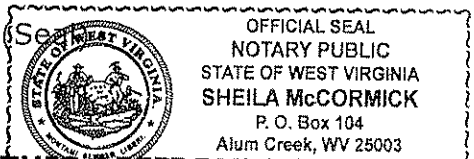
