Division of Rehabilitation Services Honors Client Achievements

The Division of Rehabilitation Services (DRS) held its annual Ability Works Recognition Ceremony on October 18 in Institute, West Virginia. Through its 29 field offices, DRS operates the state and federal vocational rehabilitation program and specializes in helping people with disabilities who want to find a job or maintain current employment. The ceremony honored eight individuals who have achieved their vocational goals by means of their own perseverance and with assistance from DRS.

The 2007 Ability Works Recognition recipients were:

Joe Voloski, 25, recovered from a life-threatening car accident to become a Naval firefighter in Yorktown, Virginia (State Winner).

Khadidra Taylor, 26, is a social service worker for DHHR's Bureau for Children and Families despite battling McCune-Albright Syndrome, a rare genetic disease (Charleston District).

Amie Becilla, 29, has insulin-dependent diabetes and teaches special education students at Westwood Middle School in Morgantown (Clarksburg District).

Sharon Hastings, 47, is a top salesperson for LiveOps, a virtual telemarketing firm, despite battling chronic fatigue syndrome, fibromyalgia and chronic lobular hepatitis (Wheeling District).

Steven Bennett, 31, returned to school and became a rehabilitation counselor for the Virginia Department for the Blind and Visually Impaired after losing much of his vision (Beckley District).

Sharon Jenkins, 53, works as an administrative assistant at the Lewis College of Business at Marshall University after recovering from an accident that nearly severed her hand (Huntington District).

Jeremy Hubbard, 27, has cerebral palsy and works as the associate director of education at Sylvan Learning Center in Martinsburg (Martinsburg District).

Dave Romine, 53, is a radiation technologist at the Center for Cancer Care in Fairlea. Degenerative disc disease forced him to leave his job as a lineman (Lewisburg District).

12th History Day at State Capitol Set for Feb. 21, 2008

Local groups with an interest in history or genealogy are invited to participate in the 12th West Virginia History Day on February 21, 2008 at the State Capitol Complex in Charleston during the regular session of the West Virginia Legislature. Local historical groups are expected to provide displays and reenactments in the Rotunda of the State Capitol.

Historians, genealogists, educators, preservationists, veterans, fraternal organizations, librarians, ethnic groups, and families and individuals with an interest in West Virginia's history are invited to provide exhibits featuring historical documents, photographs, artifacts, and publications. Other attractions will include reenactments of events in the State's history, music, story-

telling, and a ceremony honoring citizens from across the State who have made contributions to the history of West Virginia.

At an awards ceremony in the State Theater of the Cultural Center, "History Hero" awards will be presented to people who have made significant grass-roots contributions to the preservation of local or regional history. Local historical, genealogical, preservation, museum, patriotic, and other similar groups are encouraged to provide nominations for the awards. Authorized by the legislature, West Virginia History Day commemorates local groups' efforts to preserve, protect, and promote the study of the Mountain State's past.

The West Virginia Division of Culture and History joins the Archives and History Commission, West Virginia Historical Society, West Virginia Historical Association, Preservation Alliance of West Virginia, West Virginia Humanities Council, West Virginia Association of Museums, Friends of West Virginia Culture and History, and Mining Your History Foundation as organizers of this year's events. All West Virginia History Day events are free and open to the public.

History Hero nominations must be postmarked by December 31. Nominations also may be handdelivered to the Archives and History Library at the Cultural Center in the Capitol Complex by that deadline. Applications from groups interested in setting up displays on history-related projects are due by January 28, 2008.

WHAT TO DO FOR A KITCHEN FIRE

In last month's *Stateline*, we provided you with information on how to prevent kitchen fires. Even with the best precautions, a fire can still spark. Here's some helpful information on what to do if happens to you. Clip this article and tape it to the inside of a kitchen cabinet for quick reference!

- * Call 911 immediately. You can always cancel the call if you get things clearly under control.
- If the fire is, or becomes, large or out of control, do the smart thing and leave the residence immediately!
- *Keep three things handy: A pan lid (preferably one that fits multiple pans), baking soda, and an ABC-rated fire extinguisher. Make sure you know how to use the extinguisher. Never use water or flour on cooking fires.
- * If a small item is on fire and you can do it safely, put it in the sink and then extinguish it.
- * Unplug small appliances like toasters or coffee pots if you can do it safely.

- ** Keep at least one working smoke detector in your home and test it monthly; change the batteries when adjusting your clocks for daylight savings time and eastern standard time.
- ★ Slide a pan lid over flames to smother a grease or oil fire in a pot or skillet. Turn off the heat.
- For small grease/oil fires elsewhere, and for all other fires, throw baking soda over the flames.
- For oven, broiler, or microwave fires, keep the oven door shut and turn off the heat or the microwave.
- *You remember the "stop, drop, and roll" training you received in school, right? Use it if your clothes catch fire.

Each limited edition ornament – 500 made each year – illustrates a different perspective of the mansion and is designed and carved by New Martinsville juried artisan, Doug Coleman. Each glass piece is individually hand-cut and sand-blasted in Coleman's studio, making each one a one-of-a-kind decoration.

West Virginia Governor's Mansion is a 30-room Georgian revival structure overlooking the Kanawha River, designed by Charleston architect Walter F. Martens. It was started in 1924 and completed right before the gubernatorial inauguration in 1926.

A portion of the proceeds from the ornament sales benefits the West Virginia Governor's Mansion Preservation Foundation to ensure future generations will be able to enjoy the mansion's rich history.

COULD IT BE A STROKE?

One way to identify a possible stroke is to ask the person to stick out his/her tongue. If the tongue goes crooked – to one side or the other – it could be a signal the person has suffered a stroke.

Other possible clues are to ask the person to smile, repeat a simple sentence (such as "The sun is shining today."), and/or to raise both arms. If he or she has difficulty with any of these tasks, call 911 immediately. Quicker treatment means better recovery.
