Please allow this memorandum to serve as written explanation and justification for our request for Change Order #1 to increase CPO 0211 GSD2200000003, for the rental of security fencing in the amount of \$77.72, bring the total monthly cost to \$362.72 from \$285.00 due to the reasons listed below.

After the set up of the security fencing, GSD discovered a few areas that were not protected and additional fencing was required to cover these areas. The areas needing fencing are the openings in the parking garage walls.

Melissa,

Due to the methodology that we utilized for the unit price based upon monthly rental, this is a bit of a mathematical work around to make the determination.

Initial Contract - Monthly Rate/Feet of Fencing (285/650 = \$0.4385)

Adjusted Contract - Monthly Rate/Feet of Fencing (362.72/830 = \$0.437)

The actual price per foot of fencing decreased.
