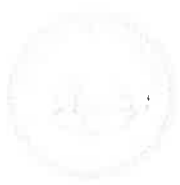

John,

We regret to inform you that the chassis ordered to Ford Motor Company for the attached Passenger Van order for Marshall County was not produced this year by Ford. They are not providing our company with an ETA or reasoning why it was not produced. At this point Ford has also raised prices to a level that is well beyond the original negotiated contracted pricing for these vans to a point where my company and the manufacturers I represent simply cannot afford to absorb the price increases. The only way for us to be able to produce this unit with the ongoing economic circumstances is to raise our price accordingly based on the OEM manufacturers price increases we have received. This would make the cost of this unit well beyond what was originally negotiated on the contract. Therefore, we must inform you that we will have to cancel this order for Marshall County due to chassis unavailability and our inability to absorb the price increases from the OEM suppliers.

We want you to know we did everything in our power to produce this unit at the original negotiated contract pricing but factors outside of my company's control dictated otherwise.
