Contract Item 3.1.4 Class A Women's Short Sleeve Shirt

Original item and color was discontinued. Replacing Item SH3975 with Item SH3788, color dark gray. Price remains the same.

Contract Item 3.1.5 Class A Men's Long Sleeve Shirt

Original item and color was discontinued. Replacing Item SH3726 with Item SH3789, color dark gray. Price remains the same.

Contract Item 3.1.6 Class A Women's Long Sleeve Shirt

Original item and color was discontinued. Replacing Item SJ133 with Item SH3790, color dark gray. Price remains the same.

Contract Item 3.1.32 5 in 1 Duty Jacket

Original item was discontinued. Replacing Item JA432 with Item JA2473 MFG# 48360T. Price remains the same.

Contract Item 3.1.52 Double Magazine Pouch

The Agency changed duty weapons and the bullet caliber changed. The magazine pouch has to accommodate the larger size. Replacing Item NP352 with Item LP665 STX BLK 83. The price remains the same.

Contract Item 3.1.59 Weapon Holster

The Agency changed duty weapons and a larger holster is needed to properly fit the new weapon. Replacing Item LP198 with Item LP145 (SPLH2222 Left hand and SPRH2222 Right Hand). The price will decrease from \$175.00 to \$153.00.
