1. Introduction

The following sections in this Statement of Work (SOW) represent the background, scope, and schedule of the WV PATH enhancement as allowed under the WV Integrated Eligibility System (IES) Project, as well as high-level pricing and work estimate by Optum, a plan for staffing by Optum, and assumptions made by Optum in connection with the work.

This SOW will include the following work related to both the FACTS and the WV PATH solutions:

 Compliance Updates for Adoption Foster Care Analysis and Reporting System (AFCARS) 2020 (AFCARS 2020), renamed from AFCARS 2.0 to reflect additional changes following public comment.

WV PATH Child Welfare (CW) Go-Live is January 1, 2023. The first AFCARS 2020 reporting period is October 1, 2022 through March 31, 2023. The first submission date for the 23A submission under AFCARS 2020 using the new Federal XML format is May 15, 2023.

This SOW outlines the level of effort necessary for Optum and DHHR to prepare the WV PATH system to:

- Capture new and modified AFCARS 2020 fields in WV PATH and submit an AFCARS 2020 compliant file via the Federal XML submission process.
- Extract data from FACTS and combine it with WV PATH derived data for the 23A submission in May 2023.
- Manage the backfill of data in WV PATH to support new and modified fields for persons converted into WV PATH.

1.2. Pricing and Payment

All work activity as outlined in this SOW is on a Time and Material basis and will be billed to WV DHHR starting at \$124.00 per hour during Contract Year 6 (Year 6), which starts on November 17, 2022, in accordance with the WV IES Contract. For any work remaining after November 16, 2023, the hourly rate will become \$128 per hour during Contract Year 7 (Year 7), which is mutually agreed upon by Optum and WV DHHR in the WV IES Contract.

1.3. Payment Schedule

The estimate of hours listed below is based on the tasks that will be assigned to Optum resources in the Project Plan. As this is a time and materials arrangement, the specific task assignments may be adjusted as approved by the DHHR Project Manager. The effort required above the totals herein will require a mutually accepted change request, the process being outlined in WV IES Deliverable 021 — Change Management Plan, Section Two: Change Management Approach.

1.4. Invoicing

Invoices for Services provided under this SOW shall be in a form approved by DHHR. The Optum invoice will identify the Delivery Order and the Central Master Agreement numbers, the completed task/deliverable, the work hours completed the previous month, reflect the dates of service and the date of completion, and may include supporting documentation to verify that the task/deliverable was completed.

DHHR shall pay Optum for the Services under this SOW, per Section 1.2 above.



2. Scope of Work

The period of performance for this Statement of Work shall commence on the effective date in the Delivery Order ("Effective Date") and continue under Section 2.8 (Project Activities).

Adoption Foster Care Analysis and Reporting System (AFCARS) 2020.

2.1.1. AFCARS Background

AFCARS is a mandatory federal compliance report of Title IV-E funded activities as part of the WV DHHR Child Welfare's CCWIS requirements being implemented in the West Virginia People's Access to Help (WV PATH) system. It is required if a state, territory, or tribe is operating foster care, adoption, and/or subsidized kinship relative under a federal Title IV-E state plan.

The United States Congress and the Office of Management and Budget use the data collected to determine general funding of the Foster Care, Adoption, and Subsidized Legal Guardian programs and the individual state allocations of that funding. It is also important to note that failure to report can lead to federal funding disallowance of Title IV-E monies, and uncorrected or insufficient reporting is subject to financial penalties that are deducted from Title IV-E administration claim.

Previously on July 30, 2020, Optum and WV DHHR had agreed to implement AFCARS 1.0 reporting in WV PATH.

The Children's Bureau (CB) released AFCARS 2.0 in 2017 with an implementation date of October 2019. However, due to several inquiries around the increase in data elements, including increased data capture requirements particularly for Indian Tribe and Sexual Orientation, the implementation deadline was pushed out until October 2020. Further state comments caused the federal implementation date to be delayed further. Current Federal guidance on this topic indicates that Child Welfare systems must be ready to collect data sufficiently to support AFCARS 2020 by October 1, 2022.

This SOW supports parties' agreement that WV PATH be modified to support AFCARS 2020 data collection beginning with the WV PATH Child Welfare (CW) Go-Live, currently scheduled for January 1, 2023 (CW Go-Live). This scope covers the following broad components:

- Modification to WW PATH screens, batches, and reports to allow the data capture of AFCARS 2020 fields, their reporting, extraction, and submission to the new Federal XML AFCARS 2020 system.
- Extract data from FACTS pertaining to the period between October 1 2022 and WV PATH go live, which must be included as part of the first AFCARS submission (23A).
- Provision of functionality to support WV DHHR caseworkers in backfilling data into WV PATH for converted person records necessary for AFCARS 2020 submission (23A) in May 2023. Going forward, the submissions will be inclusive of all WV PATH data with the next submission (23B) in November 2023 timeframe.

Each of these strands of work is discussed in the sections below.



2.1.2. AFCARS 2020 WV PATH Required Enhancements

AFCARS 2020 requires that WV PATH include the following modifications by Optum:

- Modify WV PATH screens to capture new and modified AFCARS 2020 fields. Optum will enhance
 the underlying WV PATH Child Welfare database to support these changes to the screens in
 support of the AFCARS 2020 requirements.
- Modify existing ETL process that transfers data to the data mart to reflect the new and modified AFCARS 2020 fields.
- Modify four (4) existing WV. PATH reports to reflect the new and modified AFCARS 2020 fields.
- Modify two (2) existing WV PATH batches to reflect the new and modified AFCARS 2020 fields.
- Replace the current flat file AFCARS submission mechanism with the new XML submission mechanism.
- Change the submission from a flat file to XML format and the inclusion of additional data elements which capture more details related to the Foster Care, Adoption, and Subsidized Legal Guardian programs.
- Modify screens and tables in the existing WV PATH application.
- Update ETL processes delivering data to the data mart for AFCARS reporting.
- Modify data extraction logic presently in FACTS to work with WV PATH to reflect all data, logic and format modifications required for AFCARS 2020.

2.1.3. AFCARS 2020 FACTS Data Extraction

Additionally, this SOW provides the level of effort required for Optum to assist WV DHHR with the analysis and extraction of AFCARS 2020 data from the legacy FACTS system.

The AFCARS reporting period extends from October 1, 2022 through March 31, 2023. The precise approach to selecting records for conversion is under discussion at the time of writing. However, all currently proposed approaches will leave some records – which are AFCARS 2020 reportable – within FACTS.

Records that may not be migrated to WV PATH because they are not needed for the WV PATH CW Go-Live, but will still need to be analyzed for AFCARS reporting, include the following:

- Persons within cases that are opened prior to October 1, 2022 but which close prior to WV PATH CW Go-Live.
- Persons within cases that open and close between October 1, 2022 and WV PATH CW Go-Live.
- Persons within cases that are open at Go-Live, but where records were previously reported to AFCARS, but are not converted or tagged for data conversion into WV PATH. These records are still required to be submitted as part of the May 2023 AFCARS reporting submission.
- Persons within cases that are closed prior to October 1, 2022 but for whom case activity was performed after October 1, 2022, but prior to the CW Go-Live.

The total count of persons in these groups is presently estimated to be 2,000. For this group, Optum will create an AFCARS 2020 conversion process to convert the FACTS AFCARS extract into the WV PATH AFCARS 2020 staging tables. These records will never appear as WV PATH records. They are needed in the AFCARS 2020 staging tables to simplify the merging process that occurs between WV PATH and FACTS records for AFCARS reporting.



2.1.4. Support for State Data Backfill

Prior to 23A submission in May, it will be necessary to backfill AFCARS 2020 data into existing records. The nature and approach for this work falls into two categories:

- Backfilling of FACTS only records. This is the set of data converted into AFCARS staging tables from FACTS (estimated 2,000 person records). For this group, Optum will develop a throwaway backfill tool to allow State users to backfill AFCARS 2020 into these 2,000 records. Optum will then upload this data into the AFCARS 2020 PATH staging tables.
- Backfilling PATH records converted from FACTS. Depending upon the approach selected for PATH conversion (tagging, auto tagging, something else), the number of records to be backfilled may reach 20,000. Completion of these records will be managed through PATH using the modified AFCARS 2020 screens and reports.

To ease the data entry requirement on the State for backfilling, Optum will seek to derive any data that it can from prior FACTS records. It is estimated that approximately half of the data backfilling may be derivable in this manner – this requires a proof of concept. The proof of concept has been estimated in the overall Level of Effort of this SOW. The State will be responsible for completion of any fields that cannot be derived.

WV DHHR will submit the first AFCARS 2020 report in May 2023 (23a submission) using the new XML format, and understands that some elements may not yet have populated the report because the overall transition period to WV PATH does not align exactly with AFCARS 2020 reporting periods.

WV DHHR anticipates the ACF will accept null entries in the XML file for the AFCARS 2020 (23a) submission (May 2023). Optum assumes WV DHHR will bring any feedback from ACF directly and immediately to Optum's attention, to address identified data issues with the AFCARS 2020 (23) submission (May 2023), understanding Optum will not be liable for penalties associated with incomplete or partial reporting.

Optum understands the second AFCARS 2020 (23b) submission (November 2023) will be required to be fully populated using the new XML format. Should this understanding change, Optum will work to provide WV DHHR an updated estimate, which could result in an additional Statement of Work to address changes deemed necessary to complete the AFCARS 2020 (23b) submission in November 2023.



2.1.5. AFCARS WV PATH Implementation Timeline

This SOW supports work effort for AFCARS 2020 to be organized into two distinct phases. Each phase has work effort for both Legacy FACTS and PATH CW.

3. SOW Related Documentation

3.1. SOW Project Artifacts

Optum will prepare and submit the following documentation specific to this SOW to DHHR:

- Project Milestones: This document will contain milestones of key tasks and deliverables.
- System Design Document: This document will contain a detailed system design for the new screen and database functionality being added to WV PATH and will be broken down by technical components.
- Data Mapping and Extraction Logic Matrix for All Elements required for AFCARS 2020.
- Test Plan/Results Document: This document will highlight the areas and types of testing that will be performed. It will also be composed of test scenarios and expected outcomes. Optum will use existing test scenarios. In addition, this document will provide a detailed outcome of all the test scenarios that were executed in the various phases of testing.

3.2. Deliverables

Deliverables for this Project are as follows:

- Final Deliverable submission, which shall be the enhancements that Optum develops, tests, and deploys that perform the updated functionality that corresponds to each enhanced update to support AFCARS 2020 identified in Section 2 above.
- Successful testing is defined as acceptance by the Federal AFCARS submission tool and data quality tool in their test region.
- Optum is providing both the documentation and approval of these changes in the Optum ServiceNow online ticketing system.
- Documentation around the system changes will be entered into a ServiceNow Change ticket and Optum will create an approval request in the Change Ticket for WV DHHR Leadership to approve implementing the changes in the WV PATH system.

3.3. Acceptance of Deliverables

The documents identified in Section 3.2 of this SOW will be formally submitted to DHHR for final review and approval.

DHHR shall review the Deliverables, notify Optum of any deficiency(ies), notify Optum when the SOW has been fulfilled, and Approve each Deliverable identified in Section 3.2 of this SOW, including the execution of the Deliverable Acceptance Form.



4. Estimate of Effort

Based on an industry-standard "Waterfall" Systems Development Life Cycle, the estimate of hours for this Statement of Work is shown below and not to exceed unless documented and approved upon in a subsequent change request submitted to DHHR by Optum the process being outlined in WV IES Deliverable 021 – Change Management Plan, Section Two: Change Management Approach.

5. Project Assumptions

Below are the assumptions for this Project:

- Work commences under this SOW upon execution of the Delivery Order by DHHR.
- The rates proposed are valid through November 16, 2023.
- For any work needed beyond November 16, 2023, another Delivery Order will need to be executed to continue such work.
- WV DHHR will provide the personnel to perform User Acceptance Testing in accordance with the estimated timeline in Section 4.2 with the completion of UAT.
- Completion of UAT will be followed by a clear data quality result on a partial file.
- Completion of the project is when a compliant submission will have no issue being accepted according to the AFCARS 2020 criteria.
- An actual submission will require a full 6-month data set, (10/01/2022 to 03/31/2023).
- Optum and WV DHHR agree the first AFCARS 2020 submission may have missing data due to the 6-month reporting period (10/01/2022 to 03/31/2023) being during WV DHHR transition from legacy FACTS to WV PATH.
- Although the AFCARS 2020 XML file will contain all required data elements, not all fields in the new submission will be populated with data from the legacy system or WV PATH for the Spring 2023 submission. The subsequent Fall 2023 submission will be more complete.
- Optum will not be liable for any lost or reduced funding due to incomplete fields or partial reporting submission.
- There are federally defined financial penalties for incomplete AFCARS reporting, starting in May 2023, for which Optum will not be liable.
- Optum will not be liable for any federally defined financial penalties for incomplete AFCARS reporting.
- Only the credentialed WV DHHR data master can upload the AFCARS data into the Federal portal.
- Estimated timelines assume that the authorized representatives from the WV Office of Technology, and the MIS Staff respond to Optum requests and provide necessary input and/or approvals in a timely manner so Optum may continue to meet the requirements and timeframes identified herein.
- WV DHHR will provide Optum with as much notice as possible regarding potential delays in work
 progress within the project plan. Optum will not be held liable for missed deadlines held up by
 the completion of State-owned tasks or tasks with dependencies on State-owned tasks as
 documented in the project plan.
- Maintenance and Operations (M&O) impacts related to this SOW are not fully known and may require additional support and funding.
 Training on the new fields for AFCARS 2020 should remain a task with WV DHHR; Optum does
- not assume responsibility for training WW DHHR staff around the new AFCARS 2020 requirements.

 Optum and WV DHHR agree that the AFCARS 2020 (23A) submission cannot be delayed past May 2023 should other delays on the project prevent necessary testing of the AFCARS 2020 (23a) submission.
- The federal AFCARS submission has a fixed deadline of May 2023. The quality and completeness
 of this submission is at risk unless work is authorized to begin expeditiously.



6. Project Roles and Responsibilities

6.1. DHHR Roles and Responsibilities

DHHR roles and responsibilities are described below:

- Approve and execute the Delivery Order and the SOW prior to work commencing.
- Approve the software requirements specifications and provide the Business Requirement Document.

- Prepare User Acceptance Test plan/scenarios.
- Execute User Acceptance Testing.

- Ensure Optum is provided with a single resource as a Project lead and that Optum is provided with reasonable timely assistance to enable Optum to meet the requirements and timeframes identified herein.
- Train WV DHHR users on the new fields for AFCARS 2020.

- Provide expertise on system design, project management, code development, testing and deployment.
- Oversee assigned resources.
- Coordinate with the CB, on details such as portal access, data quality and data collection, and on updates to required data elements and file format.
- Designate a single Optum resource as the Project lead and as the single point of contact for the West Virginia Project Manager, who will be Vijay Patel.
- Provide Deliverables as defined in Section 3 of this SOW.
