## Change Order No. 2

This Change Order No. 2, dated December 16, 2022, amends the Statement of Work, dated June 30, 2022, between Ernst & Young LLP ("we" or "EY") and State of West Virginia ("State") related to EY's professional Services described in the SOW.

The SOW is hereby amended to incorporate the modifications set forth below. Except as modified by this Change Order No. 2, all terms and conditions of the SOW shall continue in full force and effect and be unaffected by this Change Order No. 2.

Attachment A (Dispute resolution procedures) is hereby deleted and replaced in its entirety with the following.

### Mediation

A party shall submit a dispute to mediation by written notice to the other party or parties. The mediator shall be selected by the parties. If the parties cannot agree on a mediator, the International Institute for Conflict Prevention and Resolution ("CPR") shall designate a mediator at the request of a party. Any mediator must be acceptable to all parties and must confirm in writing that he or she is not, and will not become during the term of the mediation, an employee, partner, executive officer, director of or beneficial owner with significant influence over any EY Firm audit client.

The mediator shall conduct the mediation as he/she determines, with the agreement of the parties. The parties shall discuss their differences in good faith and attempt, with the mediator's assistance, to reach an amicable resolution of the dispute. The mediation shall be treated as a settlement discussion and shall therefore be confidential. The mediator may not testify for either party in any later proceeding relating to the dispute. The mediation proceedings shall not be recorded or transcribed.

Each party shall bear its own costs in the mediation. The parties shall share equally the fees and expenses of the mediator.
