GENERAL TERMS AND CONDITIONS:

- 1. CONTRACTUAL AGREEMENT: Issuance of an Award Document signed by the Purchasing Division Director, or his designee, and approved as to form by the Attorney General's office constitutes acceptance by the State of this Contract made by and between the State of West Virginia and the Vendor. Vendor's signature on its bid, or on the Contract if the Contract is not the result of a bid solicitation, signifies Vendor's agreement to be bound by and accept the terms and conditions contained in this Contract.
- **2. DEFINITIONS:** As used in this Solicitation/Contract, the following terms shall have the meanings attributed to them below. Additional definitions may be found in the specifications included with this Solicitation/Contract.
- **2.1. "Agency"** or "**Agencies"** means the agency, board, commission, or other entity of the State of West Virginia that is identified on the first page of the Solicitation or any other public entity seeking to procure goods or services under this Contract.
- 2.2. "Bid" or "Proposal" means the vendors submitted response to this solicitation.
- **2.3.** "Contract" means the binding agreement that is entered into between the State and the Vendor to provide the goods or services requested in the Solicitation.
- **2.4. "Director"** means the Director of the West Virginia Department of Administration, Purchasing Division.
- **2.5. "Purchasing Division"** means the West Virginia Department of Administration, Purchasing Division.
- **2.6. "Award Document"** means the document signed by the Agency and the Purchasing Division, and approved as to form by the Attorney General, that identifies the Vendor as the contract holder.
- **2.7. "Solicitation"** means the official notice of an opportunity to supply the State with goods or services that is published by the Purchasing Division.
- **2.8. "State"** means the State of West Virginia and/or any of its agencies, commissions, boards, etc. as context requires.
- **2.9. "Vendor"** or "Vendors" means any entity submitting a bid in response to the Solicitation, the entity that has been selected as the lowest responsible bidder, or the entity that has been awarded the Contract as context requires.

3. CONTRACT TERM; RENEWAL; EXTENSION: The term of this Contract shall be determined in accordance with the category that has been identified as applicable to this Contract below:

Initial Contract Term: The Initial Contract Term will be for a period of one year The Initial Contract Term becomes effective on the effective start date listed on the first page of this Contract, identified as the State of West Virginia contract cover page containing the signatures of the Purchasing Division, Attorney General, and Encumbrance clerk (or another page identified as), and the Initial Contract Term ends on the effective end date also shown on the first page of this Contract.
Renewal Term: This Contract may be renewed upon the mutual written consent of the Agency, and the Vendor, with approval of the Purchasing Division and the Attorney General's office (Attorney General approval is as to form only). Any request for renewal should be delivered to the Agency and then submitted to the Purchasing Division thirty (30) days prior to the expiration date of the initial contract term or appropriate renewal term. A Contract renewal shall be in accordance with the terms and conditions of the original contract. Unless otherwise specified below, renewal of this Contract is limited to https://doi.org/10.2016/jhree/ successive one (1) year periods or multiple renewal periods of less than one year, provided that the multiple renewal periods do not exceed the total number of months available in all renewal years combined. Automatic renewal of this Contract is prohibited. Renewals must be approved by the Vendor, Agency, Purchasing Division and Attorney General's office (Attorney General approval is as to form only)
Alternate Renewal Term – This contract may be renewed for successive year periods or shorter periods provided that they do not exceed the total number of months contained in all available renewals. Automatic renewal of this Contract is prohibited. Renewals must be approved by the Vendor, Agency, Purchasing Division and Attorney General's office (Attorney General approval is as to form only)
Delivery Order Limitations: In the event that this contract permits delivery orders, a delivery order may only be issued during the time this Contract is in effect. Any delivery order issued within one year of the expiration of this Contract shall be effective for one year from the date the delivery order is issued. No delivery order may be extended beyond one year after this Contract has expired.
Fixed Period Contract: This Contract becomes effective upon Vendor's receipt of the notice to proceed and must be completed withindays.

The notice to proceed will then be incorporated into the Contract via change order to memorialize the official date that work commenced.
5. QUANTITIES: The quantities required under this Contract shall be determined in accordance with the category that has been identified as applicable to this Contract below.
✓ Open End Contract: Quantities listed in this Solicitation/Award Document are approximations only, based on estimates supplied by the Agency. It is understood and agreed that the Contract shall cover the quantities actually ordered for delivery during the term of the Contract, whether more or less than the quantities shown.
Service: The scope of the service to be provided will be more clearly defined in the specifications included herewith.
Combined Service and Goods: The scope of the service and deliverable goods to be provided will be more clearly defined in the specifications included herewith.

One-Time Purchase: This Contract is for the purchase of a set quantity of goods that are identified in the specifications included herewith. Once those items have been delivered, no additional goods may be procured under this Contract without an appropriate change order approved by the Vendor, Agency, Purchasing Division, and Attorney General's office.
Construction: This Contract is for construction activity more fully defined in the specifications.
6. EMERGENCY PURCHASES: The Purchasing Division Director may authorize the Agency to purchase goods or services in the open market that Vendor would otherwise provide under this Contract if those goods or services are for immediate or expedited delivery in an emergency. Emergencies shall include, but are not limited to, delays in transportation or an unanticipated increase in the volume of work. An emergency purchase in the open market, approved by the Purchasing Division Director, shall not constitute of breach of this Contract and shall not entitle the Vendor to any form of compensation or damages. This provision does not excuse the State from fulfilling its obligations under a One-Time Purchase contract.

- 9. WORKERS' COMPENSATION INSURANCE: Vendor shall comply with laws relating to workers compensation, shall maintain workers' compensation insurance when required, and shall furnish proof of workers' compensation insurance upon request.
- 10. VENUE: All legal actions for damages brought by Vendor against the State shall be brought in the West Virginia Claims Commission. Other causes of action must be brought in the West Virginia court authorized by statute to exercise jurisdiction over it.

ACCEPTANCE: Vendor's signature on its bid, or on the certification and signature page, constitutes an offer to the State that cannot be unilaterally withdrawn, signifies that the product or service proposed by vendor meets the mandatory requirements contained in the Solicitation for that product or service, unless otherwise indicated, and signifies acceptance of the terms and conditions contained in the Solicitation unless otherwise indicated.

Any information provided in specification manuals, or any other source, verbal or written, which contradicts or violates the West Virginia Constitution, West Virginia Code, or West Virginia Code of State Rules is void and of no effect.
- **22. COMPLIANCE WITH LAWS:** Vendor shall comply with all applicable federal, state, and local laws, regulations and ordinances. By submitting a bid, Vendor acknowledges that it has reviewed, understands, and will comply with all applicable laws, regulations, and ordinances.

Any change to existing contracts that adds work or changes contract cost, and were not included in the original contract, must be approved by the Purchasing Division and the Attorney General's Office (as to form) prior to the implementation of the change or commencement of work affected by the change.
- 25. WAIVER: The failure of either party to insist upon a strict performance of any of the terms or provision of this Contract, or to exercise any option, right, or remedy herein contained, shall not be construed as a waiver or a relinquishment for the future of such term, provision, option, right, or remedy, but the same shall continue in full force and effect. Any waiver must be expressly stated in writing and signed by the waiving party.
- 26. SUBSEQUENT FORMS: The terms and conditions contained in this Contract shall supersede any and all subsequent terms and conditions which may appear on any form documents submitted by Vendor to the Agency or Purchasing Division such as price lists, order forms, invoices, sales agreements, or maintenance agreements, and includes internet websites or other electronic documents. Acceptance or use of Vendor's forms does not constitute acceptance of the terms and conditions contained thereon.
- 27. ASSIGNMENT: Neither this Contract nor any monies due, or to become due hereunder, may be assigned by the Vendor without the express written consent of the Agency, the Purchasing Division, the Attorney General's office (as to form only), and any other government agency or office that may be required to approve such assignments.
- 28. WARRANTY: The Vendor expressly warrants that the goods and/or services covered by this Contract will: (a) conform to the specifications, drawings, samples, or other description furnished or specified by the Agency; (b) be merchantable and fit for the purpose intended; and (c) be free from defect in material and workmanship.
- **29. STATE EMPLOYEES:** State employees are not permitted to utilize this Contract for personal use and the Vendor is prohibited from permitting or facilitating the same.
- 30. PRIVACY, SECURITY, AND CONFIDENTIALITY: The Vendor agrees that it will not disclose to anyone, directly or indirectly, any such personally identifiable information or other confidential information gained from the Agency, unless the individual who is the subject of the information consents to the disclosure in writing or the disclosure is made pursuant to the Agency's policies, procedures, and rules. Vendor further agrees to comply with the Confidentiality Policies and Information Security Accountability Requirements, set forth in http://www.state.wv.us/admin/purchase/privacy/default.html.

31. YOUR SUBMISSION IS A PUBLIC DOCUMENT: Vendor's entire response to the Solicitation and the resulting Contract are public documents. As public documents, they will be disclosed to the public following the bid/proposal opening or award of the contract, as required by the competitive bidding laws of West Virginia Code §§ 5A-3-1 et seq., 5-22-1 et seq., and 5G-1-1 et seq. and the Freedom of Information Act West Virginia Code §§ 29B-1-1 et seq.

DO NOT SUBMIT MATERIAL YOU CONSIDER TO BE CONFIDENTIAL, A TRADE SECRET, OR OTHERWISE NOT SUBJECT TO PUBLIC DISCLOSURE.

Submission of any bid, proposal, or other document to the Purchasing Division constitutes your explicit consent to the subsequent public disclosure of the bid, proposal, or document. Obligations related to political subdivisions may include, but are not limited to, business licensing, business and occupation taxes, inspection compliance, permitting, etc. Upon request, the Vendor must provide all necessary releases to obtain information to enable the Purchasing Division Director or the Agency to verify that the Vendor is licensed and in good standing with the above entities.

Neither the Vendor, nor any employees or subcontractors of the Vendor, shall be deemed to be employees of the State for any purpose whatsoever. Vendor shall be exclusively responsible for payment of employees and contractors for all wages and salaries, taxes, withholding payments, penalties, fees, fringe benefits, professional liability insurance premiums, contributions to insurance and pension, or other deferred compensation plans, including but not limited to, Workers' Compensation and Social Security obligations, licensing fees, etc. and the filing of all necessary documents, forms, and returns pertinent to all of the foregoing.

Vendor shall hold harmless the State, and shall provide the State and Agency with a defense against any and all claims including, but not limited to, the foregoing payments, withholdings, contributions, taxes, Social Security taxes, and employer income tax returns.

- 36. - 41. PREFERENCE FOR USE OF DOMESTIC STEEL PRODUCTS: Except when authorized by the Director of the Purchasing Division pursuant to W. Va. Code § 5A-3-56, no contractor may use or supply steel products for a State Contract Project other than those steel products made in the United States. A contractor who uses steel products in violation of this section may be subject to civil penalties pursuant to W. Va. Code § 5A-3-56. As used in this section:
 - a. "State Contract Project" means any erection or construction of, or any addition to, alteration of or other improvement to any building or structure, including, but not limited to, roads or highways, or the installation of any heating or cooling or ventilating plants or other equipment, or the supply of and materials for such projects, pursuant to a contract with the State of West Virginia for which bids were solicited on or after June 6, 2001.
 - b. "Steel Products" means products rolled, formed, shaped, drawn, extruded, forged, cast, fabricated or otherwise similarly processed, or processed by a combination of two or more or such operations, from steel made by the open heath, basic oxygen, electric furnace, Bessemer or other steel making process.
 - c. The Purchasing Division Director may, in writing, authorize the use of foreign steel products if:
 - 1. The cost for each contract item used does not exceed one tenth of one percent (.1%) of the total contract cost or two thousand five hundred dollars (\$2,500.00), whichever is greater. For the purposes of this section, the cost is the value of the steel product as delivered to the project; or

42. PREFERENCE FOR USE OF DOMESTIC ALUMINUM, GLASS, AND STEEL: In Accordance with W. Va. Code § 5-19-1 et seq., and W. Va. The cost of domestic aluminum, glass, or steel products may be unreasonable if the cost is more than twenty percent (20%) of the bid or offered price for foreign made aluminum, glass, or steel products. If the domestic aluminum, glass or steel products to be supplied or produced in a "substantial labor surplus area", as defined by the United States Department of Labor, the cost of domestic aluminum, glass, or steel products may be unreasonable if the cost is more than thirty percent (30%) of the bid or offered price for foreign made aluminum, glass, or steel products. This preference shall be applied to an item of machinery or equipment, as indicated above, when the item is a single unit of equipment or machinery manufactured primarily of aluminum, glass or steel, is part of a public works contract and has the sole purpose or of being a permanent part of a single public works project. This provision does not apply to equipment or machinery purchased by a spending unit for use by that spending unit and not as part of a single public works project.

All bids and offers including domestic aluminum, glass or steel products that exceed bid or offer prices including foreign aluminum, glass or steel products after application of the preferences provided in this provision may be reduced to a price equal to or lower than the lowest bid or offer price for foreign aluminum, glass or steel products plus the applicable preference. If the reduced bid or offer prices are made in writing and supersede the prior bid or offer prices, all bids or offers, including the reduced bid or offer prices, will be reevaluated in accordance with this rule.

43. INTERESTED PARTY SUPPLEMENTAL DISCLOSURE: W. Va. 3.2 Patch

- 3.2.1 Embroidered Uniform Patches shall be sewn onto specified uniform items by the vendor. Patches will be provided by the Agency throughout the contract to the successful vendor to attach to uniforms 3.2.2.1. Vendor must notify Agency when their patch inventory is below 200 to restock in a timely manner.
 - 3.2.1.1 The patch shall be affixed to the left sleeve, centered one (1) inch down from the shoulder seam.
 - **3.2.1.1.1** Item 4 will require a square Velcro backed patch which shall be placed on the left shoulder of the item.
 - **3.2.1.2** Item numbers requiring patches are: 3, 20, 21, 22, 23, 24, 25, 26, 27, 28, 29.

3.3 Logo

- 3.3.1 The DEP logo shall be silkscreened or digitally printed on the ID panel on items 1, 2, 5, 7.
- 3.3.2 The DEP state logo shall be direct embroidered on the left breast of items 30, 31, 32, 33, 34 and the fleece liner of item 2.
 - **3.3.2.1** Logo shall be approximately 3" X 2 1/2"
- 3.3.4 The DEP state logo shall be direct embroidered on all hats and caps. (Items 35, 36, 37, 38, 39)
 - **3.3.4.1** Logo shall be approximately 3 1/2" X 2 1/4"
- **3.3.5** WV DEP shall provide to the successful vendor the necessary logo artwork samples and/or files.

3.4 Alterations

- **3.4.1** Standard alterations shall be done by the vendor at no additional charge.
- **3.4.2** Standard alterations shall include sleeve length and pant length.

3.5 Samples

- 3.5.1 All vendors submitting bids for brands and/or styles other than those specified shall provide a sample of each "or equal" item to the WV Purchasing Division along with written specifications for the "or equal" item at no cost.
 - **3.5.1.1** All samples must be the color requested in the specifications.
 - **3.5.1.2** Examples of "or equal" items MUST be provided prior to award of contract but it is preferred that it be provided with the bid.
 - **3.5.1.3.1** Samples will be reviewed and approved prior to award by DEP.
 - **3.5.1.3** Any deviations from the mandatory specifications must be submitted as a question by the question deadline in order to be considered. Responses to vendor questions shall be published as an addendum on Oasis Vendor Self Service.

3.6 ORDERING AND PAYMENT:

- 3.6.1 Ordering: Vendor shall accept orders through wvOASIS, regular mail, facsimile, e-mail, or any other written form of communication. Vendor is required to accept on-line orders through a secure internet ordering portal/website. Website must include a detailed graphic of each item along with written description. Vendor shall include a brief description of how Agency may utilize the on-line ordering system. It is preferred by the agency that the description is included with the bid, but may be requested prior to award. Vendor shall ensure that its on-line ordering system is properly secured prior to processing Agency orders on-line.
- **3.6.1** Portal shall be operational and able to process orders for various DEP locations using the approval process requested within 60 days of contract award. If not, the Agency reserves the right to cancel the contract.
- **3.6.2** Agency and vendor shall have a kickoff meeting within 14 days of contract award. Then, a meeting will be held each week after until portal is operational. Meetings shall be online.

- **3.6.3** Online ordering system shall have an administrative dashboard or log-in that allows Agency administrators to review, reject, track orders as well as run reports of item usage.
- **3.6.4** The Agency will check to ensure that the reporting function meets the requirements listed in 8.3. The Agency will not award the contract to any vendor that can't meet the reporting requirements.
 - **3.6.5** Portal must have the ability for different levels of approval within DEP.
 - **3.6.5.1** DEP has several different divisions. Each division must have the ability to view and approve the orders placed by employees in that division.
 - **3.6.5.2** Not all employees shall have the ability to approve orders or fully place an order. Some employees shall enter an order and submit it. The system should then route the order toa designated approver.
 - **3.6.5.3** DEP shall have the ability to administer user and approver accounts.
 - **3.6.5.3.1** DEP contract administrators shall give the awarded vendor a list of employee names, divisions, locations, and designated approvers.
 - **3.6.6** The Agency has several locations throughout the state of WV. Ordering system must have those locations entered for employees to use for shipping and billing. Employees must not be able to enter or ship to any address other than the approved locations. See Exhibit A.
 - **3.6.7** All items listed on the website shall be contract items including contract price and color. No additional items shall be shown on the portal. All contract sizes shall be listed on the portal for ordering.
 - 3.6.8 Item names, numbers and descriptions should match the contract.
 - **3.6.9** If the on-line ordering system is down or malfunctioning, vendor must accept orders via mail, email or by phone.
- **3.7 Payment:** Vendor shall accept payment in accordance with the payment procedures of the State of West Virginia.
 - **3.7.1** Invoices must reference online order number, delivery office address, employee name and Agency Delivery Order (ADO) on the invoice. Failure to reference the information could cause delay in payments.
 - 3.7.2 Invoices must be sent to the Agency within 30 days of shipping.
 - **3.7.3** Invoices shall be sent to order approver.
 - 3.7.4 Vendor cannot charge the Agency prior to shipping the item.
 - **3.7.5** Orders must be invoiced and not require payment at the time of the order submittal.
 - **3.7.6** Vendor must accept online payments.

- 3.8 Reports: Vendor shall provide electronic on demand reporting and annual summaries through the online portal to the Agency showing the Agency's items purchased, quantities of items purchased, and total dollar value of the items purchased. Vendor shall also provide reports showing the items purchased during the term of this Contract, the quantity purchased for each of those items, and the total value of purchases for each of those items. Failure to supply such reports may be grounds for cancellation of this Contract. Reports showing order status, including backordered items, shall be available to be run on demand showing the item status on each order.
 - **3.8.1** Reports shall be exportable to Excel and Google Sheets or similar.
 - **3.8.2** Reports shall be available by DEP division, location, employee, authorized approver, order status, item, cost. Additional categories or filters are allowed.
 - 3.8.3 Examples of the Vendor's reports will be requested prior to the award of the contract to determine if the reporting fulfills the Agency requirements. The Agency will not award the contract to any vendor that can't meet the reporting requirements. See Exhibit B for reference. Exhibit B is just an example of the reports and does not have to be exactly replicated.

4 CONTRACT AWARD:

- **4.1 Contract Award:** The Contract is intended to provide Agency with a purchase price on all Contract Items. The Contract shall be awarded to the Vendor that provides the Contract Items meeting the required specifications for the lowest overall total cost as shown on the Pricing Pages.
- 4.2 Pricing Pages: Vendor shall complete the commodity lines in Oasis in lieu of a Pricing Page by submitting a price for each of the line items in wvOASIS. . Vendor shall complete the commodity lines in their entirety as failure to do so may result in Vendor's bids being disqualified. Vendors must bid on every item to be considered for award. If an item is not available, please submit a formal question or replacement via email to the Purchasing Division buyer listed on the solicitation.

The commodity lines in Oasis contain a list of the Contract Items and estimated purchase volume. The estimated purchase volume for each item represents the approximate volume of anticipated purchases only. No future use of the Contract or any individual item is guaranteed or implied.

Vendor shall electronically enter the information into the commodity lines via wvOASIS, if available, or as an electronic document. Vendors can download the electronic copy of the list of contract items from the wvOASIS Vendor Self-Service website. If responding with a paper bid, Vendors should download and/or print the assembled CRFQ document (with the highest version number) from wvOASIS and

insert their unit price and extended cost for each line item. Should there be a conflict with bid total, unit price shall prevail.

5 CONTRACT RENEWAL:

- **Renewal:** This Contract may be renewed upon the mutual written consent of the Agency, and the Vendor, with approval of the Purchasing Division and the Attorney General's Office (Attorney General approval is as to form only).
- **Renewal Price Adjustments:** A price adjustments may occur one time, with the contract's renewal, and only if all parties.
 - 5.1.1 All Contract Items will be adjusted proportionally, upwards, or downwards, based on the percentage change from contract award to the most recent index rate available at the time of renewal submission on the Producer Price Index by Commodity; Textile Products and Apparel index at https://fred.stlouisfed.org/series/WPU03. If for any reason the index is no longer available at the time of the renewal, an equivalent textile index will be used.

EXAMPLE OF ADJUSTMENT:

- The January 2021 index rate was 151.300
- The January 2022 index rate was 174.218
- Contract Item 1 bid price was \$5.00/each (example only)

A 15.15% change in the Textile Products and Apparel index occurred between January 2021 and January 2022. Contract Item 1 will be adjusted proportionally to match the percentage change in the index — therefore would be increased by 15.15%. The contract price for this Contract Item during the renewal period would be adjusted from \$5.00 to \$5.76 for the remainder of the contract. The same calculation would be performed for all Contract Items proportionally.

- **5.1.2** The Price adjustments and renewal will be granted or denied at the sole and absolute discretion of the State.
- **5.1.3** Price adjustments shall be memorialized by a written Change Order which much be reviewed and approved by the Agency to be effective. Adjusted pricing will not take effect until the effective date of such Change Order and cannot be retroactive.
- 6 ORDERING AND PAYMENT: Please see Section 3.6 & 3.7 of the mandatory requirements for ordering and payment specifications.

7 DELIVERY & RETURN:

- 7.1 **Delivery Time:** Vendor shall deliver standard orders within <u>20</u> working days after orders are received. Vendor shall deliver emergency orders within <u>10</u> working day(s) after orders are received.
- 7.2 Vendor shall ship all orders in accordance with the above schedule and shall not hold orders until a minimum delivery quantity is met. Vendor shall partially ship items and not hold for a full delivery of an order if there are items delayed.
- 7.3 Items must be shipped to the DEP office listed on order.
 - **7.3.1** DEP has office locations around the state of WV that will receive shipments. Vendor must pay attention to the delivery address on order and is responsible for shipping to correct location.
 - **7.3.2** Shipments must have the order number and/or the employee's name included in the package. There must be an identifier on the shipment to match it to the order.
- 7.4 Late Delivery: The Agency placing the order under this Contract must be notified in writing if orders will be delayed for any reason. Any delay in delivery that could cause harm to an Agency will be grounds for cancellation of the delayed order, and/or obtaining the items ordered from a third party.
 - Any Agency seeking to obtain items from a third party under this provision must first obtain approval from the Purchasing Division.
- 7.5 Delivery Payment/Risk of Loss: Standard order delivery shall be F.O.B. destination to the Agency's location. Vendor shall include the cost of standard order delivery charges in its bid pricing/discount and is not permitted to charge the Agency separately for such delivery. The Agency will pay delivery charges on all emergency orders if Vendor invoices those delivery costs as a separate charge with the original freight bill attached to the invoice.
- 7.6 Return of Unacceptable Items: If the Agency deems the Contract Items to be unacceptable, the Contract Items shall be returned to Vendor at Vendor's expense and with no restocking charge. Vendor shall either make arrangements for the return within five (5) days of being notified that items are unacceptable or permit the Agency to arrange for the return and reimburse Agency for delivery expenses. If the original packaging cannot be utilized for the return, Vendor will supply the Agency with appropriate return packaging upon request. All returns of unacceptable items shall be F.O.B. the Agency's location. Vendor may also choose for Agency to not send the item back, but still process the refund. The returned product shall either be replaced, or the Agency shall receive a full refund for the purchase price, at the Agency's discretion.

- 7.7 Return Due to Agency Error: Items ordered in error by the Agency will be returned for credit within 30 days of receipt, F.O.B. Vendor's location. Vendor shall not charge a restocking fee if returned products are in a resalable condition. Items shall be deemed to be in a resalable condition if they are unused and in the original packaging. Any restocking fee for items not in a resalable condition shall be the lower of the Vendor's customary restocking fee or 5% of the total invoiced value of the returned item(s).
- 8. REPORTS: Please see Section 3.8 of the mandatory requirements for reporting requirements.

9. VENDOR DEFAULT:

- 9.1 The following shall be considered a vendor default under this Contract.
 - **9.1.1** Failure to provide Contract Items in accordance with the requirements contained herein.
 - **9.1.2** Failure to comply with other specifications and requirements contained herein.
 - **9.1.3** Failure to comply with any laws, rules, and ordinances applicable to the Contract Services provided under this Contract.
 - **9.1.4** Failure to remedy deficient performance upon request.

DEP Uniforms

- 9.2 The following remedies shall be available to Agency upon default.
 - **9.2.1** Immediate cancellation of the Contract.
 - **9.2.2** Immediate cancellation of one or more release orders issued under this Contract.
 - **9.2.3** Any other remedies available in law or equity.

10. MISCELLANEOUS:

- **10.1 Substitutions:** Vendor shall supply only Contract Items submitted in response to the Solicitation unless a contract modification is approved in accordance with the provisions contained in this Contract.
 - 10.1.1 If a contract item becomes discontinued during the life of the contract, vendor must submit an equal substitution of the same price and specifications as originally awarded contract item.
 - 10.1.2 Vendor shall notify Agency of discontinued item immediately, but at most, within 7 days that vendor is aware of issue with item along with substitution options.
 - 10.1.3 Vendor shall send written notice along from the manufacturer of discontinuation along with substitution option specifications to DEPProcurement@wv.gov.
 - 10.1.4 Vendor may be requested to mail a sample substitution at no cost to the Agency.
 - 10.1.5 Vendor shall not offer substitutions to general employees and staff via phone or email. Substitutions must be processed via formal change order to the contract, approved by contract administrators and the Purchasing Division.
- **10.2 Vendor Supply:** Vendor must carry sufficient inventory of the Contract Items being offered to fulfill its obligations under this Contract. By signing its bid, Vendor certifies that it can supply the Contract Items contained in its bid response.
- 10.3 Contract Manager: During its performance of this Contract, Vendor must designate and maintain a primary contract manager responsible for overseeing Vendor's responsibilities under this Contract. The Contract manager must be available during normal business hours to address any customer service or other issues related to this Contract. Vendor should list its Contract manager and his or her contact information below. Should the contract manager listed here change over the life of the contract, vendor must notify Agency within 5 business days.
