West Virginia Schools for the Deaf and the Blind is replacing the old non IFR stage curtains with IFR curtains. During the installation, it was noted that two of the pieces that we initially thought were able to stay, would also have to be replaced. It was also noted that one piece we thought was needed was not. The price of the pieces needed is \$9,688, the price of the piece we did not need was \$3,327. That leave a net difference of \$6,361. We feel this price is reasonable based on the work needed to replace the needed pieces.
