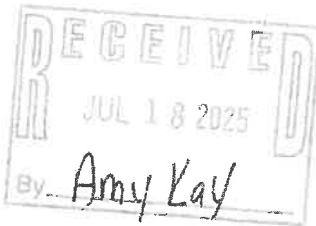

4. Renewals for contracts over \$100,000 must be approved.
