## MEMO

**RE: CCT 1500 ADO23\*1**

This correspondence is intended to clarify the dates associated with our original contract document CCT 1500 ADO23\*1 created on or about 5/1/22. The document was created originally to accommodate the acquisition of EProsucuter which was replacing the sunseting software, Justware, by Journal Technologies, Inc. (JTI). Further, the intent is for both parties to agree on the modifications contained herein so that payment can be made to JTI for historical services. Due to varying issues, the timing for go live was delayed by approximately six months and original contractual dates were altered.

Pursuant to that end, we desire to modify the time frame on commodity line 4 to 1/1/24-12/31/24, this twelve-month period will be paid at \$3,300 per month totaling \$39,600.00 for test hosting.

Next, we would like to modify the time frame for commodity line 3 to 4/9/24-4/8/25 payable in the amount of \$90,000.00, which represents the pre-go-live period identified in the contract.
