THIRD AMENDMENT TO AGREEMENT 06/01/2026

This Third Amendment (this "Amendment") is entered into and effective as of ~~June 01, 2026~~ (the "Amendment Effective Date") between EAN Services, LLC ("Contractor") and The State of West Virginia ("Participating Entity").

WHEREAS, the parties have entered into that certain Participating Addendum, Contract Number: CMA 0212 CRENTAL25B, dated as of September 15, 2025, as amended by Amendment 1 dated July 1, 2025, Amendment 2 dated January 1, 2026, and an Extension Letter dated April 13, 2026 (collectively, the "Agreement"); and

WHEREAS, the parties desire to amend the Agreement as set forth herein.

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Amendments.

a. Amend section titled "n. Vehicle License Fee" by deleting it in its entirety and replacing with the following:

"n. Vehicle License Fee. Vehicle License Fee (VLF). Contractor may change the fee amount at any time during the term of the contract. For any changes to the VLF fee within the State of West Virginia, the Contractor must submit a change order to the contract. The VLF fee in the State of West Virginia at the Initiation of this Amendment is \$2.45."

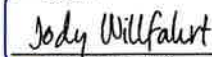
2. Miscellaneous. The terms and conditions of the Agreement, except as duly modified by this and any previous amendments, remain in full force and effect, provided that to the extent that there is any conflict between the terms of the Agreement and the terms of this Amendment, the terms of this Amendment shall govern and control. Capitalized terms used and not defined in this Amendment have the respective meanings assigned to them in the Agreement. This Amendment may be executed in counterparts (including exchange by facsimile or attached as a PDF, or other electronic file type or by DocuSign, Adobe Sign, or other electronic signature), each of which is deemed an original, but all of which constitute one and the same agreement.
