# Vehicles Now Available at Surplus Property Through Federal Fixed Price Program

The West Virginia State Agency for Surplus Property (WVSASP) is now participating in the U.S. General Services Administration's Fixed Price Program, which has allowed WVSASP to obtain federal vehicles, including those used for law enforcement. The vehicles are made available exclusively to eligible organizations for a low price.

"This is an important opportunity for our cities and counties in West Virginia to procure a vehicle at an affordable rate," said WVSASP Manager Elizabeth Cooper. "The federal Fixed Price Program has allowed WVSASP to acquire and offer these vehicles at a considerable savings. The program is already a success and has attracted a lot of interest."

## New Purchasing Procedure Aids Agencies in Obtaining Lowest Price Available

In last year's legislative session, the Purchasing Division was authorized to make some parts of the procurement process more flexible. In an effort to do just that, the Purchasing Division has added a new purchase option to its *Procedures Handbook* to help ensure agencies obtain the lowest price possible for a commodity or service.

Subsection 5.3.1.7 provides for a direct buy if bids received are higher than the publicly posted price of a non-bidding entity.

The new procedure states:

"A spending unit may reject all bids and cancel a solicitation and then purchase a commodity or service directly from a non-bidding entity if: all bids received are priced higher than the publicly posted price of the non-bidding entity. A public posting may include an internet screen print, news media advertisement, or publicly available catalog.

## Purchasing Division Shares Agency Resource Center Redesign, Names 2022 Procurement Officer of the Year, and Introduces New Logo

Wow, what a productive and constructive conference we had last month! After a three-year hiatus from an in-person conference, we were able to offer a hybrid approach this year, with inperson workshops for those who wished to attend in person, and a virtual option for those whose schedules or circumstances did not allow them to. During the three-day conference, we announced our 2022 *Procurement Officer of the Year* (see below), gave you the chance to add to our Idea Board (a concept we incorporated into our internal operations as a result of our work with Toyota), and introduced our new logo. We also found out what is working within your agencies and what the Purchasing Division can do better to improve efficiency. Working with Toyota during the past year has brought about many improvements, and looking forward, we're excited to see what the future has in store.

One of our focuses during the last several months has been to hone our communication efforts and make our website easier to navigate for our procurement officers. At the conference, we shared a version of our revamped Agency Resource Center. The prototype of the webpage was updated to include links to the most important information an agency buyer might use in his or her daily operations, categorized to make it much easier to find exactly what is needed on our website. We are reviewing the feedback received and plan to have the updated website online in the next few weeks.

As we look to improve our own processes, our Surplus Property Unit is making strides of its own. Recently they began utilizing the federal Fixed Price Program to purchase vehicles. This

program allows the agency to purchase federal vehicles and resell them for a fraction of what they would cost brand new. In light of the vehicle shortage that has affected agencies and local governments, this program has provided the state with an alternate means of obtaining vehicles, saving thousands of dollars. If you're in need of a vehicle and Surplus Property doesn't have what you need, call them and find out if any federal vehicles might be



available, or let them know what you're looking for so they can keep you in mind as vehicles come in. More information on this program can be found on Page 1.

# **Quick Procurement of Certain Commodities Saves Money**

The Purchasing Division often hears from its agency partners about the challenges related to the time constraints involving central purchases. For the past year, the Division has been working with the Toyota Production System Support Center (TSSC), a nonprofit corporation affiliated with Toyota Motor North America. The TSSC supports organizations committed to improvement by sharing with them concepts of the Toyota Production System in ways tailored to their specific business needs. One of the process improvements as a result of those meetings is the implementation of a fast track procurement process for goods that are frequently purchased and whose vendor pool remains fairly constant in the industry. Those vendors are also familiar with state purchasing procedures. Solicitations for some items, such as steel and concrete for the Division of Highways (DOH), have been processed in as little as 14 days.

The simplified process eliminates pre-bid meetings and reduces a solicitation's advertising time from 10 days to five. With the recent price fluctuations in a volatile market, it has helped the DOH acquire commodities at a vendor's original stated price.

"Many vendors haven't been able to hold their prices during the time it usually takes to award a contract, but when we can award quickly, the price holds



and it saves the agency money," said Buyer Supervisor Tara Lyle. "The faster process works for commodities and services with good specifications, so the vendors don't have many questions."

Any agency procurement officer who has an idea for a commodity or service that could be successfully fast-tracked should send the suggestion to their assigned Purchasing Division buyer.

The direct purchase from the nonbidding entity must be made at the publicly posted price, or less, and must be of equal quality to the bid specifications."

The updated *Purchasing Procedures Handbook* can be found at www.state.wv.us/admin/purchase/Handbook.

"This new method is basically an opt-out provision that allows an agency to cancel a solicitation and buy at a lower public price if it exists," said Purchasing Division General Counsel Jimmy Meadows. "The only way this works, though, is if the price the agency compares bids to is public. Without the price being public, you could get into a situation where a known bidder chooses to forgo bidding in favor of waiting to see what prices are bid and then undercutting all the other bidders. The state cannot allow that type of unfair competition, so the price must be publicly available."

Examples of publicly available prices include traditional print and internet advertisements, catalogues, screen prints of vendor websites, MSRP publications, etc. A vendor's quote would not be considered publicly available.

#### **Purchasing Recognizes Latest Certification Recipient**

The Purchasing Division is pleased to announce Jodi Hash as the latest recipient in its West Virginia Procurement: Basic Certification program.

Hash, a senior procurement specialist with the West Virginia Lottery, has worked for the state for approximately 10 years.

# **Agencies Reminded of Vendor By Commodity Report**

Agencies are reminded of the Vendor by Commodity Report within wvOASIS's Business Intelligence, which has become a valuable tool for procurement officers at the delegated and central levels.

This option in wvOASIS allows users to search for vendors that provide certain goods or services by using a commodity code. Identifying vendors as part of the requisition process ensures vendors are made aware of solicitations published by the state of West Virginia for the goods or services they offer.

To run the Vendors by Commodity Report, open WV-FIN-VN-010 within Business Intelligence in wvOASIS and click "Refresh All." Upon entering the report's single input, the first four digits of a selected commodity code, a report will iden-

tify all vendors from the VCUST table in wvOASIS who have indicated they can provide the commodity based on that code or one with a similar code family to what the agency is seeking.

of one vehicle obtained through the Fixed Price Program was estimated to be \$21,000. WVSASP was able to offer this vehicle for only \$13,000.

In July, WVSASP supplied three police cars to the city of Dunbar. The next month, the city of Wheeling also obtained three SUVs. WVSASP has plans to continue requesting federal vehicles and fulfilling the needs of the state.

Priority for federally-obtained vehicles is given to tax-supported eligible organizations. Specifically, vehicles with police packages are made available to local police departments and sheriff's offices.

#### Sheets Honored as 2022 Procurement Officer of the Year at Annual Conference

The Purchasing Division has named Morgan Sheets as the 2022 *Procurement Officer of the Year*. Sheets is an administrative services manager for the West Virginia Veterans Home in Barboursville. He has worked in state procurement since November 2017, first with the Department of Health and Human Resources' Bureau for Medical Services. In August 2020, Sheets accepted a position at the Veterans Home as the fiscal supervisor, which was recently reclassified to an Administrative Services Manager I position.

"Morgan's job performance has been excellent during his time with the state," said the co-worker who nominated him. "He strives to produce quality work products for his agency. He is well-versed in purchasing and *wv*OASIS terminology, and this helps him to communicate effectively about his work with internal and external parties."

Sheets work helps lower the cost of contracted health care services for residents of the Veterans Home.

"I would not be in state government if not for Jimmy Dowden at DHHR/BMS," said Sheets. "He facilitated my training and also steered me to join the National Institute of Governmental Purchasing (NIGP). NIGP monthly meetings have great training sessions, and more importantly, the wealth of procurement knowledge in the room and having access to that is very beneficial. Thirdly, since I left DHHR and went to the Department of Veterans Assistance, I have reached out numerous times to many people in the Purchasing Division for guidance and assistance.

"Lastly, without my team at the West Virginia Veterans Home, this would not have been possible. This was truly a TEAM award. I would also like to mention my boss, Mike Lyons, who gave me carte blanche to fix what was wrong here; he is a great leader and I am proud to work for him. I would also be remiss to not mention my wife, who has put up with my crap for years and also let me borrow her car to get to the conference."

Sheets earned his Basic Certification from the West Virginia Purchasing Division and has attended several of the Division's training sessions and conferences. He also served as a panelist at the 2019 Agency Purchasing Conference.
