CHANDELIER, SCONCE, CANDELABRUM RESTORATION PROJECT

The State of West Virginia, Department of Administration, General Services Division is seeking a qualified vendor for the restoration of ten (10) crystal chandeliers and twenty-five (25) crystal wall sconces, five (5) brass chandeliers, and four (4) candelabra. The location of these items is in the West Virginia State Capitol Building and the Governor's Mansion, both of which are located at 1900 Kanawha Blvd. E., Charleston, West Virginia.

These fixtures are part of the history of our State and extreme care must be used in the restoration, removal and the final reinstallation of the fixtures. These items are the original light fixtures in both the Governor's Mansion as well as the State Capitol Building. These chandeliers and wall sconces must be restored using only UL approved items along with brass items and/or crystal pieces that are of the same style and design to match the original pieces.

The successful vendor shall submit a project list that describes at least three (3) similar restoration projects that include restoration of crystal chandeliers, brass and/or crystal wall sconces as well as brass chandeliers. These must include the project name, and contact information on these projects. Failure to submit the project list with the bid shall cause disqualification of the bid. The successful vendor shall have at least five years experience in the restoration field, and submit evidence of this experience with the bid. Failure to submit evidence of the experience requirement with the bid shall cause disqualification of the bid.

The work is required to meet standards established in the Code of Ethics of the American Institute for Conservation of Historic and Artistic Works, as well as meet the Guidelines for Practice of the American Institute for Conservation of Historic and Artistic Works.

Vendor is to supply any and all temporary light fixtures as required by the General Services Division for both the Governor's Mansion and the Governor's Reception Room. These replacements must be of proper style and character to maintain the dignity of the buildings that represent the people of West Virginia. All temporary items shall be approved by the General Services Division prior to installation.

The General Services Division will prioritize the order in which the vendor will restore the fixtures. The General Services Division will determine the number of fixtures which may be removed from the Capitol Complex at a particular time. All original items replaced during any restoration must be returned to the General Services Division, exclusive of electrical wiring.

The following tentative format will be followed by the Purchasing Division and the General Services Division for GSD066428:

All prospective bidders must attend a mandatory pre-bid conference on Thursday, June 8, 2006, at 6:30 a.m. in the cafeteria of the Main Capitol Building, General Services Division. Failure to attend this prebid conference shall cause disqualification of the bid. All vendors who plan to attend this prebid conference should notify Purchasing Division Buyer Supervisor Ron Price via email no later than June 6, 2006. Contact information may be found below.

The mandatory pre-bid meeting will consist of initial registration; a walk-through of the project areas (during which prospective bidders will be allowed and encouraged to ask questions, and make comments or suggestions regarding the project); and, a final close out meeting. Depending on the amount of time needed for the walk through, a working lunch may be necessary.

Vendors may record by still camera, video camera, drawings, field notes, etc. Vendor may examine each item and may ask questions that relate to the chandeliers and wall sconces. At no time can any of the materials gathered during any section of the walk-through be used without the permission of the State of West Virginia, Department of Administration, General Services Division.

After completion of the prebid conference, the General Services Division will make final determination of the restoration and repair needed for each item. An Addendum detailing these specific requirements will be submitted to all vendors attending the prebid conference.

A F F I D A V I T

West Virginia Code §5A-3-10a states:

No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owned is an amount greater than one thousand dollars in the aggregate.

DEFINITIONS:

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Debtor" means any individual, corporation, partnership, association, limited liability company or any other form or business association owing a debt to the state or any of its political subdivisions.

"Political subdivision" means any county commission; municipality; county board of education; any instrumentality established by a county or municipality; any separate corporation or instrumentality established by one or more counties or municipalities, as permitted by law; or any public body charged by law with the performance of a government function or whose jurisdiction is coextensive with one or more counties or municipalities.

"Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceeds five percent of the total contract amount.

EXCEPTION:

The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

LICENSING:


The vendor must be licensed in accordance with any and all state requirements to do business with the state of West Virginia.

CONFIDENTIALITY:

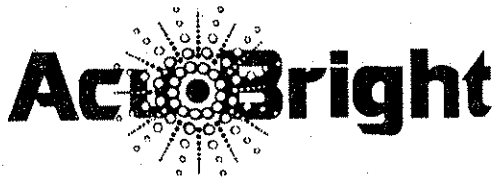


