#### SCOPE OF CONTRACT

The purpose of this Contract shall be to supply compact, portable sign stands and highly reflective roll-up signs, as required, to various West Virginia Division of Highways (WVDOH) personnel.

#### **COMPACT PORTABLE SIGN STANDS - SPECIFICATIONS**

All stands bid shall be approved in accordance with the requirements of the National Cooperative Highway Research Program (NCHRP) Report 350 when utilized as described herein.

Compact, portable sign stands shall be capable of holding 36" and 48" roll-up signs a minimum of 12" off the ground. It shall have 4 (four) legs capable of telescoping in or out to utilize both 36" and 48" diamond shaped signs. Each leg, when telescoped out, shall positively lock into the extended position by way of a stainless steel "push" button type mechanism. Each leg shall have three (3) positive locking positions; vertical for storage, and two additional horizontal positions for adjustment on uneven terrain. Legs shall be manufactured for long life utilizing aluminum.

The frame, spring(s), and mast of the stand shall be fabricated of steel, or other approved material, and have the ability to flex if necessary, allowing the complete assembly to have additional wind spilling capability beyond that which is provided by the sign ribs. These components shall be stainless, electro-deposit zinc coated, hot-dip galvanized, powder coated steel, or other approved long life material.

The stand mast shall hold the sign in position by clamping onto the vertical rib of the sign. The clamping device shall accommodate all of the vertical rib sizes detailed as part of this Contract. The clamping device shall be designed such that the sign may be inserted into position using two hands with the clamping device open, and be quickly tightened into place thereafter. Both cam type and screw-in type will be considered, in addition to other similar acceptable designs. Screw-in type mechanisms shall include a tightening knob that may be easily operated in a fast manner, without requiring an excessive number of rotations to tighten.

The stand shall not be excessively heavy, bulky, or cumbersome, as determined by the office and field staff involved in the evaluation of stands submitted for consideration.

The overall "footprint" of the stand with the legs in the retracted and extended positions shall not be excessive, as determined by the office and field staff involved in the evaluation of stands submitted for consideration. The side-to-side dimension of the footprint is critical due to shoulder width considerations, and generally should be limited to 36" in the retracted position, and 60" in the extended position.

The end of each stand leg shall be equipped with a permanently affixed tip manufactured of rubber, or other similar approved material, to deter the stand from "walking".

When using a 36" diamond roll-up sign in the retracted leg position, or when using a 48" diamond roll-up sign in the extended leg position, the stand shall remain upright and shall not require any additional ballasting in wind gusts created by 55 MPH and 70 MPH speed limit traffic, respectively. The stand shall be significantly stiff to prevent excessive swaying and twisting of the sign.

All stands shall include a resting or stop point on the mast for the bottom of the vertical mast at which point the bottom of the sign will be at a 12" (min) mounting height above the surface that the stand is resting on.

The successful vendor shall provide a four (4) year warranty against defects in workmanship, parts, and materials on all stands supplied as part of this Contract.

All potential stands to be bid as part of this Contract shall be submitted prior to advertisement for reviews to be performed by Traffic Engineering central office staff and select maintenance personnel. Stands that are reviewed and determined to meet the requirements specified above shall be listed within this Contract below, and will be the only stands considered for award as part of bids submitted for this Contract.

### COMPACT PORTABLE SIGN STANDS – APPROVED PRODUCTS

Based on the results of reviews conducted by Traffic Engineering central office staff, and select maintenance personnel, the following manufacturer / model stands have been approved for bidding on this Contract. Bids on the stand portion of this Contract must specify one of the following models as the stand to be supplied to be considered for award:

- Dicke Tool Uniflex 2000 Sign Stand Model UF2000 with aluminum legs, single steel spring, and screw-in universal sign attachment bracket.
- MDI Economy WindMaster Sign Stand Model 4814SSCKHDK with aluminum legs, single steel spring, and CamLock cam-type universal sign attachment bracket.
- Eastern Metal-USA Sign Model C-902-DDQA with aluminum legs
- Korman Signs Model SS548UCA with alum legs, universal latching mechanism with large grip handle, and foot release kick plates.

All stands bid shall be approved in accordance with the requirements of the National Cooperative Highway Research Program (NCHRP) Report 350 when utilized as described herein.

Aluminum substrate sign and large roll-up sign portable sign stands shall be capable of holding 0.080 aluminum 48" diamond signs, 48" octagon signs, 48" triangle signs, 36x60 vertical rectangle signs, 60x30 horizontal rectangle signs, and smaller signs, as well as roll-up signs as large as 60x60 square. The stand shall be designed such that the sign mounting height will be 12-24 in off of the ground. Stands designed for higher mounting heights (i.e. 5' or 7') shall not be allowed. The stand shall have 4 (four) legs. Each leg shall have three (3) positive locking positions; vertical for storage, and two additional horizontal positions for adjustment on uneven terrain. Legs shall be manufactured for long life utilizing either aluminum or galvanized steel.

The frame, spring(s), and mast of the stand shall be fabricated of steel, or other approved material, and have the ability to flex if necessary, allowing the stand to provide all wind spilling capability for aluminum signs, and additional wind spilling capability beyond that which is provided by the sign ribs for roll-up signs. These components shall be stainless, electro-deposit zinc coated, hot-dip galvanized, powder coated steel, or other approved long life material.

The stand provided shall include all components necessary for installing all of the signs referenced above, including an adjustable mast, all adjustable aluminum sign brackets, and an adjustable roll-up sign bracket. The roll-up sign bracket shall accommodate all of the horizontal rib sizes detailed as part of this Contract.

The stand shall not be excessively heavy, bulky, or cumbersome.

The overall "footprint" of the stand shall not be excessive. The side-to-side dimension of the footprint is critical due to shoulder width considerations, and generally should be limited to 48". The end-to-end dimension of the footprint should generally be limited to 96".

The successful vendor shall provide a four (4) year warranty against defects in workmanship, parts, and materials on all stands supplied as part of this Contract.

Stands that are reviewed and determined to meet the requirements specified above shall be listed within this Contract below, and will be the only stands considered for award as part of bids submitted for this Contract.

#### <u>ALUMINUM SUBSTRATE SIGN AND LARGE ROLL-UP SIGN PORTABLE</u> SIGN STANDS – APPROVED PRODUCTS

Due to the restricted time frame available for evaluation of stands of this type, only literature provided by potential manufacturers of this type stand was reviewed. Additionally, consideration was limited to manufacturers whose Compact Portable Sign Stands were approved for bidding, as noted above. Bids on the stand portion of this Contract must specify one of the following models as the stand to be supplied to be considered for award:

- Eastern Metal-USA Sign Model X553DD
- Korman Signs Model SS548E

#### SIGN FABRICATION STANDARDS

Note, in regards to all references below to the "WVDOH Sign Fabrication Details", these references shall be interpreted as referring to the manual "West Virginia Division of Highways, Sign Fabrication Details, Traffic Engineering Division, September 2005", and all subsequent supplements.

#### **ROLL-UP SIGN SHEETING**

All signs and plaques supplied as part of this Contract shall be manufactured using 3M RS20 (white) and RS24 (fl-orange) sheeting, as applicable, with manufacturer approved inks. The sheeting shall be warranted by the 3M Company for its' intended use and shall meet the minimum warranted retroreflective values stated by 3M, subject to the provisions stated on the 3M Product Bulletin.

#### **ROLL-UP SHEETING SPLICES**

In cases where the splicing of roll-up sign material fabric is required as noted below, the splice shall be accomplished by the following method:

- The seam shall be continuously "bridged" on the back side of the sign by a 4" (min) wide strip of 18oz Cooley fabric coated with 200mp adhesive.
- The seam shall be stitched on both the front and back faces of the sign.
- The seam shall be bar tacked on both the front and back faces of the sign on each end of the seam.

#### GENERAL SIGN FABRICATION SPECIFICATIONS

All signs supplied shall have one or more permanently affixed vertical fiberglass ribs, with at least one along the vertical centerline of the sign. The vertical ribs of all signs shall be attached to the sign face with a minimum of two metal fasteners, one each at the top and bottom. These fasteners shall include a plastic or nylon washer between the fastener and both faces of the sign. The vertical rib fastener bolts shall not be excessively long, and may protrude only slightly past the end of the bolt nut.

All horizontal or diagonal ribs shall be designed to pivot about a metallic pivot point located along the vertical rib. The ends of the metallic pivot shall be smooth without any exposed sharp edges. The ends of the horizontal/diagonal ribs on all signs shall slide into a solid, non-sliding, polycarbonate (or other similar approved material) corner pocket mounted at the edge of the sign. The corner pockets shall fasten to the sign face using two or more fasteners each. The corner pockets shall be designed for the size ribs supplied, without requiring modification to the ribs, and shall be in general conformance with the attached sample detail drawings.

When specified (see bid item listing), two 18" x 18" non-reflective fluorescent orange vinyl flags shall be permanently attached to the top of the vertical rib that is along the vertical centerline of the sign. The system for deploying the flags shall be a good quality, long lasting, reliable system. All metal parts of the system shall be stainless, electrodeposit zinc coated, hot-dip galvanized, or powder coated steel. Flag staffs should be fiberglass, similar to the sign ribs, and have a minimum section modulus equal to that of a 1/8" thick x 1" wide rib (0.002604 in ^ 3). The staffs shall be sufficiently long enough to hold the flags completely above the sign face. No hand tightening of any components shall be required to hold the flags in the deployed position. When deployed, the two flags shall extend symmetrically (about the vertical centerline) up and out from their mounting point along the vertical rib, with the flags held in position completely above the sign face, and with each staff at an angle of 30 to 60 degrees from the vertical centerline of the sign. Staff mounting and deployment systems shall be subject to review and approval.

For particular signs (see bid item listing) and all overlay plaques requiring velcro strips to be attached for temporary overlay attachment, the hook ("coarse") side of the velcro shall be attached to the sign faces. The loop ("fuzzy") side of the velcro shall be attached to the back face of the overlays.

All signs must present a finished, professional look to the motorist with no sagging of the sign material. Signs shall include anti-kite velcro loops attached to the back faces of the signs and to be connected around the ribs of the signs (quantity and general position of loops shall be noted herein). An additional length of velcro shall be fastened near the vertical center of one of the horizontal end points on each sign, and shall be oriented such that when the sign is rolled up on the vertical rib the velcro will encircle the sign and hold it in the rolled up storing position.

All roll-up signs shall have a permanent sticker affixed to the non-reflective face with the wording "PROPERTY OF WVDOH" in ½" minimum legend size.

The successful vendor shall provide a one (1) year warranty against defects in workmanship, parts, and materials (with the exception of that which is covered under the 3M warranty) on all signs supplied as part of this Contract.

#### **ADDITIONAL SPECIFICATIONS FOR BID ITEM 3**

Signs supplied as part of Bid Item 3 shall be per the WVDOH Sign Fabrication Details, fabrication number R1-1, 36", and shall be octagonal in shape. Rib sizes, rib locations, rib lengths, corner pocket locations, rotation point location, and anti-kite velcro strip locations shall be in substantial conformance as shown in the attached drawing "36" OCTAGON – CORNER POCKET AND RIB CONFIGURATION".

#### **ADDITIONAL SPECIFICATIONS FOR BID ITEM 4**

Signs supplied as part of Bid Item 4 shall be per the WVDOH Sign Fabrication Details, fabrication number R1-1, 48", and shall be octagonal in shape. Rib sizes, rib locations, rib lengths, corner pocket locations, rotation point location, and anti-kite velcro strip locations shall be in substantial conformance as shown in the attached drawing "48" OCTAGON – CORNER POCKET AND RIB CONFIGURATION".

#### **ADDITIONAL SPECIFICATIONS FOR BID ITEM 5**

Signs supplied as part of Bid Item 5 shall be per the WVDOH Sign Fabrication Details, fabrication number W3-1M, 36". An orange background shall be used. The symbol may be glued or sewn onto the sign face separately. Rib sizes, rib locations, rib lengths, corner pocket locations, rotation point location, and anti-kite velcro strip locations shall be in substantial conformance as shown in the attached drawing "36" DIAMOND – CORNER POCKET AND RIB CONFIGURATION".

#### ADDITIONAL SPECIFICATIONS FOR BID ITEM 6

Signs supplied as part of Bid Item 6 shall be per the WVDOH Sign Fabrication Details, fabrication number W3-1M, 48". An orange background shall be used. The symbol may be glued or sewn onto the sign face separately. Rib sizes, rib locations, rib lengths, corner pocket locations, rotation point location, and anti-kite velcro strip locations shall be in substantial conformance as shown in the attached drawing "48" DIAMOND — CORNER POCKET AND RIB CONFIGURATION".

#### ADDITIONAL SPECIFICATIONS FOR BID ITEM 7

Signs supplied as part of Bid Item 7 shall be per the WVDOH Sign Fabrication Details, fabrication number R1-2, 36", and shall be triangular in shape. Rib sizes, rib locations, rib lengths, corner pocket locations, rotation point location, and anti-kite velcro strip locations shall be in substantial conformance as shown in the attached drawing "36" TRIANGLE – CORNER POCKET AND RIB CONFIGURATION".

Signs supplied as part of Bid Item 8 shall be per the WVDOH Sign Fabrication Details, fabrication number R1-2, 48", and shall be triangular in shape. Rib sizes, rib locations, rib lengths, corner pocket locations, rotation point location, and anti-kite velcro strip locations shall be in substantial conformance as shown in the attached drawing "48" TRIANGLE – CORNER POCKET AND RIB CONFIGURATION".

Signs supplied as part of Bid Item 11 shall be per the attached drawing "BID ITEM 11 MODIFIED STANDARD DETAIL". Overall size shall be 36"x60". All text shall be black. The background above the horizontal border shall be orange. The background below the horizontal border shall be white. The seam between the upper (orange background) and bottom (white background) portions of the sign shall be sewn along the black border in the manner specified above in the ROLL-UP SHEETING SPLICES section. No numerals shall be screened onto the sign face. 2 ea. 28" long x 1" (min) wide pieces of velcro shall be glued or sewn onto the sign face, as shown on the attached modified standard detail, to facilitate the attachment of the interchangeable numerals to be supplied as part of Bid Item 12. Rib sizes, rib locations, rib lengths, corner pocket locations, rotation point location, and anti-kite velcro strip locations shall be in substantial conformance as shown in the attached drawing "36X60 VERTICAL RECTANGLE - CORNER POCKET AND RIB CONFIGURATION".

Items supplied as part of Bid Item 12 shall be individual numeral plaques intended to be attached to the face of signs supplied under Bid Item 11. #### ABSTRACT FROM THE RECORDS OF THE COMMISSIONER'S ORDERS DATED

September 23, 2004

Pursuant to authority vested in the Commissioner by Chapter 17, Article 6, Section 2, of the Official Code of West Virginia, 1931, as amended, the Commissioner, upon an engineering and traffic investigation, hereby ORDERS a speed limit in work zones on controlled access highways with four or more lanes as follows:

- 1) 55 MILES PER HOUR (mph) on all readways with existing speed limits of 70 mph.
- 2) 50 MILES PER HOUR (mph) on all roadways with existing speed limits of 60 mph or 65 mph.
- 3) 45 MILES PER HOUR (mph) on all roadways with existing speed limits of 55 mph.
- 4) 40 MILES PER HOUR (mph) on all roadways with existing speed limits of 50 mph.

A work zone speed limit may be established in active work areas within the traveled way when at least one of the following conditions is satisfied:

- Road work activities cause the closure of a travel lane, OR
- Road work activities cause a reduction of the existing travel lane widths; OR
- Road work activities cause a temporary detour of the existing travel lanes.

This Order shall be effective when appropriate signs giving notice to the public have been installed in accordance with one of the two conditions noted below:

- For work areas that will be in existence for a period of time that exceeds one daylight operation "WORK ZONE SPEED LIMIT WHEN FLASHING" signs shall be in place, flashers shall be appropriately attached to these signs and said flashers shall be in operation, OR
- For work areas that will be in existence for periods of time, not to exceed one daylight operation "WORK ZONE SPEED LIMIT" signs shall be in place and all such signs shall be immediately removed or covered during; (a) non-working daylight hours, and (b) at the end of each daylight operation.

The authority to install the work zone speed limit shall be based on specific requirements contained in project plans, or by placing traffic control devices in accordance with the latest version of "Traffic Control for Street and Highway Construction and Maintenance Operations" Manual.

#### AFFIDAVIT

#### West Virginia Code §5A-3-10a states:

No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owned is an amount greater than one thousand dollars in the aggregate

#### **DEFINITIONS:**

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Debtor" means any individual, corporation, partnership, association, limited liability company or any other form or business association owing a debt to the state or any of its political subdivisions. "Political subdivision" means any county commission; municipality; county board of education; any instrumentality established by a county or municipality; any separate corporation or instrumentality established by one or more counties or municipalities, as permitted by law; or any public body charged by law with the performance of a government function or whose jurisdiction is coextensive with one or more counties or municipalities. "Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

#### **EXCEPTION:**

The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

#### LICENSING:

Vendors must be licensed and in good standing in accordance with any and all state and local laws and requirements by any state or local agency of West Virginia, including, but not limited to, the West Virginia Secretary of State's Office, the West Virginia Tax Department, West Virginia Insurance Commission, or any other state agencies or political subdivision. Furthermore, the vendor must provide all necessary releases to obtain information to enable the Director or spending unit to verify that the vendor is licensed and in good standing with the above entities.

#### **CONFIDENTIALITY:**

The vendor agrees that he or she will not disclose to anyone, directly or indirectly, any such personally identifiable information or other confidential information gained from the agency, unless the individual who is the subject of the information consents to the disclosure in writing or the disclosure is made pursuant to the agency's policies, procedures and rules. Vendors should visit www.state.wv.us/admin/purchase/privacy for the Notice of Agency Confidentiality Policies.
