1. Description of Work:

To provide all labor and materials for the removal and installation of the gas fired boiler system and hot water pumps at the West Virginia Division of Highways, District One, 1334 Smith Street, Charleston, West Virginia 25301.

Quote shall also include disposal of the old unit and the removal of any asbestos in accordance with state and federal regulations.

All work must be completed in accordance with the specifications set forth by the West Virginia Division of Highways and purchase order issued by the Department of Administration, Purchasing Division.

The unit to be replaced is as follows:

1. Peerless, Model 210-12-WT, Serial #210-3741
Max BTU Input per hr 2310000
BTU Output per hr 1848000
Min BTU Input per hr 924000
Ratings 1432600

The new hot water system shall consist of a primary secondary loop arrangement. Two boilers shall replace the one existing boiler to provide some redundancy for the primary heating source. The system shall have a dual circulating pump system. Each boiler will have two stages of heating for a total of four stages in the system. Said system shall have Carrier field installed CCN controls. Controls shall communicate with the existing Carrier control system.

2. Pre-bid Conference:

There will be a mandatory pre-bid conference on 09/06/07 at 10:00 AM. Said conference will be held at 1334 Smith Street, Charleston, West Virginia 25301. This will allow the vendor to fully inspect the facility where the system will be installed. All interested bidders are required to be present at this meeting. Failure to attend the mandatory pre-bid conference shall automatically result in disqualification. No one person can represent more than one vendor.

3. Liquidated Damages:

Contractor agrees that all work is to be completed within 45 consecutive calendar days following receipt of the owner's written "Notice to Proceed". For each calendar day of delay in achieving completion, the contractor shall be liable for and shall pay the owner liquidated damages in the amount of two hundred fifty dollars (\$250.00) per day.

PURCHASING AFFIDAVIT

"Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.


EXCEPTION: The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

LICENSING: Vendors must be licensed and in good standing in accordance with any and all state and local laws and requirements by any state or local agency of West Virginia, including, but not limited to, the West Virginia Secretary of State's Office, the West Virginia Tax Department, West Virginia Insurance Commission, or any other state agencies or political subdivision. Furthermore, the vendor must provide all necessary releases to obtain information to enable the Director or spending unit to verify that the vendor is licensed and in good standing with the above entities.





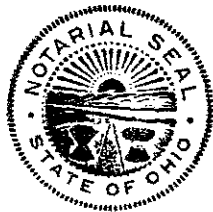
