GENERAL TERMS & CONDITIONS REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

- 1. Awards will be made in the best interest of the State of West Virginia
- 2. The State may accept or reject in part, or in whole, any bid.
- 3. All quotations are governed by the West Virginia Code and the Legislative Rules of the Purchasing Division.
- 4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125.00 registration fee.
- All services performed or goods delivered under State Purchase Orders/Contracts are to be continued for the term of the Purchase Order/Contract, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
- Payment may only be made after the delivery and acceptance of goods or services.
- 7. Interest may be paid for late payment in accordance with the West Virginia Code.
- 8. Vendor preference will be granted upon written request in accordance with the West Virginia Code.
- 9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
- 10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
- 11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
- 12. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.

RESPONSE TO VENDOR QUESTIONS AS FOLLOWS:

- QUESTION: Are we correct in our understanding that only one original copy of our response and one convenience copy are required?

 ANSWER: That is correct.
- QUESTION: If there are no collections scheduled at a site, does the collector still need to be at the collection site the minimum 1 day per week?

 ANSWER: The vendor must be available for the scheduling of collection at each site a minimum of one day per week. However, if no collections are scheduled, the vendor shall not be required to appear at the site.
- 3. **QUESTION:** Do you anticipate that each county will do self collections or will it be in only certain counties?

ANSWER: All BCSE offices shall be given the supplies for collections. The BCSE does not anticipate that any offices will be excluded from collection.

4. **QUESTION:** If a county was doing all of their own self collections, would the vendor still need to provide a collector and site 1 day per week?

ANSWER: The BCSE does not anticipate that any office will be doing self collections exclusively. The vendor will still provide services. Refer to #2.

QUESTION: In the RFQ, it states the vendor shall provide training for the employees of the Agency... Such training shall be provided at each Agency office by instructors certified to provide such training. Does the BCSE wish to have BCSE staff trained to be certified trainers or does BCSE plan for the certified trainer to be provided by the vendor?

ANSWER: The vendor shall provide training for collection to all BCSE staff. The BCSE does not anticipate that the BCSE staff will provide training to its employees.

6. **QUESTION:** Are the four training DVD's to be used for those counties & staff that are performing self collections or as a general collection procedure for showing to the vendor staff performing collections?

ANSWER: The vendor shall provide training for collection to all BCSE staff. Training DVDs shall be available for the use of the BCSE for review but are not anticipated to be used in the stead of vendor-provided training.

7. **QUESTION:** Under Services to be Provided, Item # I "The testing of genetic markers by the vendor shall include the minimum of ten (10) systems which will result in a cumulative probability of inclusion of at least 99%". If the awarded service provider can successfully meet the 99% requirement with less than ten (10) but more than three (3) systems as required by the AABB standard 5-3 (8th Edition), would this be acceptable?

8. **QUESTION:** How many collection sites are provided by the current vendor?

ANSWER: The current vendor provided less than 55 sites. However, the prior contract did not require collection sites for each county.

9. **QUESTION:** Based on the estimated annual sample volume provided on page 10 of the RFQ, Cost Quotation, the estimated total samples is 5710. If there are fifty-five (55) collection sites each having a minimum of one (1) collection day per week (times 52 weeks) and each site collects only two (2) samples a week, the estimated annual volume is already exceeded. Therefore, would the State be willing to be flexible on the number of collection days per month, per site?

ANSWER: The BCSE does not anticipate that testing will be required at each site in each week of the year. However, the contract requires that the vendor have such availability for the convenience of difficult-to-schedule customers and those with travel restrictions.

10. **QUESTION:** Are all appointments scheduled or are there walk-ins from court?

ANSWER: Generally, the BCSE will schedule the appointments in advance. The BCSE does not normally have walk-ins, but does not exclude this possibility if court is held on the day of collection AND the court would require the same.

11. **QUESTION:** On page 5 of the RFQ, Reports for the Tests, item D states each report shall include "... the laboratory designated racial origin of the mother, the child, and the alleged father for calculation purposes." However, AABB standard 5.2.4.2. states, "Race/ethnic background of each parent/alleged parent or other participant(s) being tested, with the exception of the child." The child's race is not included as the child's race is not used in the calculations and the race of the child is not determined until there is a finding of paternity. Can this requirement be revised to read "the racial origin of the mother and the alleged father for calculation purposes?"

ANSWER: The BCSE will revise the requirement to page 5 of the RFQ, Report for the Tests, item D -

FROM: "Each report shall include. the laboratory designated racial origin of the mother, the child, and the alleged father for calculation purposes"

TO: "Each report shall include...the laboratory designated racial origin of the mother, and the alleged father for calculation purposes."

Add the following sentence to item D:

"The racial origin of the child will be determined after a finding of paternity."

QUESTION: On page 3 of the RFQ, item M states, "The Vendor shall provide a minimum of one (1) collection site in each of the fifty-five counties of West Virginia. Said collection sites shall be available for appointments for a minimum of one (1) day per week...."

Recognizing that this RFQ has increased the required number of collection sites from the previous RFQ, have the current number of collection sites been

found to be inadequate?

ANSWER: Although the current vendor has satisfied the technical requirements of the previous contract, the current contract requires the increased number of collection sites to provide better customer service for the convenience of difficult-to-schedule customers and those with travel restrictions.

13. **QUESTION:** How many hours does the collector need to be available on the scheduled day of each week?

ANSWER: The vendor must be available for the scheduling of collection at each site a minimum of one day per week. However, if no collections are scheduled, the vendor shall not be required to appear at the site. The vendor is not expected to remain at the site longer than necessary to complete the scheduled draws, including any emergency draws.

AGREEMENT ADDENDUM

In the event of conflict between this addendum and the agreement, this addendum shall control:

- I <u>ARBITRATION</u> Any references to arbitration contained in the agreement are hereby deleted Disputes arising out of the agreement shall be presented to the West Virginia Court of Claims
- 2 HOLD HARMLESS Any clause requiring the Agency to indemnify or hold harmless any party is hereby deleted in its entirety
- 3 GOVERNING LAW The agreement shall be governed by the laws of the State of West Virginia. This provision replaces any references to any other State's governing law.
- 4 TAXES Provisions in the agreement requiring the Agency to pay taxes are deleted. As a State entity, the Agency is exempt from Federal, State, and local taxes and will not pay taxes for any Vendor including individuals, nor will the Agency file any tax returns or reports on behalf of Vendor or any other party
- 5. PAYMENT Any references to prepayment are deleted Payment will be in arrears.
- 6 INTEREST Should the agreement include a provision for interest on late payments, the Agency agrees to pay the maximum legal rate under West Virginia law All other references to interest or late charges are deleted
- 7 RECOUPMENT Any language in the agreement waiving the Agency's right to set-off, counterclaim, recoupment, or other defense is hereby deleted
- FISCAL YEAR FUNDING. Service performed under the agreement may be continued in succeeding fiscal years for the term of the agreement, contingent upon funds being appropriated by the Legislature or otherwise being available for this service. In the event funds are not appropriated or otherwise available for this service, the agreement shall terminate without penalty on June 30. After that date, the agreement becomes of no effect and is null and void. However, the Agency agrees to use its best efforts to have the amounts contemplated under the agreement included in its budget. Non-appropriation or non-funding shall not be considered an event of default.
- 9 STATUTE OF LIMITATION Any clauses limiting the time in which the Agency may bring suit against the Vendor, lessor, individual, or any other party are deleted
- 10. <u>SIMILAR SERVICES</u> Any provisions limiting the Agency's right to obtain similar services or equipment in the event of default or non-funding during the term of the agreement are hereby deleted
- 11 ATTORNEY FEES The Agency recognizes an obligation to pay attorney's fees or costs only when assessed by a court of competent jurisdiction. Any other provision is invalid and considered null and void
- 12 ASSIGNMENT Notwithstanding any clause to the contrary, the Agency reserves the right to assign the agreement to another State of West Virginia agency, board or commission upon thirty (30) days written notice to the Vendor and Vendor shall obtain the written consent of Agency prior to assigning the agreement
- 13 LIMITATION OF LIABILITY The Agency, as a State entity, cannot agree to assume the potential liability of a Vendor. Accordingly, any provision limiting the Vendor's liability for direct damages or limiting the Vendor's liability under a warranty to a certain dollar amount or to the amount of the agreement is hereby deleted In addition, any limitation is null and void to the extent that it precludes any action for injury to persons or for damages to personal property
- 14 RIGHT TO TERMINATE Agency shall have the right to terminate the agreement upon thirty (30) days written notice to Vendor.
- 15 TERMINATION CHARGES Any provision requiring the Agency to pay a fixed amount or liquidated damages upon termination of the agreement is hereby deleted. The Agency may only agree to reimburse a Vendor for actual costs incurred or losses sustained during the current fiscal year due to wrongful termination by the Agency prior to the end of any current agreement term.
- 16. RENEWAL Any reference to automatic renewal is hereby deleted. The agreement may be renewed only upon mutual written agreement of the parties.
- 17 <u>INSURANCE</u> Any provision requiring the Agency to insure equipment or property of any kind and name the Vendor as beneficiary or as an additional insured is hereby deleted.
- 18 RIGHT TO NOTICE Any provision for repossession of equipment without notice is hereby deleted However, the Agency does recognize a right of repossession with notice
- 19. ACCELERATION Any reference to acceleration of payments in the event of default or non-funding is hereby deleted
- 20 AMENDMENTS All amendments, modifications, alterations or changes to the agreement shall be in writing and signed by both parties. No amendment, modification, alteration or change may be made to this addendum without the express written approval of the Purchasing Division and the Attorney General.
