During pre-bid conference, two alternative solutions were addressed and agreed upon.

DELETE: Language describing Elastomeric Built-up Roofing.

ADD:

Contractors shall bid two alternative roofing techniques. One bid / technique will be selected during the bid evaluation period. Bid award will be based on most cost effective method to the agency and a selection of only one method will be made (Bid #1 or Bid#2, not both).

Bid #1

Cover existing AASF#1 metal panel Hanger roof area with an EPDM roofing system approved by manufacturer for this particular application. A rust-retardant metal primer will be applied to the entire surface of the existing metal panel roof prior to roof application. Foam board insulation will be used to fill between metal panel ribs with an additional board for the EPDM adhered layer. A 20 year (Twenty Year) water tight warranty and 80 mph wind warranty supplied from the manufacturer and presented to the owner prior to application for final payment. Existing gutter will be used / reattached. A detail of the suggested termination gutter attachment is included.

Cover existing AASF#1 metal panel roof with 24 gauge or thicker, metal panels. Installation will fully adhere to the recommendations of the manufacturer. PURCHASING AFFIDAVIT

"Political subdivision" means any county commission; municipality; county board of education; any instrumentality established by a county or municipality; any separate corporation or instrumentality established by one or more counties or municipalities, as permitted by law; or any public body charged by law with the performance of a government function or whose jurisdiction is coextensive with one or more counties or municipalities. "Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceeds five percent of the total contract amount.

EXCEPTION: The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

LICENSING: Vendors must be licensed and in good standing in accordance with any and all state and local laws and requirements by any state or local agency of West Virginia, including, but not limited to, the West Virginia Secretary of State's Office, the West Virginia Tax Department, West Virginia Insurance Commission, or any other state agencies or political subdivision. Furthermore, the vendor must provide all necessary releases to obtain information to enable the Director or spending unit to verify that the vendor is licensed and in good standing with the above entities.

CONFIDENTIALITY: The vendor agrees that he or she will not disclose to anyone, directly or indirectly, any such personally identifiable information or other confidential information gained from the agency, unless the individual who is the subject of the information consents to the disclosure in writing or the disclosure is made pursuant to the agency's policies, procedures and rules. Vendors should visit www.state.wv.us/admin/purchase/privacy for the Notice of Agency Confidentiality Policies.
