- 4. Six references who are familiar with G&O's work on similar projects.
- 5. A section summarizing why WVDEP should choose the G&O Team for this project.
- A signed Purchasing Affidavit from the State of West Virginia Purchasing Division, which indicates that G&O and our subconsultants are not in debt of any kind to the State of West Virginia.
