GENERAL TERMS & CONDITIONS REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

- 1. Awards will be made in the best interest of the State of West Virginia.
- 2. The State may accept or reject in part, or in whole, any bid.
- 3. All quotations are governed by the West Virginia Code and the Legislative Rules of the Purchasing Division.
- 4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
- 5. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
- 6. Payment may only be made after the delivery and acceptance of goods or services.
- 7. Interest may be paid for late payment in accordance with the West Virginia Code.
- 8. Vendor preference will be granted upon written request in accordance with the West Virginia Code.
- 9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
- 10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
- 11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
- 12. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
- 13. BANKRUPTCY: In the event the vendor/contractor files for bankruptcy protection, this Contract may be deemed null and void, and terminated without further order.
- 14. HIPAA BUSINESS ASSOCIATE ADDENDUM: The West Virginia State Government HIPAA Business Associate Addendum (BAA), approved by the Attorney General, and available online at the Purchasing Division's web site (http://www.state.wv.us/admin/purchase/vrc/hipaa.htm) is hereby made part of the agreement. Provided that, the Agency meets the definition of a Cover Entity (45 CFR §160.103) and will be disclosing Protected Health Information (45 CFR §160.103) to the vendor.
- 15. WEST VIRGINIA ALCOHOL & DRUG-FREE WORKPLACE ACT: If this Contract constitutes a public improvement construction contract as set forth in Article 1D, Chapter 21 of the West Virginia Code ("The West Virginia Alcohol and Drug-Free Workplace Act"), then the following language shall hereby become part of this Contract: "The contractor and its subcontractors shall implement and maintain a written drug-free workplace policy in compliance with the West Virginia Alcohol and Drug-Free Workplace Act, as set forth in Article 1D, Chapter 21 of the West Virginia Code. It is understood and agreed that this Contract shall be cancelled by the awarding authority if the Contractor: 1) Fails to implement its drug-free workplace policy; 2) Fails to provide information regarding implementation of the contractor's drug-free workplace policy at the request of the public authority; or 3) Provides to the public authority false information regarding the contractor's drug-free workplace policy."

Specifications

The following sections of the West Virginia Department of Transportation, Division of Highways Standard Specifications for Roads and Bridges, Adopted 2000 and supplemented January 1, 2003 shall apply to the administration of this contract: Sections 101, 102.4, 102.5, 105.1, 105.3, 105.10, 105.11, 105.12, 106.3, 106.4, 106.6, 106.7, 106.9, 107.2, 107.14, 107.19, 107.20, 108.8, 109.1, 109.2, 109.20.

The terms "Contractor" and "Vendor" used in the above specifications of this contract are interchangeable. Contractor shall mean Vendor and Vendor shall mean Contractor.

West Virginia Department of Transportation, Division of Highways Standard Specifications Roads and Bridges, adopted 2000 and supplemented January 1, 2003, may be obtained from:

WV Department of Transportation Division of Highways, Building 5, Room A729 1900 Kanawha Blvd., East Charleston, WV 25305

Material supplied under this contract shall meet the applicable requirements of Section 710 of the West Virginia Department of Transportation, Division of Highways Standard Specifications Roads and Bridges, adopted 2000 and supplemented January 1, 2003.

Material supplied under his contract shall be pressure treated using Chromated Copper Arsenate (CCA) - Type B or Type C, 100% pure oxide formulation only as the preserving salt. Kiln drying after treatment will not be necessary.

All treated material must be supplied from an approved preserving plant or acceptance testing and approval shall be obtained by the vendor prior to delivery. A list of approved treatment plants is available from:

PINE BRIDGE LUMBER (S4S)

Pine bridge lumber shall be No. 1 Dense or better, surfaced four sides and treated in accordance with AWPA Standard C-14 to .60 pounds per cubic foot salt retention.

TREATED PINE STRUCTURAL TIMBER ROUGH SAWED

Pine Structural Timber shall be No. 2 or better, treated in accordance with AWPA Standard C-14 to .60 pounds per cubic foot salt retention.

UNTREATED WHITE OAK BRIDGE LUMBER ROUGH SAWED

Untreated White Oak Bridge Lumber Rough Sawed shall meet the standards fo the National Hardwood Lumber Association for Sound Square Edge. Untreated White Oak shall be unsurfaced, but shall be sized by being processed through a hit or miss surface.

BIDDING INSTRUCTIONS

Vendors shall not qualify bids. Any qualifications of the bids or any modification of the specifications or conditions governing the bids may be cause to reject the bid.

Maximum bundle weight of the lumber delivered shall be 6,000 pounds.

A delivery document showing items delivered and the actual calculated gross vehicular weight of the delivery shall accompany each load. The total number of delivery axles shall be recorded on the delivery document.

A twenty-four (24) hour notification shall be required prior to each delivery.

Failure to provide a proper notification may result in a delay in acceptance of the lumber. The telephone number for notification will be recorded on the State Contract Order (SCO) issued to the vendor.
