# GENERAL TERMS & CONDITIONS REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

- 1. Awards will be made in the best interest of the State of West Virginia.
- 2. The State may accept or reject in part, or in whole, any bid.
- 3. All quotations are governed by the West Virginia Code and the Legislative Rules of the Purchasing Division.
- 4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
- 5. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
- Payment may only be made after the delivery and acceptance of goods or services.
- 7, Interest may be paid for late payment in accordance with the West Virginia Code.
- 8. Vendor preference will be granted upon written request in accordance with the West Virginia Code.
- 9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
- 10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
- 11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
- 12. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
- **13. BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, this Contract may be deemed null and void, and terminated without further order.
- 14. NOTE:

5 bridge guardrail posts with hardware, and 25 linear feet of guardrail will be attached to beams by fabricator. Shipping constraints may limit the length of attached guardrail. Cost for guardrail attachement shall be included in the unit bid price. Minimum concrete strengths will be 5500 psi at detention and 8000 psi at 28 days. Prestressing strands shall be seven-wire uncoated low relaxation oversize strand (AS=0.167 sq. in.) with a minimum tensile strength of 270,000 psi. All lab reports must accompany the shipping ticket. Delivery is expected within 90 days of award.

The two 3/4" couplers to be shipped 3 weeks before beam delivery.

### PARTIAL PAYMENT OF APPROVED BOXES

Upon completion of manufacture and approval by the Division of Highways of all Box Beams specified on an individual State Purchase Order, the vendor may invoice and the Division will pay for the cost of manufacturing the Box Beams, not to exceed 65% of the total cost of the delivered Box Beams. Partial payment for Box Beams shall be subject to the following conditions:

- a. The vendor must request partial payment and furnish an official invoice for the manufactured and approved Box Beams.
- b. The vendor shall furnish a statement of approved Box Beams condition and exact storage location.
- c. The vendor shall furnish a legal right-of-entry onto the storage site to Division of Highways' employees and/or agents for the purpose of inspecting, sampling, testing, and removing any or all Box Beams.
- d. The vendor shall certify that the stored Box Beams are suitably marked and identified as property of the Division of Highways and will not be used for any purpose not designated by the Division.
