## GENERAL TERMS & CONDITIONS REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

- 1. Awards will be made in the best interest of the State of West Virginia.
- 2. The State may accept or reject in part, or in whole, any bid.
- 3. All quotations are governed by the West Virginia Code and the Legislative Rules of the Purchasing Division.
- 4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
- **5.** All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
- 6. Payment may only be made after the delivery and acceptance of goods or services.
- 7. Interest may be paid for late payment in accordance with the West Virginia Code.
- 8. Vendor preference will be granted upon written request in accordance with the West Virginia Code.
- 9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
- 10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
- 11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
- 12. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
- 13. BANKRUPTCY: In the event the vendor/contractor files for bankruptcy protection, this Contract may be deemed null and void, and terminated without further order.
- 14. ## MACHINE SPECIFICATION TEST MARK MODEL CM-4000-LXI

<u>DESCRIPTION:</u> CM-4000-LXI Series Compression Testing Machine, designed for concrete test specimens.

CAPACITY: 400,000 lbs. Compression.

RANGE: 4,000 lbs. to 400,000 lbs.

<u>ACCURACY:</u> ± .5% of indicated load.

<u>DESIGN</u>: A single unit self-contained high strength load frame design. The digital control box and hydraulic pump with load rate control valve are mounted on the right side members of the compression unit.

<u>COMPRESSION UNIT CONSTRUCTION:</u> The load frame is manufactured from four structural steel members 5" x 3-1/2" x 3/4" thick with top and bottom crossheads having a minimum thickness of 5" x 18-3/4" wide x 12" deep. The frames side members are fully welded to the inside and outside crosshead seams forming a solid one-piece load frame. The hydraulic cylinder assembly is mounted to the bottom crosshead with force being applied in an upward direction. Total frame deflection at full capacity is .027" exceeding ACI 363 frame stiffness specification.

- A. <u>INSIDE DIMENSIONS</u>: The compression area of the load frame has a vertical daylight opening of 18-3/8" and a horizontal opening of 13-1/4". These dimensions are without spherical seated platen installed in the machine.
- B. <u>OUTSIDE DIMENSIONS</u>: The outside load frame dimensions are 60 1/4" overall height x 37 3/4" overall width x 20" overall depth when mounted on the heavy-duty stand supplied with the machine.

TOP COMPRESSION PLATEN ASSEMBLY: The spherically seated cylinder platen assembly is composed of four main parts, the contact platen, spherical disc, spherical seat and holding stem. The compression platen is 1.5" thick and 6.5" in diameter. Platen is hardened to a Rockwell hardness of 55C or better and is precision ground to maintain planeness within .0005" in any 6" of direction. Surface is scribed with concentric circles for easy specimen centering and electroplated with industrial hardened nickel for wear and rust resistance. Load capacity is 650,000 lbs. Platen conforms to ASTM C-39 specification.

BOTTOM COMPRESSION PLATEN: The lower platen is 2" thick by 12" wide by 18" deep and hardened to 55 RC or greater, plane to within .0005" in any 6" direction and hard nickel plated for wear and corrosion resistance. Concentric circles are scribed into the lower platen for easier centering of testing specimens. The platen is directly mounted to the top of the piston. A debris shroud prevents foreign matter from entering the piston and cylinder assembly.

HYDRAULIC RAM: Testing pressure to be applied by a power piston with a minimum diameter of 8". Stability length of the piston is 5" with the working stroke being 2 1/2". Precision ground and polished, the piston is mounted in a polished solid steel cylinder with a non-frictional "O"-ring and teflon back-up ring sealing system.

HYDRAULIC PUMPING SYSTEM: Hydraulic pressure is supplied to the piston by a two-stage pump. The pump features a super-charger first stage that provides low-pressure, high-volume delivery for rapid advance of the piston. Once system pressure exceeds 125 psi, stage two automatically takes over to deliver high-pressure, low-volume flow to full machine capacity. The hydraulic pump is directly connected to the electric motor, the pump runs immersed in hydraulic oil, rendering it maintenance free.

<u>HYDRAULIC CONTROL SYSTEM:</u> A single semi-automatic control valve with multiple loading and unloading functions is used.

- A. <u>METERED ADVANCE FUNCTION</u>: Loading is maintained by a pressure compensation valve that maintains a continuous rate of loading. Pressure per minute loading is adjustable from 2,000 to 200,000 pounds per minute or 0 to 0.6" per minute travel. At any time during the testing cycle the rate of loading can be adjusted. Load is applied continuously and without shock until sample failure.
- B. <u>FULL ADVANCE FUNCTION</u>: The rapid travel lever setting is used to move the compression platen at the rate of 2.5" travel per minute. This feature permits the rapid advancement of the hydraulic piston prior to making contact with the specimen, as well as pre-loading of specimens.
- C. <u>HOLD FUNCTION</u>: Pressure advance can be stopped and held to inspect the alignment of the test sample or stop the test cycle.
- D. <u>RETRACT FUNCTION:</u> This function is for the release of pressure and return of the piston to its start position.

<u>DIGITAL MOUNTING BOX:</u> The digital mounting box is located on the upper right hand side of the load frame, with the digital unit vertically mounted for easier reading of displayed load values. The digital box is manufactured from heavy gage steel and is 8 5/8" H x 10 5/8" W x 4" D. For full digital information please see attached specifications on the LXI digital.



#### **SAFETY FEATURES:**

- A. <u>Fragment guards</u>: Supplied as standard equipment, guards are mounted on the front and rear openings of the load frame.
- B. <u>Maximum Capacity Protection</u>: A hydraulic safety valve prevents the hydraulic circuit from exceeding the maximum capacity of the load frame. This is set at the factory. Once maximum capacity is reached, a high-pressure relief valve stops the machine from going beyond the set capacity.

<u>COMPLIANCE</u>: The CM-4000-LXI series testing machines are in strict compliance to A.S.T.M. specifications C-39, E-4, and A.C.I. committee 363.

<u>ELECTRICAL SPECIFICATIONS:</u> The hydraulic pump motor is rated at 115/220 volts, 13.2/6.6 full load amps. Single phase, 50/60 Hz current is required. Standard motor develops 3/4 horsepower.

<u>ACCESSORY SYSTEM:</u> Accessories are held in the compression unit by means of a locking holding stem system. The stem is inserted into the upper crosshead and held by a locking setscrew, accessible from the front for operator convenience and safety. Spacers are used for obtaining proper spacing for specimens of various heights.

<u>UNIT WEIGHT:</u> Complete unit shipping weight without accessories is 1,600 lbs.

<u>SHIPPING:</u> CM-4000-LXI machines are shipped in an upright position, bolted to a wooden skid and crated. Total shipping weight can vary, depending upon type and number of accessories ordered.

<u>WARRANTY</u>: Test Mark warranties the CM-4000-LXI testing machine, digital system and load platens for a period of two (2) years.



A durable membrane keypad is used to select and set all menu functions. Specific keys are; test set up menu, enter, tare, scroll arrows, store, print, specimen ID number, escape, 0 through 9, decimal point, utility diagnostics and password protected calibration.

Accuracy exceeds ASTM C-39 and E-4 requirements and in general is better than + .5% of indicated load from 1% to full machine capacity. This accuracy is achieved through a calibration program using 10 calibration points with piecewise linear fit between points. Accuracy is further improved through a unique edit calibration function, which allows the onsite calibrator to re-enter the program and reset an individual value assigned to a



For hard copy test documentation, up to 1,000 tests can be stored in memory and printed directly on a parallel port printer or transferred to a PC through a standard RS-232 serial port. To transfer stored test results to a PC, the optional Wincom or Wincom Plus data communications transfer program is required. The Wincom Plus program includes the added feature of allowing raw X-Y data to be transmitted directly to a PC for generating a Load/Stress vs. Time graph. Up to 10 individual graphs stored in the PC can be plotted on a single report page.

An optional piston travel speed indicator package is available, that when activated displays travel rates in either in, mm or cm per second or minute.
