REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)**

1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. All quotations are governed by the *West Virginia Code* and the *Legislative Rules* of the Purchasing Division.
4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
5. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
6. Payment may only be made after the delivery and acceptance of goods or services.
7. Interest may be paid for late payment in accordance with the *West Virginia Code*.
8. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
12. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
13. **BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, this Contract may be deemed null and void, and terminated without further order.

SCOPE OF CONTRACT

The purpose of this contract shall be to furnish materials required for the maintenance of Energy Absorption System Energite III Sand Barrels, Energy Absorption System Fitch Sand Barrels, and Traffix Devices Sand Barrels.

DELIVERY

All prices bid shall be FOB destination. A list of delivery addresses for the Sign Shop in each District is attached as part of this Contract. Note, various alternate addresses may be utilized in each District. All orders shall be shipped complete within forty-five (45) days A.R.O. Late delivery charges against the vendor may be assessed at a rate of \$50.00 per calendar day beyond forty-five (45) days A.R.O. Notification of shipment from vendor or shipper shall be received a minimum of 48 hours before delivery of material at the location indicated on the release. All non-hardware parts shall be shipped adequately secured on pallets for ease in unloading.

AWARD OF BID ITEMS

For the purposes of obtaining replacement components for all existing attenuating devices in use, all parts listed on the bid item list will be awarded with the exception of complete replacement sand barrel units. Only ONE of the following combinations of Item numbers for complete sand barrel units will be awarded:

- Either Item numbers 1 and 2, or
- Item number 4, or
- Item numbers 6, 7, and 8

The combination awarded will be based on comparison of the combined Total Amount value for each combination.

All other sand barrel Item Numbers listed are to be awarded.

All bids are to be reviewed by the WVDOH Traffic Engineering Division prior to award.

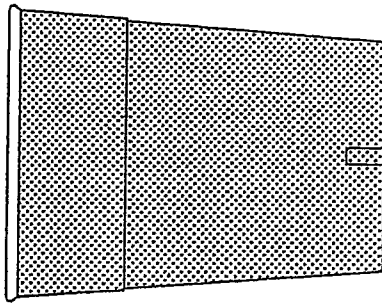

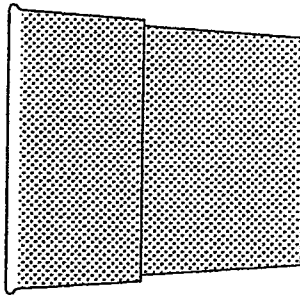

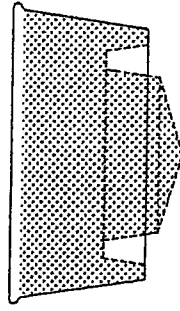

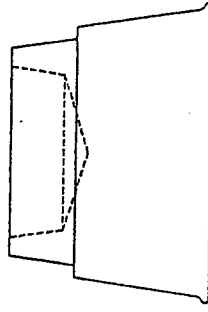

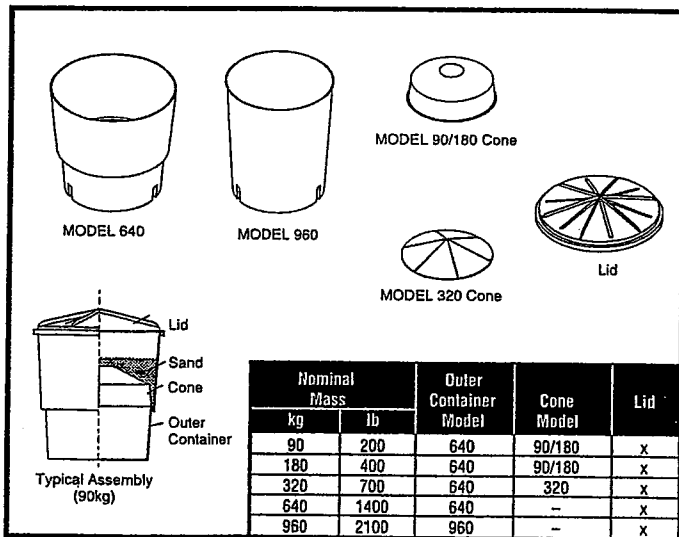

Site Preparation/Foundation

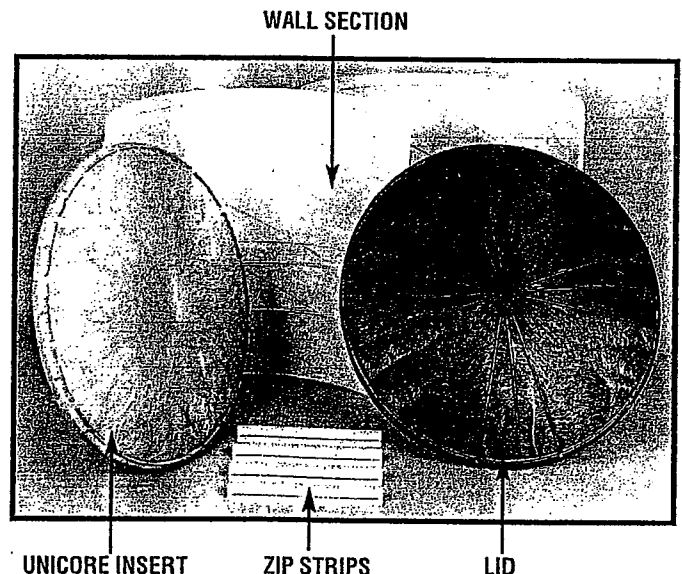
The Energite® III/Fitch® Universal Module Systems can be installed on concrete or asphalt surfaces at sites with a maximum grade (lateral and longitudinal) of 5%. If the grade is greater than 5%, the site will require grading before installation can begin.

All curbs and raised islands should be removed. Where this is not possible, a maximum of 100 mm (4") high is recommended. The site must also be clear of debris and snow.

Inspect Shipment


