All prices shall remain firm for a minimum of one year.

Delivery:

It is preferred that deliveries be made within 30 days after receipt of order (ARO).

Deliveries shall be made during normal working hours. State Agencies must be advised in writing if orders will be delayed for any reason.

All prices shall be quoted as F.O.B. shipping destination. The minimum order for prepaid shipping to one, in-state destination shall be \$200,00 for orders less than \$200.00 the vendor may add actual transportation costs (prepaid) to the invoice as a separate item.

Ordering Requirements:

The agency shall submit an executed ABC Form prior to order release of alcohol.

Form 5150.9 is required to purchase Tax Free Alcohol. This form is required to avoid the billing of the Federal Excise Tax. It is the responsibility of the agency to verify that the successful vendor has this form on file which will exempt their purchases from this Federal Excise Tax on alcohol purchases.

PURCHASING AFFIDAVIT

VENDOR OWING A DEBT TO THE STATE:

West Virginia Code §5A-3-10a provides that: No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owed is an amount greater than one thousand dollars in the aggregate.

PUBLIC IMPROVEMENT CONTRACTS & DRUG-FREE WORKPLACE ACT:
