The West Virginia Division of Culture and History is soliciting bids for procurement of air filtering media required for the HVAC system located in the Cultural Center on the Capitol Complex in Charleston, West Virginia.

It is anticipated that the Agency will require 448 units of each type of media annually. Minimum individual order for each type of media will be Fifty-Six (56) units. Piecemeal ordering is due to lack of storage space for the full procurement quantity. Media shall meet the specifications below.

Vendor shall be required to accept a VISA/State of West Virginia Purchasing Card as payment in arrears for the commodity delivered. Bid shall include the cost of shipping to the point of delivery and any other charges required for delivery. Prices shall remain constant for the life of the contract.

SPECIFICATION

- **Pre-Filter:** Fiberbond Dustlok filter panel, synthetic media w/ internal wire support, w/ SPOR-AX Anti-microbial agent or, approved equal.
