Questions and Answers

Q1. Referring to the ¾ inch by 0 high calcium fines. Will there be any price adjustment if fines of less than the specified 96% calcium carbonate equivalent are used?

A1. No, the price shall be based on 96% calcium carbonate equivalent. If fines off less than 96% calcium carbonate equivalent are used, you shall have to provide additional tonnage to compensate for the lower calcium carbonate equivalent at no additional cost.

Q2. Referring to the construction of the sludge cells. Are the soils on site suitable to be impervious for sludge cell construction?

A2. The sludge cells do not have to be impervious, but they do have to hold water. The water may leak out over a several day period. It shall be the contractors' responsibility to use the most suitable soil material on site.

Q3. Referring to Pond 3 area. Does a sludge line run from this area back to the sludge cells and how is it going to be routed?

A3. Yes, one sludge line will run down to Pond 3 and the contractor may determine the best possible route for it between Pond 3 and the sludge cells.

REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)**

1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. All quotations are governed by the *West Virginia Code* and the *Legislative Rules* of the Purchasing Division.
4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
5. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
6. Payment may only be made after the delivery and acceptance of goods or services.
7. Interest may be paid for late payment in accordance with the *West Virginia Code*.
8. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.






