4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125.00 registration fee.
5. All services performed or goods delivered under State Purchase Orders/Contracts are to be continued for the term of the Purchase Order/Contract, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
6. Payment may only be made after the delivery and acceptance of goods or services.
7. Interest may be paid for late payment in accordance with the *West Virginia Code*.
8. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.

The following questions and associated responses are from the Pre-Bid Conference for the above referenced project.

- Question: The cut and fill sections do not totally balance. Can the final grades be adjusted as necessary?
Answer: The sections were not revised when the passive treatment systems were deleted from the plans. So, yes, the final grade can be adjusted to account for this small discrepancy.
- Question: Can on-site rock from the excavation of the highwall be utilized in channel construction?
Answer: The only such rock that can be utilized is the placement of random boulders for the natural stream channel construction. Otherwise, as per Specification 7.2.1, an acid/base account shall be required on sandstone to ensure that it is not acid producing, but commercially purchased limestone is preferred.
- Question: Are the component structures for natural stream channel construction supposed to be installed on only one side of the channel as per the detail?
Answer: The component structures are to be installed on both sides of the channel, but not directly across from each other.
- Question: Does the geomembrane apply to both of the natural stream channels?
Answer: No, it applies to Channel No. 7 and not Channel No. 6.
- Question: Does the installation of the geomembrane require it to be seamed or can it be overlapped?
Answer: It is required to be seamed.
- Question: Is it required to submit a written drug policy with the bid?
Answer: No. The purchasing affidavit was revised on July 1, 2008. The contractor is only required to sign an up to date purchasing affidavit prior to award of the contract. The Purchasing Division will provide the revised form to the contractor.
