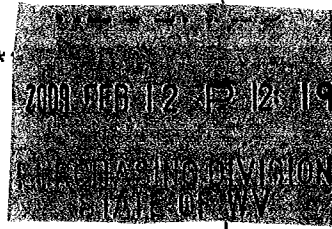

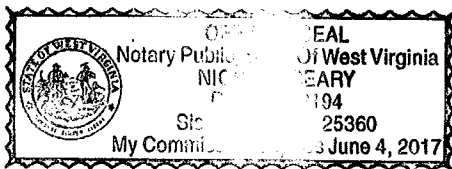

REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)**

1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. All quotations are governed by the *West Virginia Code* and the *Legislative Rules* of the Purchasing Division.
4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
5. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
6. Payment may only be made after the delivery and acceptance of goods or services.
7. Interest may be paid for late payment in accordance with the *West Virginia Code*.
8. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
12. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
13. **BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, this Contract may be deemed null and void, and terminated without further order.
14. **HIPAA BUSINESS ASSOCIATE ADDENDUM:** The West Virginia State Government HIPAA Business Associate Addendum (BAA), approved by the Attorney General, and available online at the Purchasing Division's web site (<http://www.state.wv.us/admin/purchase/vrc/hipaa.htm>) is hereby made part of the agreement. QUESTIONS AND ANSWERS

Q: Where is the leach field for the septic tank? Will AML pay the Contractor extra for having to repair the leach bed?

A: The exact location of the leach field is unknown. AML will not pay extra for repair of the leach bed. Payment for repair of the leach bed will be considered incidental to Pay Item 7.3, "18" I.D. HDPE PIPE".

Q: Are we doing any work behind the building?

A: No. The original plans show pipe placement behind the building but the hillside behind the building appears unstable. The attached drawings reflect a change of alignment for the pipe.

Q: Is the bridge at the entrance of the street a private bridge or a county bridge?

A: The owner of the bridge is unknown.

Q: Is the concrete structure hollow?

A: The structure appears to have been a cistern.

Q: Is the portal roof collapsed up that high?

A: The extent of collapse within the portals is unknown.

Q: Is the ditch from the last portal rock riprapped?

A: The ditch is grass lined across the bench and is rock riprapped down the slope as is shown on the plans.

SPECIFICATION REVISION

Add 7.2.4 Pipe Backfill

Backfill for pipe within the yard shall consist of random material excavated from the trench for pipe placement. Pipe backfill across the roadway shall consist of crusher run stone as described in Specification 7.2.1 Stone.

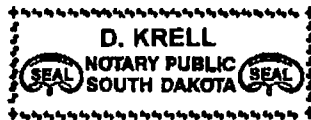
