4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
5. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
6. Payment may only be made after the delivery and acceptance of goods or services.
7. Interest may be paid for late payment in accordance with the *West Virginia Code*.
8. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.

Q: Are there any realty issues at this site?

A: The Contractor shall be responsible for obtaining rights of entry for equipment and materials storage areas. The residents yard across the highway is not within the construction limits.

Q: Will the discharge pipes that are to be bored into the mine be placed on a slope?

A: Yes, as shown on the drawings.

Q: The elbow on the pipe is because of a change in grade?

A: Yes, as shown on the drawings.

Q: What does the cutoff stone do?

A: The stone is placed to prevent piping along the outside of the steel casing to prevent future erosion problems.

Q: What is to be done with the trees?

A: The trees are to be disposed of off site. No burning will be allowed on site.

Q: Have you measured the water level in the piezometer?

A: Yes, a water level is shown on the profile. However, the level may change.

Q: About where is the floor of the coal?

A: A coal seam level is shown on the profile and a drill log is attached.

Q: Is the guy wire in the way of the bench cut?

A: If the guy wire is in the way, the Contractor shall reference Special Provision XV "UTILITIES AND OTHER OBSTRUCTIONS" as outlined in the Construction Specifications.

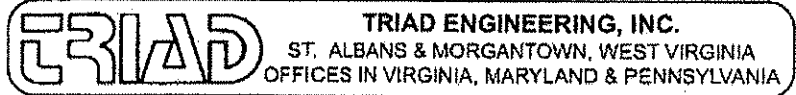

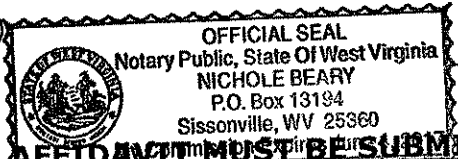

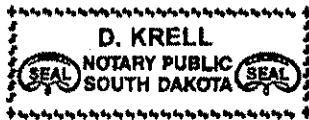
