We use our Trimble GPS (Pathfinder Professional) equipment as a survey tool to navigate, determine base points, x-y locations, and log feature attribute information with submeter accuracy. This system is used to map natural and man-made features; establish the initial traverse for corridor planning activities; and for locating feature points (manholes), monitoring points (air samples), and pollutant sources. We can plot GPS data on maps using AutoCAD, MicroStation, or GIS ArcInfo. Feature attribute data such as wetland data can be logged in the field and printed on a customized data form. Digital data from an external source such as a noise meter can be imported into GPS and presented on a map or form in conjunction with a feature. DATA CONVERSION

Gannett Fleming has extensive experience in data conversion and output. We have developed efficient procedures for converting hardcopy pre-existing maps and drawings to digital format. Through the use of several large-format 800-dpi scanners, raster editing software, and interactive vectorization software products, we are capable of providing a total package of services. The hardware that we are currently using for our scanning operations consists of a Vidar truscan 800, and an Ideal FSS8300; both are state-of-the-art 800-dpi E-size scanners. The scanners convert line and text features from the original hardcopy into a raster image, the resolution of which is determined by the quality of the hardcopy and scanner settings. Once the raster image is created in one of many acceptable formats, (Intergraph .CIT, AutoCAD .RLE, .TIF, .BMP, etc.) we process the raster image with one of our raster editing tools. We use I/RAS C and I/RAS B software products to process either black-and-white or greyscale scanned raster images. Both products have the capability for an affine transformation so that raster images can be georeferenced to any desired datum and projection.

For vectorization purposes, our primary tool is I/GEOVEC software by Intergraph. I/GEOVEC is an interactive vectorization software product that generates vector graphics for CADD or GIS. User-identified parameters define the line work to be vectorized. While the operator must still provide direction cues, this procedure has proven cost-effective over hand-digitizing or current automatic vectorization solutions. Feature fields can also be linked with databases later in the mapping procedure.

ENVIRONMENTAL LABORATORY

Gannett Fleming is associated with an environmental laboratory that is located in our facility and is capable of performing a vast range of water quality, solid waste and environmental testing. The laboratory is nationally accredited under the guidelines of the NELAC program. Analytical equipment includes an autoanalyzer, flame and flameless atomic absorption spectrophotometers, an X-ray diffraction spectrophotometer, a mass spectrograph, gas chromatographs, an infrared analyzer, and the normal array of laboratory facilities. 



Site 3888 is part of the Dents Run Acid Mine Drainage (AMD) restoration project and consists of three (3) deep mine discharges that negatively impacted Dents Run. The original system was proposed by the U.S. Army Corps of Engineers, and consisted of a deep mine discharge collection system, an Open Limestone Channel, and an Oxidation/Precipitation Basin. Gannett Fleming, Inc. was retained by the Corps to analyze the performance of the system and provide remedial solutions if necessary.

Gannett Fleming analyzed the existing system design and influent/effluent water quality data, and found that the system was not meeting water quality effluent goals. Alternatives for remediation and/or retrofit were developed with the intent of using as much of the existing system as possible to reduce remediation costs. The recommended alternative consisted of the conversion of an existing settling pond into a vertical flow wetland. The retrofit made it possible to meet the water quality effluent goals, extend system life, and provide for excess alkalinity to buffer downstream sources of AMD in remote locations not accessible for treatment system construction.

DENTS RUN SITE 3893 RETROFIT



Site 3893 is part of the Dents Run Acid Mine Drainage (AMD) restoration project and consists of two (2) unnamed tributaries impacted by acid mine drainage (AMD) baseflow. Gannett Fleming, Inc. was retained by the Corps to finalize Designs for the reclamation of an abandoned surface coal mine and Passive Treatment Systems for the Seep 8 and Seep 9 AMD discharges.

After completion of surface reclamation, USACOE conducted additional water quality monitoring in the Seep 9 hollow during 2006 to see if the reclamation project had improved the quality of the Seep 9 hollow. The results of that monitoring showed that the Seep 9 water quality was actually worse than the data contained in the Corps 1999 feasibility study, resulting in an unacceptably short maintenance interval for the system as designed.

Gannett Fleming analyzed possibilities for remediation and/or retrofit to use as much of the existing design as possible. The recommended alternative was a recirculating pretreatment for the Seep 9 discharge to lower total influent acidity and dissolved metals concentrations, which significantly extended system life and decreased operations and maintenance costs, with a minimal up-front cost.


FALL BROOK ACTIVE TREATMENT SYSTEM

Owner: Tioga County Concerned Citizens Committee

Location: Fallbrook, Tioga County, Pennsylvania Project Construction and Design Costs: \$1.2M

The Fallbrook project consists of the collection and conveyance of 4 abandoned deep mine discharges that are impacting Fallbrook, a tributary of the Tioga River. Preliminary designs called for passive treatment of the discharges, but site constraints and the large size and cost of passive treatment made the largest of the discharges untreatable with passive technologies. Gannett Fleming was retained by the Tioga County Concerned Citizens Committee (TCCCC) to design an active treatment system that would collect, convey and treat all of the discharges.

Gannett Fleming analyzed the available water quality and flow data at the site, and performed a preliminary feasibility study to determine if it was possible and economically feasible to collect and convey the discharges to a central location without using pump stations to lift the flow of AMD. After initial surveying work was completed, it was determined that a non-powered conveyance system could be designed to carry the flow to a location that best suited a treatment plant. The system was designed to treat a 3000 gallon per minute combined discharge, and consists of approximately 6000 lineal feet of conveyance pipelines, a pebble lime active treatment module with silo, mixing channels, and oxidation/precipitation basins. System construction is expected in 2008.



FARR TIPPLE AMD TREATMENT SYSTEM

Location: Tuscarawas County, Ohio
Estimated Construction Cost: \$128,000

The Farr Tipple AMD Treatment System has been designed to provide passive treatment to an underground mine discharge. Influent waters are characterized by elevated metals and acidity. Our design proposes a mine seal to insure that all of the mine water is collected and enters the treatment system. This water will initially pass through an anoxic limestone drain, then flow through a series of three (3) wetland cells, an aerobic pond cell, an aerobic wetland cell, and a rock filter cell. The ALD will increase the alkalinity, promoting iron precipitation in the aerobic pond cell. The remaining two cells will continue the iron removal, producing an acceptable effluent quality. The final effluent from the treatment system is expected to be normal effluent limits. The life expectancy of the system as designed is a minimum of 15 years.

A reclamation plan was developed for the 57-acre site, which included bio-capping using WesTan Soil Plus TM, an organic soil conditioner from the E.H. Hall/Westfield Tanning Company.

Specific goals and objectives for the project included a reduction of the hydraulic loading and metals loading entering Two Mile Run and Kettle Creek, and the creation of a wildlife food plot for Pennsylvania's growing Elk herd, accomplished by regrading and establishing a permanent vegetative cover to the impacted area.

Close coordination was maintained with the Kettle Creek Watershed Association and Trout Unlimited during plan preparation in order to best meet the restoration goals.

KING COAL HIGHWAY

Gannett Fleming was responsible for geologic reconnaissance, geotechnical site investigation program, site mining issues, cut slope analysis and design, very large embankment fills analysis and design, and other geotechnical design and analysis for the King Coal Highway Project. The proposed highway is a 96-mile, four-lane divided highway running from Williamson to Bluefield. This section of the highway is 9.0 miles in length and is located between Red Jacket and Hampden. The project also consists of the proposed relocation of the existing two-lane roadway of WV Route 65 that runs between Taylorville and Red Jacket accommodating an at grade intersection with the proposed King Coal Highway. These sections of roadway will be developed over an area of rugged topography with an extensive history of surface and deep mining activities. The King Coal Highway alignment encounters large areas with mine overburden mountaintop back stacks, mine valley fills, mine spoil fires, and extensive highwalls. An additional aspect of the project is the partnering relationship between Alpha Natural Resources Inc. (formerly Nicewonder Contracting Inc.), WVDOH, and Mingo County, so that the road can be constructed concurrent with mining activities.





MARJOL BATTERY RECYCLING SITE HOST COMMUNITY REVIEW OF POTENTIALLY RESPONSIBLE PARTY (PRP) CLEANUP

In the early 1960s, the Marjol Battery Company initiated battery salvage operations in the small borough of Throop just north of Scranton. By the late 1960s, the Pennsylvania Department of Environmental Protection (PADEP) had initiated air sampling of lead emissions in response to citizen complaints. Citizen health problems and PADEP orders addressing the situation continued throughout the 1970s. The site ceased operations in 1981. In 1987, PADEP made a request to the U.S. EPA to perform off-site cleaning under the provisions of Superfund. In 1994, the Borough of Throop requested Gannett Fleming to be its technical advisor relative to the site cleanup of the Marjol property. Issues have included evaluation of alternative remedial actions, soil stabilization of the site to prevent erosion into the adjacent river, subsidence due to underground mining, filling of voids left from surface coal mining, aerial extent and depth of lead, methods of lead-contaminated soil disposal, future land uses, and environmental justice.



MOSQUITO CREEK ACID RAIN IMPACT ABATEMENT PROJECT

The Mosquito Creek watershed is poorly buffered and has suffered for many years from the impacts of acid rain, damaging and in places eliminating a once thriving trout fishery. Under a Pennsylvania Growing Greener Grant, Gannett Fleming is assisting the Mosquito Creek Sportsman Association in adapting and implementing passive treatment approaches for acid mine drainage to generate alkalinity and neutralize acidity in this watershed. One vertical flow wetland cell has been designed and constructed for this purpose, and two additional treatment sites have been funded under another Grant. These systems will work synergistically to reduce acidity in three contiguous headwaters tributaries and a portion of the main stem. A concurrent study will evaluate the results of these projects and sample key points in the remainder of the watershed develop a progressive restoration plan to guide future alkalinity-generating activities, and to predict the ultimate level of effort required to restore water quality throughout Mosquito Creek.

NORTH SPRING BRANCH BASEFLOW ISOLATION AND PASSIVE TREATMENT SYSTEM

Under NPDES permit conditions, treatment was required for metals-contaminated baseflow emanating from the toe of a wood waste landfill and entering a mountain stream channel at multiple, diffuse points. Using a baseflow isolation approach, Gannett Fleming designed a system to separate the contaminated groundwater from clean surface water runoff in the channel, allowing application of wetland treatment where it would be otherwise prohibited by construction space constraints in the steep, narrow stream valley. The existing channel was filled with coarse aggregate and a collection pipe, and a new, lined stream channel reconstructed on top of the collection zone using gabion baskets. Following completion, discharge from the collection zone was monitored for wetland treatment system design data under an extension of the NPDES compliance timeframe negotiated by Gannett Fleming. The final design consisted of three vegetated wetland cells targeted at iron removal, and a unique high-angle bacteria bed targeted at manganese removal with minimal construction space. Gannett Fleming was responsible for all aspects of the project design, preparation of plans, specifications, and bid package materials, and construction supervision. The system has shown excellent performance, meeting compliance targets since its construction in 1999.



Our firm provided design and construction services for ODNR Division of Mineral Resources Management to remediate an abandoned underground mine complex causing subsidence damage to seven residences in Martins Ferry, Ohio. This work was performed as part of the Abandoned Mine Land – Emergency program and required rapid response to the initial complaint and fast-track design. Depth to the mine varied over the project area from 15-feet to 40-feet.

Design - A mine void grouting program was designed to protect the seven residences from future subsidence events. Thirty-three boreholes were schedule with angles from zero to forty-five degrees. The residences were located in close proximity to each other, which provided for limited work space between structures. Gannett Fleming prepared the construction Plans, Specifications, and Estimate.

Construction Services - Gannett Fleming provided a professional as a full-time on-site inspector to maintain construction logs and provide technical guidance as required. The work required frequent interaction with the residents and general public. The boring program was adjusted as work proceeded to provide maximum grout coverage under the residences.






SIMMONS RUN A.M.D. TREATMENT SYSTEM

The Simmons Run A.M.D. Treatment System has been designed to collect and passively treat acid mine drainage originating from abandoned underground and surface coal mines. Influent waters are characterized by elevated metals and acidity. Our firm's design consists of an open water pond and five (5) wetland cells, three (3) anaerobic vertical flow wetland cells and two (2) aerobic wetland cells. The open water pond will collect surface runoff in addition to mine drainage seepage, and will function as a flow equalization device. The pond has been designed with an emergency spillway to route high flows around the wetland system to avoid damage to the wetland cells. The underground mine discharge enters the system at the second wetland cell. Discharge from the system is anticipated to be well within mandated effluent limits. Design of the wetland cells has been based on a minimum life expectancy of 15 years.
