**REVISION TO CONSTRUCTION SPECIFICATIONS**

Special Provision XVIII ROADWAY REPAIR – Remove sentence “The Contractor shall maintain the existing access road through the cemetery to the site in a clean condition as approved by the WVDEP.”

**QUESTIONS AND ANSWERS**

Q: Are there 8 mine seals at the site?

A: No, there are 4 as shown on the drawings.

Q: What kind of splash pads are we to put in?

A: Sandstone or limestone as outlined in Section 7.2.1 STONE of the Construction Specifications.

Q: The mine seals are wet and not dry seals?

A: Yes, as shown on the drawings.

Q: There are vertical pipes?

A: Yes, there are vertical standpipes to be installed as shown on the drawings.

Q: How do we handle the guy wire?

A: Refer to Special Provision XV UTILITIES AND OTHER OBSTRUCTIONS in the Construction Specifications for instructions on moving the guy wire.

Q: How deep are the grass lined ditches?

A: The ditches from the portals are 1' deep and the main ditch is 1.5' deep as outlined in the drawings.

Q: How long is the main channel?

A: The channel is approximately 400 feet long as shown on the drawings.

Q: What kind of sediment control will be used? Can we use silt fence?

A: There are straw bales to be placed on site as shown on the drawings, however the Contractor can also place silt fence in addition to the straw bales shown. The Contractor is responsible for controlling sediment as outlined in Section 5.0 SEDIMENT CONTROL of the Construction Specifications.

Q: Is there a railroad right of way at this site.

A: Yes.

Q: Do we need railroad insurance on this project?

A: No, but the railroad, along with other property owners within construction limits, will need to be listed as an additional insured on your insurance policy.

Q: Are there other portals at this site?

A: There could be other portals within existing backfill but we are installing 4 wet seals as shown on the drawings.

Q: How far does the main drainage channel go?

A: The channel ties to existing highway drainage within construction limits as shown on the drawings.

Q: Can you get soil borrow past the last portal?

A: You can borrow soil within the construction limits but there may not be an adequate amount. Soil may be borrowed outside construction limits according to Section 6.4 SOIL BORROW of the Construction Specifications.

Q: Is there a portal at the survey stake?

A: The survey stakes are turning points and not portal locations. The portal locations are shown on the plans.

Q: Is there any water backed up in the mines?

A: The site was not drilled so the water level in the mine is unknown. The Contractor shall refer to Section 9.0 MINE SEALS of the Construction Specifications for dewatering activities.
