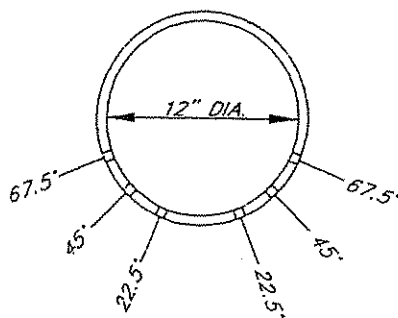

**Addendum #1 - Questions During Pre-Bid Meeting  
For DEP 14548  
Peora (Keller) Clogged Stream Project**

The following questions were identified from the Pre-Bid Conference. The answers provided herein take precedence over verbal answers at the PBC should there be any conflicts between the two.

- 1.) **Q.** Enhancement areas were mentioned, where is the enhancement area near the house?  
**A.** Below the road near the house fence as indicated on the plans.
- 2.) **Q.** Do you have a starting elevation for the bore location?  
**A.** No, it is dependent on the location of the pit and the target elevation from the bore log.
- 3.) **Q.** Do you have known elevations located on the surface?  
**A.** Yes.
- 4.) **Q.** Does the bore hole locations indicate large amounts of water in the mine works?  
**A.** Yes.
- 5.) **Q.** Is the type of water line known that is located along the road?  
**A.** No.
- 6.) **Q.** What is the name of the P.S.D. that services this area?  
**A.** Not known at this time, but "Miss Utility" will contact the companies to locate this line when needed.
- 7.) **Q.** If the water line needs relocated to complete the horizontal boring, how will this be paid?  
**A.** The Contractor will be reimbursed at invoice cost from the utility company as approved by the WVDEP.

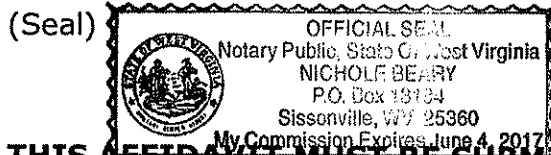

4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
5. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
6. Payment may only be made after the delivery and acceptance of goods or services.
7. Interest may be paid for late payment in accordance with the *West Virginia Code*.

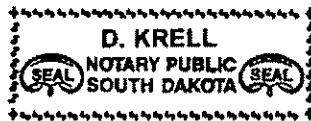
