REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. All quotations are governed by the *West Virginia Code* and the *Legislative Rules* of the Purchasing Division.
4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
5. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
6. Payment may only be made after the delivery and acceptance of goods or services.
7. Interest may be paid for late payment in accordance with the *West Virginia Code*.
8. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
12. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
13. **BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, this Contract may be deemed null and void, and terminated without further order.
14. **HIPAA BUSINESS ASSOCIATE ADDENDUM:** The West Virginia State Government HIPAA Business Associate Addendum (BAA), approved by the Attorney General, and available online at the Purchasing Division's web site (<http://www.state.wv.us/admin/purchase/vrc/hipaa.htm>) is hereby made part of the agreement. Item 1: Cover sheet Bid Schedule Item for "Clearing and Grubbing" reads 4.1. It should read 4.0.

Item 2: Cover sheet Bid Schedule quantity amount for "Revegetation" reads 20 acres. It should read 10 acres.

Item 3: Article II – Bidding Information, Section 8.0 states "the successful bidder agrees to schedule with DEP a preconstruction conference within 270 calendar days of the purchase order date". This should read "within 21 calendar days".

Also it states the successful bidder agrees to fully complete the project "within 270 calendar days from said date". This should read "365 calendar days".

Item 4: The contractor is to submit a sediment control plan prior to construction for each site. Sediment plans to be shown on plans for each site.

Item 5: Some of the sites are within the town limits of Rhodell and thus B&O Taxes may be required.

Site 1 Questions & Answers:

Item 6: Q) Will the pond be drained; is this the area where the cofferdam is to be placed? What is the method of installation of the pipe conveyance pipe?

A) The pond will not be drained. The cofferdam was not shown on any plan sheet to be implemented; it is in the detail sheet as a method to be used if working in the stream was necessary. The trench will be a type "A" trench repair with concrete placed around the pipe because of the limited cover over top of the mine seal pipes.

Item 7: Q) Is trash to be removed from site 1?

A) Trash within the limits of construction on site 1 will be removed.

Item 8: Q) What is to be done with debris removal from existing structures?

A) Specification 4.2 discusses debris removal.

Item 9: Q) Where are soil borrow areas?

A) Soil borrow areas are designated on the plan sheets and test pit information on each site is available on the Existing Plan Sheets.

Item 10: Q) Can site 3 be accessed across the creek?

A) If the contractor chooses to access site 3 from across the creek the contractor is responsible for permits crossing the creek.

Item 11: Q) Where is refuse removed to be placed?

A) The plans show a fill to be constructed adjacent to the refuse pile where the refuse can be placed.

Item 12: Q) Where is the inlet to be placed for water service to the home at site 5 and is the contractor to run the waterline?

A) The contractor is to discuss with homeowner where to place the inlet before installation. The contractor is not responsible for waterline to the home.
