- 1. Awards will be made in the best interest of the State of West Virginia.
- 2. The State may accept or reject in part, or in whole, any bid.
- 3. All quotations are governed by the West Virginia Code and the Legislative Rules of the Purchasing Division.
- 4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
- 5. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
- 6. Payment may only be made after the delivery and acceptance of goods or services.
- 7. Interest may be paid for late payment in accordance with the West Virginia Code.
- 8. Vendor preference will be granted upon written request in accordance with the West Virginia Code.
- 9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
- 10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
- 11. The laws of the State of West Virginia and the Legislative Rules of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
- 12. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
- 13. BANKRUPTCY: In the event the vendor/contractor files for bankruptcy protection, this Contract may be deemed null and vold, and terminated without further order.
- 14. ENTRY MAT SERVICES FOR WEST VIRGINIA STATE CAPITOL

The West Virginia Department of Administration, General Services Division (the "Agency" or "Owner"), is requesting quotations for a complete service package to supply and service entry mats at Agency-owned or leased facilities throughout the State.

GENERAL SPECIFICATIONS

- 1. All rugs and/or mats will be of industry quality (commercial-grade nitrile rubber based, 18oz minimum weight nylon-face or twist) and flat appearance as to not pose a tripping hazard. No torn or damaged rugs and/or mats will be permitted to remain in place during the life of the contract. No soiled or dirty mats or rugs shall be used as replacements during a service call. Mats or rugs should have an anti-slip backing. Mats or rugs shall be available in a minimum of twelve solid colors from which the Agency shall select for each facility.
- 2. Service will consist of pick-up and delivery on a weekly basis during the months of November through April, and bi-weekly during the months of May through October, totaling 39 service calls per annum. Service will also consist of equal service level for customer-owned logo mats (existing logo mats are of sizes equal to those listed on bid form, below).
- 3. Bidders are required to include any and all extraneous fees, such as environmental disposal fees, fuel sur-charges, delivery fees, etc., as part of the bid cost. Under NO circumstance will any of these types of fees be "tacked-on" over and above the unit bid cost of the contract.
- 4. Two copies (one original and one copy) of invoices will be submitted for payment monthly (in arrears) and must include the following information:
 - a. Copies of all service orders completed as witnessed and signed by Agency's Representative at each designated Building location. Each Building will require a separate service ticket.
 - b. One of the invoices must be in original type or state "original" on the face if computer generated. Invoice must include FEIN number and the complete address of vendor. Invoices shall be mailed to the following address:

c. Successful vendor is required to submit – within ten (10) working days after award of the contract - a chain or book sample representative of

product being quoted to include all colors which are available for selection under this contract.

- d. Successful vendor shall be required to accept payment by the State Purchasing Card for monthly invoices.
- 5. Upon termination of this contract, vendor will be solely responsible for the removal of all rugs and mats (EXCEPT customer-owned logo mats) from State premises. Upon termination of service in any facility for which service is initiated under this contract, vendor shall be solely responsible for the removal of all rugs and mats (EXCEPT customer-owned logo mats).
- 6. Agency will designate size and color application per Building to include quantities to be utilized; such modification may only be authorized in writing by Agency. Agency will generate an individually numbered release order listing the sizes needed per facility.
