The Consumer Advocate Division of the Public Service Commission of West Virginia ("CAD") is soliciting bids for the provision of consulting services in connection with 1) the general rate case filing of Hope Gas, Inc. dba Dominion Hope ("Dominion Hope") at the Public Service Commission of West Virginia, PSC Case No. 08-1783-G-42T; and 2) the proposed sale of Dominion Hope, PSC Case No. 08-1761-G-PC, described more fully below.

The Consumer Advocate Division has formally intervened on behalf of residential customers of the gas utility in both matters. Case filings can be reviewed at the Commission's web site at: <a href="http://www.psc.state.wv.us/">http://www.psc.state.wv.us/</a>. (Direct links to the filings are not available. Search by case number using the "case information" function of the site.)

Dominion Hope is the second largest gas utility in West Virginia and is part of the Dominion Resources, Inc. ("Dominion") family of companies. The Company=s filing indicates that it is seeking an increase in rates of approximately \$34.4 million or at least 21 percent for residential customers. Dominion, Dominion Hope and Peoples Hope Gas Companies LLC ("PH Gas") recently have filed a joint petition for approval of the sale of Dominion Hope to PH Gas, with equity interest to be held by a wholly-owned subsidiary of Babcock & Brown Infrastructure Fund North America LP ("BBIFNA"). The joint petitioners in this sale and acquisition case recently filed a motion to consolidate the general rate case with the sale and acquisition case.

We are seeking bids for both the general rate case and the sale and acquisition case. Under the general rate case the vendor shall be required to address revenue requirement issues under two different scenarios-continued ownership of Dominion Hope by Dominion, and alternatively under ownership by PH Gas/ BBIFNA. Rate of return and the rate case impact of the Commission's recent order requiring Dominion Hope to switch its storage accounting method from LIFO to WACOG will be handled by the Consumer Advocate Division staff. The consultant will be expected to provide expert testimony on all other revenue requirement issues under the two ownership scenarios, including rate base, revenues, expenses, service company billings, taxes, operating income, and all of the sub-areas which fall into these categories.

The Consumer Advocate Division will handle general policy issues in the sale and acquisition case. The consultant will be expected to provide expert testimony on all other issues arising in the context of the proposed transaction. As was the case in Dominion's recent failed effort to sell Dominion Hope to Equitable Resources, Inc., pension and OPEB issues assumed significant value and importance and will require considerable attention by the consultant. Respondents to this RFQ can submit bids on either or both of the two distinct cases. The CAD reserves the right to award the contract separately for either case or as a single contract for both cases combined. If bids are submitted on both cases, the bidder must show it possesses adequate staffing to cover both cases simultaneously. Estimated number of hours is for bidding purposes only, because actual number of hours are unknown.

Upon request, the agency may request a list of personnel who will be working on the identified elements of the above described case(s). For the general rate case, the vendor shall be required to have participated in a minimum of ten (10) regulated utility cases involving revenue requirement issues. Upon request, vendor shall submit proof of such experience. Vendor shall provide a list of any cases that could be in conflict with this case. For the sale and acquisition case, the vendor shall be required to have participated in a minimum of ten (10) utility cases involving similar transactions. Upon request, vendor shall submit proof of such experience. Vendor shall provide a list of any cases that could be in conflict with the above described case(s).

The general rate case consultant must have at least 10 years experience testifying on revenue requirement issues involving regulated utilities. The consultant in the sale and acquisition case must have at least10 years experience testifying in regulated utility matters on a wide variety of issues relating to similar transactions. Consultants in both matters must be Certified Public Accountants or have advanced degrees in business, economics, finance or accounting. The consultants must be able to coordinate and incorporate recommendations from multiple witnesses testifying on behalf of the Consumer Advocate Division.

### **PURCHASING AFFIDAVIT**

#### VENDOR OWING A DEBT TO THE STATE:

West Virginia Code §5A-3-10a provides that: No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owed is an amount greater than one thousand dollars in the aggregate.

#### PUBLIC IMPROVEMENT CONTRACTS & DRUG-FREE WORKPLACE ACT:

West Virginia Code §21-1D-5 provides that: Any solicitation for a public improvement construction contract shall require each vendor that submits a bid for the work to submit at the same time an affidavit that the vendor has a written plan for a drug-free workplace policy in compliance with Article 1D, Chapter 21 of the West Virginia Code. A public improvement construction contract may not be awarded to a vendor who does not have a written plan for a drug-free workplace policy in compliance with Article 1D, Chapter 21 of the West Virginia Code and who has not submitted that plan to the appropriate contracting authority in timely fashion. For a vendor who is a subcontractor, compliance with Section 5, Article 1D, Chapter 21 of the West Virginia Code may take place before their work on the public improvement is begun.

#### **ANTITRUST:**

Such assignment shall be made and become effective at the time the purchasing agency tenders the initial payment to the bidder.

#### I. INTRODUCTION

The Columbia Group, Inc. proposes to provide consulting services to the Consumer Advocate Division of the Public Service Commission of the State of West Virginia ("CAD") on revenue requirements issues with regard to the recent base rate case filing of Hope Gas, Inc. d/b/a Dominion Hope ("Hope" or "Company"), PSC Case No. 08-1783-G-42T. Hope serves approximately 114,000 customers in 32 counties in West Virginia. Hope is currently owned by Dominion Resources, Inc. ("Dominion").

On November 24, 2008, the Company filed for a base rate increase of \$34.4 million or approximately 71.2% over going-level non-gas revenue at present rates. This filing reflected Hope's current ownership structure. On December 5, 2008, Hope also filed an alternative request for a base rate increase of \$26.9 million or approximately 55.7% over going-level non-gas revenue at present rates. This latter request assumes that Dominion's request to sell the Company's stock to Babcock and Brown Infrastructure Fund North America LP ("BBIFNA") will be approved by the Public Service Commission ("Commission").

This proposal includes the provision of revenue requirement services, including a development of rate base, going-level revenues, going-level operating expenses, service company billings, and going-level income tax claims. It also includes a review of going-level depreciation claims to ensure that going-level depreciation expense is consistent with CAD's recommended utility plant in service claim. This proposal does not include a detailed review of the depreciation rates used by Hope.

The services outlined in this proposal will be provided for two scenarios. First, we will provide a full revenue requirement analysis assuming the current ownership structure. Second, we will provide an alternative revenue requirement recommendation based on the sale of Hope to BBIFNA. Andrea C. Crane, President of The Columbia Group, Inc., is the proposed witness for this engagement.

#### II. BUSINESS ORGANIZATION

This proposal is being made by The Columbia Group, Inc. through its office located at 199 Ethan Allen Highway, Ridgefield, Connecticut 06877. (Mailing address: PO Box 810, Georgetown, CT 06829.) The Columbia Group, Inc. was founded in 1981 as a public interest utility consulting firm. Columbia is a full service utility consulting group. We currently have a professional staff of five consultants. Members of Columbia have presented direct testimony in over 800 dockets across the United States. These dockets have included matters relating to gas, electric, water, wastewater, telephone, navigation, solid waste and cable television facilities.

The regulatory work of Columbia personnel has been on behalf of divisions of consumer advocate, state regulatory commissions, departments of attorney general, municipal utilities and municipalities. Columbia personnel do not testify on behalf of investor-owned utilities.

All work outlined in this proposal will be performed by Columbia personnel under the supervision of Andrea C. Crane, President of the firm. Ms. Crane would also serve as the witness on this engagement.

#### III. PROJECT SUMMARY

This engagement will include a review of the filings made by the Company, critical evaluation of those filings, development of proposed adjustments, formulation of recommendations on selected policy issues, and development of a recommended revenue requirement for each ownership scenario. As we develop our revenue requirement recommendations, we will also work closely with CAD and its other consultants.

Our analysis begins with a determination of the appropriateness of the test year selected by the Company. In this regard, we will review the Company's claim for plant in service, depreciation reserve, cash working capital, materials and supplies, other reserves and prepayments, contributions in aid of construction, and other elements. Our analysis will be directed toward ensuring that the Company a) has included appropriate elements, and only appropriate elements, in its rate base claims and b) has correctly quantified those elements. Possible issues to be addressed include forecasts of construction, claims for construction work in progress, the treatment of non-cash items in cash working capital, development of materials and supplies, and elimination of contributions in aid of construction from rate base. We will utilize the overall cost of capital recommendation developed by CAD or its other consultants to determine the required operating income for the Company, given our recommended rate base.

We will then evaluate the Company's going-level revenue claims, at present rates. This evaluation includes recommendations regarding normalizations and annualizations for such factors as number of customers, consumption, weather, and

other variables.

Coincident with developing a going-level revenue recommendation, we will examine the Company's going-level expense claims. Specific areas of scrutiny may include salaries and wages, benefits, inflation adjustments, uncollectibles, affiliated interest charges, and other issues. Adjustments will be proposed where appropriate. In addition, we will review the Company's going-level income tax claims.

After reviewing the Company's filing, and making specific adjustments to rate base, going-level revenue and expenses, and taxes, we will then develop our recommended revenue increase/decrease.

We will work closely with CAD to apply our recommended revenue requirement to CAD's recommended rate structure.

Following is a discussion of some of the issues likely to be encountered in this proceeding.

- 1. <u>Test Year</u> The test year selected will be reviewed to determine whether it represents a period of time of normal operating conditions and financial results.
- 2. Plant In Service We will review the Company's plant in service claim to determine whether the plant claimed is used and useful in providing utility service. As part of this review, we will evaluate the history of the Company with regard to completed construction relative to budgeted construction.
- 3. <u>Construction Work In Progress</u> We generally recommend the exclusion of construction work in progress from rate base, on the basis that such plant is not used and useful in the provision of utility service. Any claim for the inclusion

of construction work in progress in rate base will be evaluated in view of the Company's cash flow requirements.

- 4. Advances for Construction These funds are cost free sources of capital and should be deducted from rate base. To the extent that these advances have not been fully repaid and/or the advance period has expired, these funds should be transferred to contributions in aid of construction.
- Contributions in Aid of Construction These funds are also cost free sources of capital and should be deducted from rate base.
- 6. <u>Depreciation Reserve</u> We will ensure that the Company's depreciation reserve claim is consistent with its depreciation expense claims. In many cases, utilities propose a full year of depreciation expense on test year plant additions, but include only one-half year of depreciation reserve in its rate base claim.
- 7. <u>Accumulated Deferred Income Taxes</u> This balance represents cost free capital to the Company and should be an offset to rate base or should be included in the capital structure of the Company as zero cost capital.
- 8. <u>Cash Working Capital</u> We will evaluate the cash working capital claim made by the Company. We prefer the use of a lead/lag study to determine cash working capital requirements, and we recommend that such a study be performed if a utility is large enough to warrant this undertaking. If a lead/lag study is provided, we will ensure that all non-cash items have been excluded, such as depreciation expense and deferred taxes. In addition, we will

recommend the inclusion of cash working capital provided by interest expense in the study, if not included by the Company. We will also review for reasonableness the lead/lag days used to develop the Company's claim.

- 9. <u>Materials and Supplies</u> We will ensure that any claims for materials and supplies represent a normalized level. In addition, we may recommend that the average balance of materials and supplies be offset by the amount of cash working capital provided by the average monthly accounts payable associated with the materials and supplies monthly balances.
- 10. Other Rate Base Components We will review all other rate base components to ensure that the Company's treatment is consistent with Commission precedent and good ratemaking practice.
- 11. Revenue We will review all revenue claims and ensure that going-level revenue has been appropriately annualized by the Company. Annualizations based on customer growth during the test year and normalizations based on normal operating conditions, including normal weather conditions, will be recommended where appropriate.
- 12. <u>Miscellaneous Revenue</u> We will review the Company's treatment of miscellaneous revenue. We generally recommend that a normal level of miscellaneous revenue be included in the development of the Company's proforma income claim.

- 13. Depreciation Expense on Contributions in Aid of Construction We generally take the position that depreciation expense on contributions in aid of construction should be excluded from the Company's pro forma expense, on the basis that this expense represents a return of capital to investors, who never supplied the funds for this investment. Therefore, allowing depreciation expense on contributions results in a windfall to the Company's shareholders.
- 14. <u>Salaries and Wages</u> We will fully explore several issues relating to the Company's salary and wage claims, including 1) proposed salary and wage increases, 2) proper annualization of test year increases, 3) overtime expense, 4) percentage of salaries and wages capitalized relative to historical levels, and 5) employee levels and vacancy rates.
- 15. <u>Benefit Expense</u> Benefit costs continue to be one of the fastest growing expense items for utilities. We generally take the position that estimated increases should not be reflected in rates, and require that utilities provide notification of rate increases from their carriers in order to achieve rate recognition.
- 16. Pension and OPEB Expense We will examine any claims by the Company for recovery of pension expenses and/or other post-employment benefit ("OPEB") costs. It is possible that the Company's pension fund is fully funded at this time, and therefore no cash contribution is required. If such is the case, we will oppose any claims by the Company for reflection of pension expenses in utility rates. With regard to OPEB costs, we will evaluate the annual accrual expense

as well as the annual out-of-pocket payments. We generally recommend that the utility fund its OPEB liability in order to achieve recognition of the expense in rates.

- 17. Affiliated Interest Transactions We will evaluate any affiliated interest transactions entered into by the Company. Any affiliated transactions should involve products and services necessary for the provision of utility service. In addition, a utility should demonstrate that these products and services are being provided at reasonable cost, and that the allocation methodologies used to allocate costs among subsidiaries appropriately reflect cost causation.
- 18. <u>Promotional Advertising, Marketing, Lobbying, and Political Activity</u> These are all expense items that we have opposed in previous proceedings. We will review the filing to identify issues in these areas, and we will propose adjustments that are consistent with the policies of the Commission.
- 19. Rate Case Expense We generally prefer that rate case expenses be normalized, rather than amortized, to avoid violation of the prohibition regarding retroactive ratemaking. We will review all supporting material provided to support the Company's claim, and make recommendations regarding the size of the rate case expense claim as well as the recovery period.
- 20. <u>Inflation Adjustments</u> We generally oppose the application of inflation adjustments. We are especially critical of any inflation adjustments applied to the historic test year.

- 21. Other O&M Adjustments We will critically review each expense adjustment proposed by the Company to ensure that such adjustments reflect known and measurable changes to the test year results.
- 22. Consolidated Income Taxes We have successfully sponsored consolidated income tax adjustments in many states. Since many utilities file their federal income tax returns as part of a consolidated group, they can take advantage of tax losses experienced by affiliated companies. We generally recommend an adjustment based on the modified effective federal income tax rate, unless a regulatory commission has a policy of determining federal income taxes on a standalone basis.

#### IV. WORK PLAN

This engagement will be implemented by delivery of the following services:

#### 1. Review of the Filing

The testimony, exhibits, workpapers, rate sheets, and other material filed by the Company will be reviewed in detail. Special emphasis will be placed on determining that Commission policy and practice have been followed by the Company. A preliminary summary of the issues in the case, and their approximate dollar impact, will be prepared as soon as practical.

#### 2. Preparation of Discovery

Based upon our review of the Company's filing, we will issue formal interrogatories. The responses to these interrogatories will be carefully reviewed and follow-up or additional interrogatories will be propounded. We strongly believe in the informal discovery process and we will make ourselves available to visit the Company's offices to meet with their personnel, review relevant data, and solicit other materials or data as may be necessary to complete the investigation. In addition, we will respond in a timely manner to data requests that are propounded upon The Columbia Group, Inc. as a result of testimony filed by Columbia personnel.

#### 3. Analysis of the Company's Direct Case

The preliminary issue list will be updated based upon the discovery aspects of our investigation and any input provided by CAD or its other consultants. We will discuss the completed issue list with CAD to ensure that all parties have a full understanding of all pertinent issues and views.

#### 4. Assistance in Cross-Examination

We will assist in identifying lines of cross-examination and in preparing cross-examination questions for the positions taken by all parties in the proceeding. Proposed questions, relevant material, and a synopsis explaining the line of cross-examination will be furnished to CAD. We will also furnish on-site assistance during the actual cross-examination.

#### 5. Submission of Direct, Supplemental, and Surrebuttal Testimony

A draft copy of our direct testimony will be provided to CAD at least one week prior to the filing date. In addition, to the extent necessary, supplemental and surrebuttal testimony and exhibits will be prepared. Columbia personnel will also stand for cross-examination on all testimony submitted by them.

#### 6. Summary of the Parties' Issues

We will review and prepare a summary of the issues raised by all parties. This summary will include a quantification by issue.

#### 7. Technical Assistance with Briefs and Oral Arguments

We will continue to provide technical assistance during the time that briefs and reply briefs are being prepared. This will include review of the briefs filed by other parties in the proceeding.

#### 8. Other Technical Assistance

We will provide other assistance to CAD, including the provision of status reports, consultation with CAD and its other witnesses, and other assistance as may be required.

#### 9. Review of the Commission's Order

We will review the order of the Commission and prepare a summary outlining how the Commission responded to our position on each issue.

#### V. PRIOR EXPERIENCE – REVENUE REQUIREMENTS MATTERS

#### VI. PROPOSED PERSONNEL

Personnel proposed for this engagement include Andrea C. Crane, James D. Cotton, and Elizabeth P. Jensen.

Andrea C. Crane, President of the firm, has testified as an expert witness in approximately 300 utility proceedings in 17 states and the District of Columbia. Ms. Crane has participated in numerous gas and electric proceedings around the country, including cases involving Public Service Company of New Mexico, Westar Energy, Inc., Kansas City Power and Light Company, Potomac Electric Power Company, Baltimore Gas and Electric Company, the Long Island Lighting Company, Chesapeake Utilities, Elizabethtown Gas Company, Midwest Energy, Reliant Arkla, Public Service Electric and Gas Company, Consolidated Edison, Inc. and New Century Energies, Inc.

Ms. Crane also has extensive experience testifying in utility merger proceedings. She had testified in merger or acquisition cases involving New Mexico Public Service Company, Southwestern Public Service Company, Texas-New Mexico Power Company, Atlantic City Electric Company, Delmarva Power and Light Company, Baltimore Gas and Electric Company, New England Electric Systems, Consolidated Edison, Northeast Utilities, and others.

Prior to becoming a consultant in 1989, Ms. Crane spent seven years in professional positions with GTE Service Corporation and Bell Atlantic Corporation. Ms.

Crane's educational background includes an M.B.A. degree in Finance and a B.A. degree in Chemistry, both from Temple University. Ms. Crane would be assisted, as necessary, by James D. Cotton and Elizabeth P. Jensen.

James D. Cotton is Chairman and Principal of the firm. Mr. Cotton has 33 years experience testifying in utility matters. Since joining the firm in 1986, Mr. Cotton has testified as an expert witness in approximately 130 utility proceedings in 20 states on issues of revenue requirements, accounting issues, cost of service allocations, and regulatory policy.

Prior to joining The Columbia Group, Mr. Cotton worked for eight years for the Georgetown Consulting Group, Inc., serving as an expert witness in utility rate proceedings in electric, gas, and telecommunications cases in the area of revenue requirements, specifically rate base, revenues and expenses, and regulatory requirements. Mr. Cotton holds an M.B.A. degree in Finance from Columbia University Graduate School of Business and a B.A. from Franklin & Marshall College.

Elizabeth P. Jensen serves as an expert witness in accounting and finance. In addition to serving as an expert witness in utility rate proceedings, Mrs. Jensen has performed numerous buy/ sell analyses and models for the utility industry, performed project financing analyses, and developed pro forma financial statements. She also has significant experience in regression analysis, particularly involving weather variables, and in net present value and internal rate of return studies.

Mrs. Jensen has conducted transfer price valuations, break-even price scenarios, and market valuation studies for sales of assets to and from municipalities. She has also conducted various studies to determine the financial and rate viability of nuclear plant

construction and/or abandonment, and she was active in the Shoreham nuclear plant proceedings conducted by the New York State Governor's Task Force.

Mrs. Jensen was associated with The Georgetown Consulting Group from 1984 to 1986, when she joined The Columbia Group. Prior to becoming a consultant in 1984, Mrs. Jensen was an Assistant Manager for Business Planning and Analysis at General Foods, Inc. In this position, she was responsible for financial planning and strategic analysis for a \$700 million business unit.

Mrs. Jensen's educational background includes an M.S. in Management from the Alfred P. Sloan School at M.I.T. and a B.A. from the University of Washington. Mrs. Jensen also previously served on the Board of Directors of Consumers Union, publisher of *Consumer Reports*.
